**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Hayward Tyler, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

### (1) DESCRIPTION OF THE PLAN

The following description of the Hayward Tyler, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan covering all eligible employees of Hayward Tyler, Inc. (the “Plan Sponsor”) and Energy Steel & Supply Co. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Employee Contributions – Participants may contribute up to 60% of eligible compensation as defined in the Plan, limited to a maximum amount as set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the plan year may contribute an additional amount set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans.

An employee becomes eligible to participate in the Plan on date of hire, and may elect to contribute as soon as administratively possible. The Plan contains an automatic enrollment feature beginning at a deferral rate of 4%, which increases by a percentage annually until the participant reaches a deferral rate of 10%. Participant can opt for different deferral rates.

- (c) Employer Contributions – The Company makes a matching contribution for each employee who enters into a salary reduction agreement and meets the employer contribution eligibility requirement. The matching contribution during 2024 and 2023 equaled 50% of the first 10% deferred by participants. Employees are eligible for the employer match on the first of the month following three months of employment.

The Company may also contribute a discretionary non-elective contribution for each employee, without regard to current or accumulated net profits of the Company determined by the Board of Directors for each year. During 2024 and 2023, the Company made no discretionary non-elective contribution.

- (d) Participant Accounts – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s contribution, (b) Plan earnings, and (c) forfeitures of terminated participants’ non-vested account balances. Allocations are based on a participant’s eligible compensation relative to total eligible compensation, deferred contribution amounts or account balances, as defined by the Plan.

The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant determines the investment strategy of their account as provided by the Plan.

- (e) Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions of the participant’s account plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after one year of employment, with an additional 20% per year thereafter until fully vested. Upon normal retirement age, 65 years old, death or disability, a participant becomes fully vested.

- (f) Payments of Benefits – On termination of service due to death, disability or retirement, a participant may elect to receive distributions equal to the value of the participant’s vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, installment payments, or leave the funds in the Plan until retirement age or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee’s non-forfeitable account balance is less than \$5,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.

A participant may withdraw rollover contributions at any time.

- (g) Forfeited Accounts – Forfeitures represent amounts, which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce the employer contributions and the Plan’s administrative fees. In 2024 and 2023, forfeitures were used to reduce employer contributions and Plan expenses by \$35,954 and \$20,126, respectively. Forfeitures available at December 31, 2024 and 2023 were \$954 and \$2,050, respectively.

- (h) Notes Receivable from Participants – Participants may borrow a minimum of \$1,000 up to a maximum, not to exceed 50% of their vested account balance or \$50,000, whichever is less. Loan transactions are treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms vary in range, up to ten years. The loans are secured by the balance in the account and bear a reasonable interest rate as determined by the Plan administrator based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest is repaid ratably through payroll deductions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- (b) Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gain and losses on investments bought and sold, as well as held during the year.

- (c) Notes Receivable – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

- (d) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (e) Administrative Expenses – In general, all Plan expenses except certain recordkeeping fees are paid for by the Company.
- (f) Benefit Payments – Benefits are recorded when paid.
- (g) Subsequent Events – The Company has evaluated subsequent events through July 11, 2025, which is the date that the financial statements were available to be issued.

(3) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(4) TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(7) INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(8) FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (1) DESCRIPTION OF THE PLAN

The following description of the Hayward Tyler, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan covering all eligible employees of Hayward Tyler, Inc. (the “Plan Sponsor”) and Energy Steel & Supply Co. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Employee Contributions – Participants may contribute up to 60% of eligible compensation as defined in the Plan, limited to a maximum amount as set by the Internal Revenue Service (IRS). Participants who have attained the age of 50 before the end of the plan year may contribute an additional amount set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans.

An employee becomes eligible to participate in the Plan on date of hire, and may elect to contribute as soon as administratively possible. The Plan contains an automatic enrollment feature beginning at a deferral rate of 4%, which increases by a percentage annually until the participant reaches a deferral rate of 10%. Participant can opt for different deferral rates.

- (c) Employer Contributions – The Company makes a matching contribution for each employee who enters into a salary reduction agreement and meets the employer contribution eligibility requirement. The matching contribution during 2024 and 2023 equaled 50% of the first 10% deferred by participants. Employees are eligible for the employer match on the first of the month following three months of employment.

The Company may also contribute a discretionary non-elective contribution for each employee, without regard to current or accumulated net profits of the Company determined by the Board of Directors for each year. During 2024 and 2023, the Company made no discretionary non-elective contribution.

- (d) Participant Accounts – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s contribution, (b) Plan earnings, and (c) forfeitures of terminated participants’ non-vested account balances. Allocations are based on a participant’s eligible compensation relative to total eligible compensation, deferred contribution amounts or account balances, as defined by the Plan.

The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant determines the investment strategy of their account as provided by the Plan.

- (e) Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions of the participant’s account plus actual earnings thereon is based on years of continuous service. A participant is 20% vested after one year of employment, with an additional 20% per year thereafter until fully vested. Upon normal retirement age, 65 years old, death or disability, a participant becomes fully vested.

- (f) Payments of Benefits – On termination of service due to death, disability or retirement, a participant may elect to receive distributions equal to the value of the participant’s vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, installment payments, or leave the funds in the Plan until retirement age or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee’s non-forfeitable account balance is less than \$5,000, excluding rollovers, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.

A participant may withdraw rollover contributions at any time.

- (g) Forfeited Accounts – Forfeitures represent amounts, which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce the employer contributions and the Plan’s administrative fees. In 2024 and 2023, forfeitures were used to reduce employer contributions and Plan expenses by \$35,954 and \$20,126, respectively. Forfeitures available at December 31, 2024 and 2023 were \$954 and \$2,050, respectively.
- (h) Notes Receivable from Participants – Participants may borrow a minimum of \$1,000 up to a maximum, not to exceed 50% of their vested account balance or \$50,000, whichever is less. Loan transactions are treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms vary in range, up to ten years. The loans are secured by the balance in the account and bear a reasonable interest rate as determined by the Plan administrator based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. Principal and interest is repaid ratably through payroll deductions.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- (b) Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gain and losses on investments bought and sold, as well as held during the year.

- (c) Notes Receivable – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

- (d) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (e) Administrative Expenses – In general, all Plan expenses except certain recordkeeping fees are paid for by the Company.
- (f) Benefit Payments – Benefits are recorded when paid.
- (g) Subsequent Events – The Company has evaluated subsequent events through July 11, 2025, which is the date that the financial statements were available to be issued.

(3) PLAN AMENDMENT AND TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(4) TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(5) WITHDRAWING PARTICIPANTS

There were no participant distributions requested in 2024 but not paid until 2025.

(6) RELATED PARTY TRANSACTIONS

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

(7) INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024 and the related investment activity reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(8) FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – Valued at quoted market prices at year-end.

*Money market* – The Plan is able to obtain actively traded quoted prices for these funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
