We are the Court Appointed Accountants for the Chapter 7 Bankruptcy Trustee of Off Lease Only LLC (“OLO” or the “Debtor”), the Sponsor of the Off Lease Only LLC 401(k) Profit Sharing Plan and Trust. OLO filed for protection under Chapter 11 of the United States Bankruptcy Code on September 7, 2023, and was converted to a Chapter 7 proceeding on October 3, 2023, at which time Don A. Beskrone Esq. was appointed as the Chapter 7 Trustee. All operations and payroll ceased as of the Chapter 7 filing.

As a result of the Chapter 7 bankruptcy proceeding, and pursuant to 11 U.S.C. Sect. 704(a)(11), the Trustee is responsible for the liquidation of the Plan Assets of the Off Lease Only 401(k) Profit Sharing Plan and Trust (“the Plan”).

The 2024 annual informational return was prepared from the best information available; that is, data provided by the Plan’s Record Keeper and Plan Asset Custodian, Voya Retirement Insurance and Annuity Company (“Voya”). Due to the cessation of business and the filing of bankruptcy, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable.

This Plan requires audited financial statements, but as a result of the bankruptcy, the bankruptcy estate does not have funds to pay for the audit, and bankruptcy regulations require that Plan expenses be paid from Plan Assets. In an effort to minimize costs and preserve participants’ funds, the annual audit for the final 2024 short year will not be prepared. Given that the Plan has terminated and all funds have been distributed to participants, the Trustee and Bederson believe that not preparing audits is in the best interests of the Plan’s participants. In addition, the Debtor’s former personnel provided the Trustee with very limited financial or other records needed to administer the bankruptcy, and as such, the records required to complete the audit are not available. Accordingly, due to lack of information caused by the bankruptcy and the need to preserve Plan Assets for participants’ benefit, the annual audit will not be prepared or attached to this Form 5500.

During 2024, as part of the termination and liquidation process, all of the Plan’s remaining funds were distributed to Participants. We are not aware of any complaints from Participants regarding the distribution or disposition of their account balances.

The Trustee, by his signature on the face of this informational return, has relied on Voya’s expertise in preparing the return from the available records, which were limited due to the entity’s cessation of business. Neither the Trustee, nor the Trustee’s Court Appointed Accountants have any direct knowledge of the transactions recorded by the Debtor and Voya as reported on this return. In addition, the Trustee and his professionals have no knowledge of the processes used or policies put in place by the Debtor or Voya. However, it is our qualified opinion that this is a complete return based on the financial information available.
