1. Description of Plan

ITO, Inc. dba Kikka 401(k) Plan (the Plan) was formed on August 19, 1998. The following description of the Plan is for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of ITO, Inc. dba Kikka (the Sponsor) who have completed one year of service and attained age 21 or older. The Plan administrator controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee and Employer Contributions

Each year, participants may contribute from 1% to 100% of their pre-tax annual compensation in 1% increments. The maximum dollar amount allowed was \$23,000 for the year ended October 31, 2024 and the catch up contribution limit for age 50 or older was \$7,500. The Company may make matching and discretionary contributions on behalf of each eligible participant. During the year ended October 31, 2024, the Company's matching contribution was at 50% of each participant contribution up to the first 10% of annual gross compensation.

Participant Accounts

Each participant account is credited with the participant's contributions and allocations of the Company's contribution and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Withdrawals and Distributions

Participants may receive a distribution from the Plan prior to their termination of employment and they can withdraw from the Plan in the event of financial hardship if they satisfy certain conditions. Generally, participants may request a pre-retirement withdrawal or a hardship distribution from their fully vested accounts in the Plan. Participants may be entitled to receive a pre-retirement distribution if he or she has reached age 59 1/2. There were eight hardship distributions during the year.

Vesting

All participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer's contribution portion of the participants' accounts and actual earnings in the Plan is based on the following schedule:

Years of Service Completed	Vesting Percentage
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Qualified participants become fully vested in the sponsor's contributions, including investment income after 6 years of service.

Loan to Participants

The Plan has adopted a loan program to provide loans to plan participants. Participants are permitted to have two loans outstanding at any time. Loans bear reasonable rates of interest (the prime rates) and are adequately secured. The maximum amount of which a loan may be made is the lesser of \$50,000 or one-half of participants' vested account balances in the Plan, whichever is less. The maximum amount of \$50,000 will be reduced by a participant's highest outstanding loan balance in the previous twelve months or one-half of participants' vested account balance in the Plan reduced by the current outstanding loan balance. The minimum amount of any loan is \$1,000. All loans are required to be repaid according to the loan agreement or upon terminating employment.

Payment of Benefits

Benefit payments for vested amounts are paid to participants or their beneficiaries in a manner requested by the participant or beneficiary as soon as practicable after the participant's termination of employment, disability, retirement or death, as governed by the Plan agreement. For the year ended October 31, 2024 benefits paid to participants were \$2,050,992.

Mandatory Cash-Out

If the value of a participant's vested account balance, determined as of a date following the participant's date of termination of employment, is \$5,000 or less, the participant will receive an immediate cash-out of the vested account balance as soon as administratively feasible and no further benefits will be payable from the Plan or the plan administrator will roll it over to an IRA that is established for participants.

Tax Status

The Internal Revenue Service has determined and informed the Company by a letter that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax positions that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; Tax years 2021, 2022, 2023 are open to examination, however, there are no audits for any tax periods in progress.

Plan Termination

Although the Company has not expressed any intention to do so, the employer has the right to discontinue its contributions at any time and to amend the Plan, to change or eliminate various provisions, or to terminate the Plan subject to the provisions set forth in ERISA. In the event of any termination of the Plan, or upon complete or partial discontinuance of contributions, the accounts of each participant shall become fully vested and non-forfeitable.

Forfeited Accounts

Forfeited non-vested amounts may be used to reduce administrative expenses of the Plan, then any remaining forfeitures shall be applied to reduce employer contributions. As of October 31, 2024 and 2023 the ending balances were \$13,016 and \$19,622, respectively. For the year ended October 31, 2024, \$25,201 was used to reduce the administrative expenses of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment contracts, such as those included in the MetLife Stable Value Fund, are reported at contract value as provided by the contract issuer. Contract value is the relevant measurement of fully benefit-responsive investment contracts since that is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value approximates fair market value at plan year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2024 or 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions for the year ended October 31, 2024.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments. Total annual fees paid by the Plan at October 31, 2024 and 2023 were \$27,935 and \$11,520, respectively.

Deemed Distributions

In accordance with the Internal revenue Code, participant loans that are in default and not cured within the period allowed by the Plan are treated as deemed distributions. Deemed distributions are taxable to the participant in the year of default and are reported on Form 1099-R for that year. Although deemed distributions reduce the participant's account balance for the purposes of determining future distributions, the loan balance remains a Plan asset until formally written off. For the year ended October 31, 2024, the Plan recognized \$14,917 in deemed distributions and is included the accompanying statement of changes in net assets available for plan benefits.

4. Exempt Party-In-Interest Transactions

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of October 31, 2024 and 2023.

Mutual funds and stable value fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
