## **Independent Auditors' Report**

To the Plan Administrator of the

### **Opinion**

We have audited the accompanying financial statements of the National Door Industries, Inc. Employees' Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

### 1. Description of Plan

#### *General*

National Door Industries, Inc. Employees' Retirement Plan (Plan) was established May 1, 1991, for eligible employees of National Door Industries, Inc. (Company). The Plan is a defined contribution plan designed to comply with the Employee Retirement Income Security Act of 1974 (ERISA). Charles Schwab & Co., Inc. (Custodian) acts as custodian for the Plan. LSA Pension Services (Recordkeeper) acts as recordkeeper for the Plan pursuant to an agreement between the Recordkeeper and the Company. The following description of the Plan provides only general information. Participants should refer to the formal Plan document for a more complete description of the Plan's provisions.

#### *Contributions*

All employees who have attained age 20½ and have completed 1,000 hours of service during a consecutive 12-month period are eligible to become participants in the Plan. The Company may make a profit sharing contribution to the Plan, which is determined by the Company's board of directors. The Company made profit sharing contributions totaling \$140,223 for the year ended December 31, 2024. Employee contributions are not permitted under the Plan.

#### *Participant Accounts*

Each participant's account is credited with an allocation of the Company's profit sharing contribution, the Plan's earnings and any forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested in their balances based on years of continuous service at the following rates:

Less than 2 years	0%
Each additional year	20%
6 or more years	100%

### ***Forfeitures***

When certain events occur allowing for distributions from the Plan, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Participants' forfeited amounts of non-vested Company contributions are allocated to the remaining participants. Forfeitures available for use at December 31, 2024 and 2023, totaled \$14,967 and \$15,986, respectively. During the year ended December 31, 2024, the Plan used \$4,835 in forfeitures to be reallocated amongst active participants.

### ***Payments of Benefits***

Participants are entitled to 100% of their account balance upon termination of employment due to disability, death or retirement at age 62. If a participant terminates employment before age 62, the participant may withdraw their vested balance, after a consecutive five-year break in service.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participants' accounts are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### ***Plan Termination***

While the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances and net assets of the Plan would be distributed to participants in accordance with the provisions of the Plan.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities and the reported amounts of revenues and expenses. Actual results could vary from the estimates used in preparing the accompanying financial statements.

### ***Payments of Benefits***

Benefit payments are recorded when paid.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan presents the net change in fair value of investments, which consists of realized gains or losses, unrealized appreciation and any income or capital gain distributions from such investments in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments held at year-end.

### ***Risks and Uncertainties***

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

## **3. Fair Value Measurements**

Under the Fair Value Measurements and Disclosures topic of the Codification, ASC 820, disclosures are required about how fair value is determined for assets and liabilities and a hierarchy for which these assets and liabilities must be grouped is established, based on significant levels of inputs as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

### ***Mutual Funds***

These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying asset owned by the fund, less its liabilities and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

### ***Money Market Funds***

These investments are valued using \$1 for the NAV.

### ***Corporate Stocks***

These investments are valued using closing prices reported on active markets or third-party valuations.

### ***Fixed Annuity Fund***

This investment is valued at fair value, which includes the original investment and the investment returns. Under the contract, the investment return is 6.25% in years one through five and 4% thereafter until the contract is redeemed.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Investment Contract with Insurance Company

The Plan maintains an investment contract with Athene USA. Athene USA maintains the contributions in a general account. The account is credited with a guaranteed interest rate specified in the contract. The contract is included in the financial statements at fair value (which represents contributions made under the contract, plus interest, less withdrawals and administrative expenses), because it is not fully benefit-responsive. The contract does not provide for a specific maturity date at which time the value of the contract can be distributed at fair value. The contract holder can redeem the investment at fair value at any future date with no restrictions. The fair value of the fixed annuity contract at December 31, 2024 and 2023 totaled \$2,373,051 and \$2,478,873, respectively.

#### 5. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS), dated March 31, 2008, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (Code); therefore, the related trust is exempt from taxation. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three years from the date of filing.

### 6. Related Party Transactions and Party-In-Interest Transactions

Certain investments of the Plan are managed by the Custodian and, therefore, related transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services and audit services are paid directly by the Plan. The Plan sponsor pays any other fees related to the Plan's operations.
