## Independent Auditor's Report

To the Trustees  
SimplyBank 401(k) Plan  
Dayton, Tennessee

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of SimplyBank 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 3, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period ended October 3, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SimplyBank 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 3, 2024 and December 31, 2023, and for the period ended October 3, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SimplyBank 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As discussed in Note 1 to the financial statements, the governing body of SimplyBank 401(k) Plan approved plan termination on June 30, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about SimplyBank 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:


- Exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

# Notes to Financial Statements

## NOTE 1. DESCRIPTION OF PLAN

The following description of the SimplyBank 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### Plan Termination

In conjunction with SimplyBank (the Plan Sponsor) entering into an Asset Purchase Agreement effective July 1, 2024, the Plan Sponsor ceased operations and participants were no longer employees. The Plan Sponsor authorized to terminate the Plan effective June 30, 2024 and contributions to the Plan were discontinued. Upon termination, all participants became fully vested. On October 3, 2024, all Plan assets were distributed to Plan participants and the Plan was fully liquidated.

### General

The Plan, established January 1, 1998, is a defined contribution employee benefit plan providing retirement benefits to eligible participants. All employees are eligible to participate in the Plan upon the completion of 60 days of service and attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Plan Administration

The Plan Administrator is the Plan Sponsor. The administrator supervises the operation of the Plan, interprets the meaning of provisions in the Plan, determines eligibility for participation and benefits, and decides when benefits are to be paid in accordance with the terms of the Plan. The Custodian of the Plan is Voya Retirement Insurance and Annuity Company. A trust agreement provides for the investment of trust funds and prescribes powers, duties, obligations, and functions of the Custodian.

### Contributions

The Plan is a contributory plan whereby an employee who elects to participate can contribute an amount not to exceed 100 percent of the participant's compensation subject to limitations by the Internal Revenue Code. The Plan has a safe harbor matching contribution of 100 percent of contributions up to 6 percent of compensation. The Plan also allows for discretionary profit-sharing contributions as determined by the employer. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan.

The Plan records employer and employee contributions receivable when compensation is paid and deferrals are withheld. The Plan adopted Accounting Standards Codification (ASC) Topic 326, *Financial Instruments - Credit Losses*, effective January 1, 2023, using the modified retrospective method. No allowance for credit losses has been recorded as there are no contributions receivable at October 3, 2024 or December 31, 2023.

### Vesting

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus the actual earnings thereon. Vesting in the remainder of their accounts is based on a three-year cliff schedule. A participant is 100 percent vested after three years of credited service or upon death, disability, or attainment of their normal retirement age.

### Payment of Benefits

The Plan provides that a participant may begin receiving normal retirement benefits at age 65 or upon termination of service due to death, disability, or retirement. Additionally, a participant may begin receiving distributions from certain accounts prior to termination at age 59 ½. If a participant's employment is terminated, the participant is entitled to receive all of his or her vested contributions and earnings thereon. The Plan also allows certain hardship distributions prior to retirement. Distributions may be made as lump-sum distributions or in partial withdrawals.

## NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, whichever is less. Loan terms require that repayment be amortized by payroll deductions over a period not to exceed five years. The loans are secured by the balance in the participant's account and bear interest at the prime rate stated in the *Wall Street Journal* on the day preceding the preparation of loan documents plus 1 percent.

### Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's contribution, and an allocation of plan earnings and charged an allocation of administrative expenses. Employer contributions are allocated in accordance with specific plan provisions for each type of employer contribution. Plan earnings are allocated based on participant account balances as defined in the Plan.

### Forfeitures

The non-vested portion of terminated participants' accounts will be forfeited on the earlier of the date of the distribution of their vested account balance or when they incur five consecutive one-year breaks in service. Forfeitures may be used to pay administrative expenses or reduce employer contributions to the Plan. As of October 3, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$1,889, respectively. During the period ended October 3, 2024, forfeitures totaling \$9,929 were used to pay administrative expenses and forfeitures totaling \$57 were used to reduce employer contributions.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The policies that materially affect net assets available for benefits and changes in net assets available for benefits are summarized as follows:

### Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the liquidation basis of accounting as of and for the period ended October 3, 2024, and accrual basis of accounting as of December 31, 2023.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the Custodian, Voya Retirement Insurance and Annuity Company. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 3, 2024 or December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deemed the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan may be paid by the employer which would be excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments and administrative expenses.

### Subsequent Events

Management performed an evaluation of subsequent events through August 8, 2025, the date these financial statements were available to be issued.

## NOTE 3. TAX STATUS OF THE PLAN

The Plan Sponsor has adopted a Prototype Standardized Profit-Sharing Plan with CODA. The prototype plan sponsor has received a favorable opinion letter from the Internal Revenue Service, dated November 30, 2020, stating that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving its letter, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan Administrator has evaluated tax positions taken by the Plan, and has concluded that as of October 3, 2024, there are no uncertain tax positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

## NOTE 4. INVESTMENTS

The Trustees have elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Trustees instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Voya Retirement Insurance and Annuity Company, the Custodian of the Plan, except for comparing such amounts to information included in the Plan's financial statements and supplemental schedule. The Trustees have obtained certifications from the Custodian that the following information is complete and accurate.

#### NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 6. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain of the Plan's investments are interests in accounts managed by Voya Retirement Insurance and Annuity Company. Voya Retirement Insurance and Annuity Company is the Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments and administrative expenses.

#### NOTE 7. PLAN TERMINATION PROVISIONS

In conjunction with the Plan Sponsor entering into an Asset Purchase Agreement effective July 1, 2024, the Plan Sponsor authorized to terminate the Plan effective June 30, 2024, and participants became 100 percent vested in their employer contributions. Subsequent to June 30, 2024, contributions were discontinued and notes receivable from participants were no longer available.

#### NOTE 8. FAIR VALUE MEASUREMENTS

ASC Topic 820, Fair Value Measurement, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 3, 2024 and December 31, 2023.

*Pooled separate accounts:* Pooled separate accounts invest in registered mutual funds or collective investment trusts. The separate account owns and holds the underlying mutual fund or collective trust shares which are valued daily at their net asset value (NAV). The separate account is valued at its accumulation unit value (AUV) determined daily based on the NAV of shares of the underlying fund, the fund's dividends, and the contract's separate account charges. The AUV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported AUV. Participant transactions (purchases and sales) may occur daily. There are no participant or Plan redemption restrictions for these investments, and there are no unfunded commitments.

## NOTE 8. FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.
- (b) Pooled separate accounts represent investments in actively managed funds categorized primarily into bond, balanced, large cap value and growth, small/mid cap specialty, international, asset allocation, and money market funds. Bond funds invest primarily in corporate, government, and mortgage bonds and debt securities. Balanced funds invest primarily in equity securities, bonds, and securities issued and guaranteed by the U.S. Government. Large cap value and growth funds invest primarily in equity securities of large companies. Small/mid cap specialty funds invest primarily in small and medium sized companies. International funds invest primarily in international equity securities. Asset allocation funds invest primarily in aggressive stocks, international stocks, large-company stocks, government bonds, and money markets. Money market funds invest primarily in money markets.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the period. For the period ended October 3, 2024 and year ended December 31, 2023, there were no transfers in or out of Levels 1, 2, or 3.

## NOTE 9. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan invests in traditional benefit-responsive investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. At October 3, 2024 and December 31, 2023, the Plan held traditional investment contracts of \$0 and \$1,357,200, respectively.

The traditional investment contracts held by the Plan are guaranteed investment contracts. Contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00% for the period ended October 3, 2024 and year ended December 31, 2023 for the contract. The crediting rate is reviewed on an annual basis for resetting. The contracts cannot be terminated before the scheduled maturity.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the Plan to transact at contract value with contract issuers. Examples of such events include the following: (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code, (2) premature termination of the contract, (3) Plan termination or merger, (4) changes to the Plan's prohibition on competing investment contracts, or (5) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

Prior to Plan termination effective June 30, 2024, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with contract issuers and that would also limit the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.
