INDEPENDENT AUDITORS' REPORT

To the Trustees of
Hotel & Restaurant Supply 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hotel & Restaurant Supply 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended October 30, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hotel & Restaurant Supply 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 30, 2024 and December 31, 2023 and for the period ended October 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hotel & Restaurant Supply 401(k) Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter- Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1(b) to the financial statements, the plan administrator resolved to terminate the Plan and approved a plan of liquidation on April 16, 2024, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from an ongoing basis to the liquidation basis of accounting. Our report has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Hotel & Restaurant Supply 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Hotel & Restaurant Supply 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about of Hotel & Restaurant Supply 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Note 1: Description of Plan

The following description of the Hotel & Restaurant Supply (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan covering all employees of the Company that have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Plan Termination and Liquidation

On April 16, 2024, the Company formally resolved to terminate the Plan. Contributions to the Plan were frozen and employees were no longer permitted to become new participants in the Plan as of the termination date. As a result of the termination, all participants became 100 percent vested in the employer contribution portion of their accounts. All plan assets were liquidated as of October 30, 2024.

c. Contribution

Each year, participants may contribute up to 90% of pretax annual compensation, as defined by the plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make additional deferral contributions upon proper notice and approval in an amount up to 100% of their compensation in the payroll period(s) in the final month of the Plan Year. In addition, participants may contribute up to 100% of approved employer paid bonuses. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes Nonelective contributions utilizing the safe harbor method and contributes 100% of the first 3% and 50% of the next 2% of base compensation that a participant contributes to the Plan. Contributions are subject to certain limitations. The Company froze all contributions as of April 1, 2024.

In July 2025, an operational compliance issue was identified in which certain participant elective deferrals and employer matching contributions exceeded the prorated annual additions limit under Internal Revenue Code §415(c). The excess occurred because full-year contribution limits were applied, despite the plan’s short three-month year ending with its termination on April 1, 2024. These excess amounts were distributed to participants as part of the final plan wind-down.

As the Plan is fully terminated and no trust remains open, the Plan Sponsor intends to correct this operational error by submitting a request under the IRS Employee Plans Compliance Resolution System (EPCRS) via the Voluntary Correction Program (VCP).

d. Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, and (b) Plan earnings, and charged with an allocation of administration expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1: Description of Plan- Continued

e. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company safe harbor contributions and portion of their accounts plus earnings are 100% vested immediately. Upon death, total disability, or retirement (age 65), a participant is also 100% vested.

f. Payment of Benefits

On termination of service due to death, disability, retirement, or due to other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments over a period of not more than the assumed life expectancy of the participant (or his beneficiary).

Note 2: Summary of Significant Accounting Policies

a. Basis of Accounting

As discussed in Note 1(b), on April 16, 2024, the Company formally amended to terminate the Plan and determined that liquidation was imminent, as such concepts are defined in the applicable accounting standards, as of that date. As a result, the Plan changed its basis of accounting from an ongoing basis to the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America.

The Statement of Net Assets Available for Benefits as of December 31, 2023, was prepared under the accrual basis as an ongoing basis of accounting. The Statement of Net Assets (in liquidation) as of October 30, 2024, was prepared under the liquidation basis of accounting. Although the date that liquidation was deemed imminent was April 16, 2024, the Plan followed nonauthoritative guidance issued by the AICPA Financial Reporting Center under Technical Questions and Answers (TIS) Section 6931, Financial Statement Reporting and Disclosure – Employee Benefit Plans. In accordance with the guidance provided under TIS sections 6931.18-.30, the change in net assets for the period from January 1 to October 30, 2024, is reflected on a liquidation basis for the entire period.

b. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement dates. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

d. Payment of Benefits

Benefits are recorded when paid.

e. Operating Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in administrative expenses.

Note 3: Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

Note 4: Investments

Unaudited Information Certified by Plan Trustee

The October 30, 2024 and December 31, 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the period ended October 30, 2024, and the accompanying notes to financial statements were prepared in part or entirely from information certified by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$0 and \$12,771,041 at October 30, 2024 and December 31, 2023, respectively, and related net investment income of \$1,191,064 for the period ended October 30, 2024.

Note 5: Plan Termination

The Plan terminated effective April 1, 2024, as a standard termination. All participants became 100 percent vested in their accounts at the date of termination. As such, benefits were paid in full from April 2024 to October 2024 based on participant account balances. As noted in Note 2(a), the Plan changed its basis of accounting used to value Plan assets from the ongoing basis to the liquidation basis of accounting for the period ended October 30, 2024.

Note 6: Related Party and Party in Interest Transactions

For the period ended October 30, 2024 and as of December 31, 2023 certain Plan investments are shares of interest-bearing cash and mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan's party-in-interest transactions include administrative fees paid to Fidelity Management Trust Company and various other services provided for the period ended October 30, 2024.

Note 7: Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving this determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities: however, there are currently no audits for any tax periods in progress.

The results of the nondiscrimination testing for the plan period ended October 30, 2024 were not finalized as of the date these financial statements were issued. However, the Plan has historically complied with applicable nondiscrimination requirements.

Note 9: Risks and Uncertainties

The Plan invested in various investment securities that were exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of those securities could have occurred and materially affected participants' account balances. All investment assets were liquidated during the period ended October 30, 2024 in connection with the Plan's termination. As a result, the Plan held no investment securities as of October 30, 2024 and is not subject to these risks at the end of the reporting period.

Note 10: Subsequent Events

Events that occur after the Statement of Net Assets Available for Benefits date but before the financial statements are available to be issued must be evaluated for recognition or disclosure. The effects of subsequent events that provide evidence about conditions that existed at the Statement of Net Assets Available for Benefits date are recognized in the accompanying financial statements. Subsequent events which provide evidence about conditions that existed after the Statement of Net Assets Available for Benefits date require disclosure in the accompanying notes. Subsequent events have been evaluated through August 5, 2025, which is the date the financial statements were available to be issued and concluded that following subsequent event existed that should be disclosed in the financial statements.
