Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of MAQ, LLC dba MAQ Software 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 - DESCRIPTION OF PLAN

The following description of the MAQ, LLC dba MAQ Software 401(k) Plan ("the plan") provides only general information. Participants should refer to the plan agreement or Summary Plan Description for a more complete description of the plan's provisions, which are available from the plan administrator.

GENERAL

The plan is a defined contribution plan sponsored by MAQ, LLC dba MAQ Software ("the company") covering all eligible full-time employees of the company who have completed one month of service and are age 18. Effective November 15, 2024, the plan was amended to allow interns with one month of service to be eligible. Employees who are covered under a collective bargaining agreement, contractors or who are nonresident aliens with no earned income from sources within the United States are not eligible. Eligible employees enter the plan on the first day of the month following completion of service requirement. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The plan is administered by the company's 401(k) Committee ("Committee"), which is a committee of the board of directors of the company. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the plan's investment offerings and monitors investment performance.

CONTRIBUTIONS

Participants may contribute a percentage of eligible annual compensation as pre-tax and Roth contributions as defined in the plan agreement. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. All contributions are invested with Matrix Trust Company.

The company, at its discretion, may make a matching contribution. Matching contributions are based upon each participant's eligible contributions, limited to 50% of employee contributions up to 6% of the participant's eligible compensation for the plan year. The company may also, at its discretion, make profit sharing contributions. The company made matching contributions of approximately \$393,000 and \$321,000 for the years ended December 31, 2024 and 2023, respectively. There were no profit sharing contributions for the years ended December 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

PARTICIPANT INVESTMENT ACCOUNT OPTIONS

Upon enrollment in the plan, participants are able to direct their contributions, including discretionary matching contributions, among any or all of the multiple investment account options. The plan currently offers various mutual funds as investment options for participants. Participants may change their investment options daily. There are no nonparticipant directed investments.

Contributions may be held as cash balances prior to the execution of the investment according to the participant's direction.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their voluntary contributions and employer contributions plus actual earnings thereon.

PAYMENT OF BENEFITS

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of employment due to other reasons, a participant with a balance in excess of \$5,000 may elect whether to receive a lump-sum distribution or roll over the vested interest in his or her account into another qualified plan. Participants with a vested balance between \$1,000 and \$5,000 will be automatically distributed to an individual retirement account in their name. Participants with a vested balance under \$1,000 must receive the distribution in a lump sum upon termination.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**BASIS OF ACCOUNTING**

The financial statements of the plan are prepared using the accrual method of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold, as well as held during the year.

CONTRIBUTIONS

Contributions from plan participants and the matching contributions from the company are recorded in the year in which the employee contributions are withheld from compensation.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Certain expenses of the plan are paid by the company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of distributions from participants are charged directly to the participant's account and are included in administrative expenses.

SUBSEQUENT EVENTS

The plan has evaluated subsequent events through August 8, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, custodian, held the plan's investment assets and executed investment transactions from February 1, 2023 to December 31, 2024. Fidelity Management Trust Company held the plan's investment assets and executed investment transactions from January 1, 2023 to January 31, 2023. Accordingly, the custodians of the plan, have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Cash
- Net appreciation in fair value of investments
- Interest and dividend income
- Investments, as reflected in Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year)

The plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or

liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Note 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA.

Note 7 - TAX STATUS

The Internal Revenue Service ("IRS") has determined that the prototype 401(k) profit sharing plan as adopted on January 31, 2023 is designed in accordance with applicable sections of the IRC and informed the recordkeeper of such in a letter dated June 30, 2020. Although the plan has been amended since receiving the opinion letter, the plan administrator believes that the plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Market risks include global events which could impact the value of investment securities, such as tariff impositions or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - PARTY-IN-INTEREST TRANSACTIONS

Effective February 1, 2023, Human Interest, Inc. and a related entity provide the plan with investment advising, plan administration and record keeping. From January 1, 2023 through January 31, 2023, Fidelity Management Trust Company and related entities provided the plan with trustee services, investment advising, plan administration and record keeping. Expenses related to these services are paid by the plan and therefore qualify as party-in-interest transactions. The owner of the plan sponsor, as well as the plan administrator also participate in the plan and transactions with these individuals may qualify as party-in-interest transactions.

Note 10 - DELINQUENT PARTICIPANT CONTRIBUTIONS

Defined contribution plans are required to remit participant contributions to the plan as soon as they can be reasonably segregated from the company's general assets. Contributions of \$98,851 and \$50,586 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively. The company remitted these late participant contributions, including any lost earnings during the years ended December 31, 2024 and 2023, respectively.
