Note 1 - Plan Description

The following description of the Systems Unlimited, Inc. (the “Sponsor”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan with 401(k) features, available to all employees of Systems Unlimited, Inc. who have reached age 21 and have three months of service. Employees can enter the Plan the first day of the month after they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and amendments. The Plan was established on January 1, 1998, with the last amendment on January 1, 2022.

Contributions - Participants may contribute up to 100% of their eligible compensation, not to exceed the maximum amount allowable under the Internal Revenue Code, to the Plan in the form of a salary deferral. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Sponsor may contribute to the Plan a discretionary amount as a matching contribution. To be eligible for matching contributions, employees must be age 21 and have 1 year of service. In accordance with the plan document, the Company makes discretionary match contributions of 100% of participants’ elective deferrals up to 3% of eligible compensation, and 50% of elective deferrals of the next 2% of compensation for the years ended December 31, 2024 and 2023.

Participant Accounts - Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Sponsor’s contributions and (b) plan earnings (expenses). Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may direct the investment of their account balances into any combination of the investment options offered by the Plan.

Vesting - Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after five years of countable periods of service, regardless of hours of service.

Administrative Expenses - Certain administrative expenses are paid directly by the Sponsor, while other expenses are paid by the Plan.

Payment of Benefits - Upon retirement, death, disability or termination of employment, participants may elect to receive a lump-sum distribution equal to the value of the vested portion of their account balance. Vested balances of less than \$5,000 can be distributed in a lump sum without participant election. In-service distributions are allowed for hardship and attainment of age 59 ½ as explained in the plan document. Hardship distributions are only allowed in relation to employee deferral accounts during the participant’s time of employment with the Sponsor.

Notes Receivable from Participants - Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The maximum term of any loan is 5 years. Participants may only have two loans outstanding at any time. The loans are secured by the balance in the participant’s account and bear interest at 3.25% to 8.5% which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Forfeitures - Forfeitures of nonvested participant accounts are used to reduce administrative expenses or used to offset employer matching contributions. Forfeitures used during the year to offset employer contributions totaled \$5,295 and \$2,752 for the years ended December 31, 2024 and 2023, respectively. There was balances of non-vested forfeitures of \$3,904 and 6,823 as of December 31, 2024 and 2023, respectively.

Note 2 - Summary of Significant Accounting Policies

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets during the reporting period. Actual results may differ from those estimates.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition - The investment value of each fund represents contributions made, plus the proportionate share of the increase or decrease in the assets of the fund from investment earnings (interest and dividends) and realized and unrealized appreciation or depreciation in the fair value of its investments and less amounts used to pay investments and administrative expenses charged by the custodian.

Investments are stated at fair value and contract value as reported by the custodian. Shares of registered investment companies are valued by the change in market value that represents the net asset value of shares held by the Plan at year end. Investments in common collective trusts and guaranteed interest contracts are valued at contract value, which approximates fair value. Value is based upon the average yield earned by the plan adjusted to reflect the actual interest rate credited to participants. The effective interest rate is established every six months and is based on the performance of the underlying investments.

Purchases and sales of securities are recorded as of the trade date. Dividends are recorded on the ex-dividend date. The investment income shown on the statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold, and also those held during the year.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Date of Management Review - Management has evaluated subsequent events through August 8, 2025, the date which the financial statements were available to be issued.

Note 3 - Information Certified by Plan Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company (the trustee of the Plan).

Note 4 - Fair Value Measurement

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Registered investment companies - Investments in registered investment companies, which primarily consist of mutual funds, are valued at fair value based on the net asset value ("NAV") of shares held by the Plan at the end of the reporting period. The NAV is determined by the fund as of the close of regular trading and is calculated based on the fair value of the underlying investments in accordance with the fund's prospectus. These investments are classified as Level 1 within the fair value hierarchy, as they are traded in active markets and the NAV is readily observable and represents quoted prices for identical assets in active markets.

Note 5 - Benefit-Responsive Investment Contracts

The Plan holds a portfolio of investment contracts that are comprised of traditional investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest as a specified interest rate that is guaranteed to the Plan. The credit rating is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events are described in the contract; however, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 - Benefit-Responsive Investment Contracts (Continued)

In November 2021, the Plan entered into an investment contract with The Standard Life Insurance Company, which maintains the contributions in registered investment companies, and a guaranteed interest contract. The contract is a traditional single group annuity contract with a fixed rate of interest. The methodology for calculating the interest crediting rate is defined in the contract. Under the terms of this contract, there is no stated minimum or maximum interest rate for the fund. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by The Standard Life Insurance. The contract is included in the financial statements at contract value, which approximates fair value, as reported to the Plan by The Standard Life Insurance.

Contract value, as reported by The Standard Life Insurance Company, represents contributions made, less withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value is guaranteed by the full faith and credit of Standard Insurance Company; there are no wrap contracts supporting the liquidity of the fund. The fund is neither a mutual fund nor a bank product. Standard Insurance Company's obligations are not insured by the FDIC or any other federal government agency.

Note 6 - Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

Note 7 - Related Party Transactions

Standard Insurance Company (The Standard) is the trustee as defined by the Plan, and 14% and 13% of the Plan's investments as of December 31, 2024 and 2023 are held in The Standard-sponsored registered investment companies, and collective trusts, to participants. Therefore, The Standard is a party-in-interest for those investments.

Fees paid by the Plan to The Standard for investment management services and contract administrator fees amounted to \$49,709 and \$44,223 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants totaled \$316,763 and \$238,718 as of December 31, 2024 and 2023, respectively.

Note 8 - Income Tax Status

The Plan has adopted a standardized form of a prototype plan. The prototype plan obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

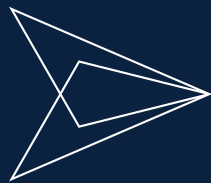
