## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
BBI Logistics, LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of BBI Logistics, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 

**NOTE A - DESCRIPTION OF PLAN**

The following description of the BBI Logistics, LLC (the Employer) 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Employer who have three months of service, are age 21 or older, and are not a nonresident alien, leased employee, covered by a collective bargaining agreement, or have the title intern. Eligible participants can enter the Plan on the first day of each Plan quarter coincident with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator and shareholders are responsible for oversight of the Plan. The Plan Administrator and management determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the shareholders.

Contributions

Each year, participants may authorize payroll deductions as before-tax and Roth contributions, up to IRS limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may elect to opt out of the Plan at any time.

The Employer may make discretionary matching, profit sharing and qualified nonelective contributions to the Plan. For 2024, the Company made discretionary matching contributions of 50% of the first 6% of compensation to participants who contributed. Total employer discretionary matching contributions were \$442,500 for the year ended December 31, 2024. The Employer made profit sharing contributions of \$50,000 for the year ended December 31, 2024.

Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan.

Participant accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, and allocations of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's discretionary matching and profit sharing contributions plus actual earnings thereon is based on hours of service of 1,000 hours for a year of vesting service and is 100 percent vested after five years of credited service.

Benefit payments

A participant may receive a lump-sum amount upon termination of service due to death, disability, or retirement. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or rollover their account balance into another individual retirement account. If the participant account balance is less than \$5,000, the Plan Administrator directs the Trustee to make a lump sum distribution as soon as administratively possible. In-service withdrawals are permitted after attainment of age 59.5 from all accounts. Participants may request a hardship distribution from all accounts.

**NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

Notes receivables from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate will be the prime interest rate plus one percent per year. Principal and interest is paid ratably through bi-weekly payroll deductions.

Forfeited accounts

Forfeited nonvested accounts are held in a non-interest bearing, unallocated cash account and are used to reduce future employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$80,076 and \$27,371, respectively. During 2024, there were forfeitures of \$6,213 that were used to reduce future employer matching contributions.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**NOTE C - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds, exchange traded funds, stable value funds:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Funds held by the Plan are considered level 1 investments and are valued at \$7,942,633 and \$5,841,249 at December 31, 2024 and 2023, respectively.

**NOTE D - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by John Hancock Life Insurance Company (John Hancock). John Hancock is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid direct compensation to Rea & Associates, Inc., the third party administrator of the Plan, and Raymond James & Associates and Merrill Lynch, the investment advisor of the Plan; therefore, these transactions qualify as party-in-interest transactions.

**NOTE E - TAX STATUS**

The IRS has determined, by a letter dated June 30, 2020, that the Non-standardized Pre-Approved Profit Sharing Plan With CODA in effect is acceptable under section 401 of the Internal Revenue Code (IRC) for use by the Employer for the benefit of their employees. The letter states that the IRC opinion on the acceptability of the form of the plan is not a ruling or determination as to whether an employer's plan qualifies under Code Section 401(a). However, an employer that adopts this plan may rely on this letter with respect to the qualification of its plan number Code Section 401(a). The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE E - TAX STATUS (CONTINUED)**

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would required recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE G - INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by John Hancock Life Insurance Company, the custodian of the Plan. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following:

**NOTE H – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE I – REFUND OF EXCESS CONTRIBUTIONS**

In February 2025, refunds of excess contributions were processed to correct the Plan's failure of the ADP/ACP nondiscrimination test for 2024. The Employer recognized \$30,309 of excess contributions payable as of December 31, 2024.

In February 2024, refunds of excess contributions were processed to correct the Plan's failure of the ADP/ACP nondiscrimination test for 2023. The Employer recognized \$37,607 of excess contributions payable as of December 31, 2023.
