For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

(1) **Description Of The Plan**

The following description of AGEISS Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants and all others should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan was originally effective January 1, 1993. The amended and restated provisions of the Plan became effective on December 31, 2018. However, the restatement was made to conform the Plan to new tax laws and some provisions may be retroactively effective. The Plan is available to employees age 21 years or older who have completed three consecutive months. Leased employees and certain non-resident aliens who have no earned income from sources within the United States are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Directors of AGEISS, Inc. (the "Company") administers the Plan.

Contributions

Participants may make before-tax contributions up to 100% of their annual compensation, not to exceed \$23,000 and \$22,500 during 2024 and 2023, respectively, as limited by the IRS, which is reviewed annually by the Secretary of the Treasury for inflation. This maximum percentage may not be reduced by the Plan administrator in certain circumstances. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions. Employees are eligible to contribute on an after-tax basis through payroll deductions up to 100% of eligible compensation as a Roth 401(k) contribution. Provided requirements are met, earnings on Roth contributions are tax-free. A participant's combined pre-tax and Roth 401(k) contributions cannot exceed the maximum annual amount allowed by law. Additional catch-up contributions are available to any participant who is age 50 or older and had made the maximum contributions for the year. The Company makes matching contributions. In 2024 and 2023, the Company made matching contributions of 100% of elective deferrals up to 5% of the employees elective deferrals paid each payroll period. Additionally, the Company made discretionary profit sharing contributions in 2024 and 2023. The Company has the right to designate all or a portion of the matching contributions as qualified.

To the extent matching contributions are so designated, they are not-forfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59 ½.

Participant Accounts

Each participant's account is credited or charged with the participant's contribution and an allocation of the Company's contribution, Plan earnings or losses, and Plan expenses.

Allocations are based upon Plan earnings or losses and account balances, as defined. The benefit to which a participant is entitled is the vested portion of the participant's account.

Vesting

Participants are 100% vested in their voluntary contributions, allocated earnings or losses thereon, and any qualified matching contributions.

Any employer contributions and the earnings or losses thereon are fully vested when contributed.

Payment Of Benefits

Upon death, disability, attaining normal retirement age (65), or termination of service, a participant will receive a lump-sum payment in the amount equal to the participant's vested account balance or payments in equal installments or a partial withdrawal of no less than \$1,000, within a reasonable period of time after termination of employment. Participants may not make withdrawals from their accounts prior to age 59 1/2, except in the event of death, disability, termination of employment, or notice of hardship, without being subject to certain restrictions and penalties. Upon a distribution event, if a participant's vested account balance is \$7,000 or less, the account will be distributed as soon as administratively possible. This threshold was changed from \$5,000, effective January 1, 2024, due to the SECURE Act 2.0. Benefits are recorded as distributions to participants when paid.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. The Cares Act temporarily allowed loans up to \$100,000 or 100% of a participants vested account balance, whichever is lower, as discussed in Note 2. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.75% to 8.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions. Interest incurred on loans and loan payments are credited to the participant's account.

(2) **Summary Of Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments Valuation And Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The Plan follows the *Fair Value Measurements And Disclosures* accounting standard, which among other things requires enhanced disclosures about investments that are measured and reported at fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at their price. The mutual funds held by the Plan are considered to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Use Of Estimates

The preparation of financial statements in conformity with generally accepted accounting in the United States of America principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions Receivable

Employee contributions receivable arise from employee contributions that are withheld from employee's salary, but have yet to be remitted to the Plan by the Employer. Additionally, employer contributions receivable arise from discretionary matching or profit sharing contributions that are to be remitted to the Plan by the Employer for wages that have been previously paid to employees. The Plan charges off uncollectible receivables when future receipts are deemed probable.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants as of December 31, 2024 and 2023, totaled \$35,436 and \$32,843, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability and included in benefits paid to participants. The Plan distributed for 2024 excess contributions to the applicable participants prior to March 15, 2025. The Plan distributed for 2023 excess contributions to the applicable participants prior to March 15, 2024.

Subsequent Events

The Plan's management has performed an evaluation of subsequent events through July 29, 2025, which is the date the financial statements were available to be issued and considered any relevant matters in the preparation of the financial statements and footnotes.

(4) **Investment Contracts with Insurance Company**

The Plan has entered into a traditional fully benefit-responsive investment contract with the Standard Insurance Company (“Standard”). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Standard, represent contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract as of December 31, 2024 and 2023, was \$1,271,182 and \$1,329,874, respectively. The average yield was 3.04% and 2.78% for 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the Plan’s ability to transact at contract value with Standard. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (c) plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or other required prohibited transactions exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Examples of such events include (a) an uncured breach of the Plan’s investment guidelines, (b) a material amendment to the contract without the issuer’s consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan’s administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The contract does not permit Standard to terminate the agreement prior to the scheduled maturity date.

(5) **Income Taxes**

The Plan did not obtain a plan-specific determination letter as it operates with Standard's determination letter, which was issued on June 30, 2020, on the basic Plan document. The Plan administrator believes that the Plan continues to be operated and administered in compliance with the applicable requirements of the Internal Revenue Code.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income tax examinations for years prior to 2021.

(6) **Forfeitures**

Forfeited accounts are used to reduce employer contributions and Plan expenses. As of December 31, 2024, the Plan had \$1,625 in excess contributions that will be moved to the forfeiture account.

(7) **Financial Data Certified By The Investment Company Administered Trust Fund**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends, for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

(8) **Administration Of The Plan**

The Company provides, at no cost to the Plan, certain administrative, accounting, and legal services to the Plan and also pays the cost of certain outside services for the Plan.

(9) **Party-in-Interest Transactions**

Note receivable from participants are party-in-interest transactions that are exempt from the prohibited rules. The Plan has fully benefits-responsive contracts with the Standard Insurance Company which is a party-in-interest transaction.

(10) **Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in the U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

(11) **Plan Termination**

Although the Company intends to continue the Plan and to make regular contributions, the Company reserves the right to terminate the Plan at any time, and its continuance is not guaranteed. The Company also has reserved the right to amend or otherwise modify the Plan, or to discontinue any further contributions or payments under the Plan, by a resolution of its Board.
