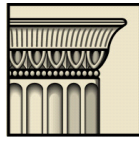

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Beer and Slabaugh Inc. Deferred Profit Sharing 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in *Note 4* to the financial statements, is complete and accurate.

Opinion

December 31, 2024

1. Description of the Plan

The following description of the Beer and Slabaugh Inc. Deferred Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Beer and Slabaugh Inc. (Company) and provides retirement benefits for substantially all employees of Beer and Slabaugh, Inc., Elkhart County Gravel, Inc., and Challenger Designs LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

A full-time employee, excluding union employees and non-resident aliens, becomes eligible to enter the Plan immediately following attainment of the age of 21 and one year of services as defined by the Plan as 1,000 hours. The entry dates into the Plan are January 1 and July 1.

Contributions

Participants may make voluntary pre-tax or after-tax Roth contributions as a percentage of eligible compensation, up to the annual dollar limits set by the Internal Revenue Code (IRC). The Plan allows for rollover contributions and for eligible participants to make catch-up contributions in accordance with Internal Revenue Service (IRS) regulations. Participants direct the investment of their contributions into various investment options offered by the Plan. Additionally, the Plan allows participants to change the amount of their contributions semiannually or elect to stop contributing on any date.

The Company may make discretionary matching and profit sharing contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions as follows: Beer and Slabaugh, Inc. – 100 percent up to 4 percent of eligible compensation; Elkhart County Gravel, Inc. – 100 percent up to 6 percent of eligible compensation; Challenger Design LLC – 50 percent up to 6 percent of eligible compensation (collectively, Company matching contribution). To become eligible for the profit sharing contribution, an employee must have attained 21 years of age and completed one year of service as defined by the Plan as 1,000 hours. The Company did not make any profit sharing contributions for the years ended December 31, 2024 and 2023.

1. Description of the Plan (continued)

Investment Options

Participants can direct that their pre-tax and Company contributions, plus earnings or losses thereon, be invested in any of the participant directed investment options offered pursuant to the Plan. The Plan allows participants to change their investment elections on a daily basis.

The investments of the Plan consisted of diverse portfolios with no significant concentration of risk by issuer, industry, or geographic location.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings (losses), and is charged with his or her withdrawals and an allocation of other administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, including rollovers, plus actual investment earnings or losses thereon. Vesting in the Company's matching contribution is based upon years of service. Participants become 20 percent vested in the Company's contribution after two years of service and increase by 20 percent each year, until they become 100 percent vested after 6 years of service.

Forfeitures

Participants who terminate employment prior to becoming fully vested must forfeit a percentage of their employer contribution amount. These forfeitures are used to reduce employer contributions or pay Plan administrative expenses. During the year ended December 31, 2024 and 2023, forfeitures totaling \$17,690 and \$663, respectively, were used to pay Plan administrative expenses. At December 31, 2024 and 2023, there was \$18,693 and \$21,607, respectively, in the forfeiture account to reduce future employer contributions or pay Plan administrative expenses.

1. Description of the Plan (continued)

Benefit Payments

Normal retirement age under the Plan is 65 years, with the option to withdraw funds at the age of 59½. Minimum distributions are required as dictated by law. On termination of service or retirement, a participant has the following options regarding his or her value of the vested interest: a) receive a lump-sum payment, b) rollover the balance into another qualified plan, or c) remain in the Plan as an inactive participant. However, if a terminated participant's vested account balance is \$1,000 or less and they have not elected a rollover, they will involuntarily receive a lump-sum distribution. If a participant is still a current employee and has not yet reached retirement age, the participant (or beneficiary) can only withdraw funds in the event of death, a disability which prevents them from working, or through a hardship withdrawal. Hardship withdrawals are only allowed from elective deferral accounts, as outlined in the Plan document.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100 percent vested in their employer contributions.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See *Note 5* for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains distributions are included in dividend income.

2. Summary of Accounting Policies (continued)

Investments (continued)

The Plan includes in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments. Unrealized appreciation or depreciation in the aggregate fair value of investments represents the change in the difference between aggregate fair value and the cost of investments, including reinvestment of earnings. The realized gain or loss on sale of investments is the difference between the proceeds received and the average cost of investments sold.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and excluded from these financial statements. Plan recordkeeping fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

Preparation of the Plan's financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

3. Income Tax Status

The Plan administrator believes that the Plan, as amended, is being operated in compliance with the applicable requirements of Section 401(a) of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt and the Plan has no income subject to unrelated business income. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to take that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

4. Investments

All investment information disclosed in the accompanying financial statements and schedule including investments held at December 31, 2024 and 2023 and net appreciation (depreciation) in fair value of investments and interest and dividend income for the years then ended, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Great-West Trust Company, LLC and Great-West Life and Annuity Insurance Company, the trustees.

5. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 (ASC 820), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to

unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (EAICA) which is called the Empower Investments Fixed Account (EIFA). The EIFA is a general account product offered through the group annuity contract, and therefore, the principal and interest for participant-initiated benefit payments are fully guaranteed by the entire general account assets of EAICA. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly.

Contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the group annuity contract since the contract was determined to be fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

6. Fully Benefit-Responsive Investment Contract (continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$266,701 and \$264,494, respectively. The crediting interest is based on a formula agreed upon by the issuer but may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events could limit the ability of the Plan to transact at contract value with the issuer. The Plan administrator does not believe that any events such as plan termination which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The investment contract does not permit Great-West Life & Annuity Insurance Company to terminate the agreement prior to the scheduled maturity date.
