Note 1 - Description of the Plan

The following description of the Raymond of New Jersey, LLC (the "Company") Retirement & Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company that are not represented by a bargaining unit and have completed 3 months of service. The Plan entry date is the 1st day of the quarter following eligibility. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions

Each year, participants may contribute up to the maximum amount allowed by law (\$23,000 in 2024) of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled investment accounts, various mutual funds and guaranteed interest accounts as investment options for participants. The Plan does not include an auto-enrollment provision. The Company makes matching contributions to the account of each eligible participant in the amount of 37.5% of the participant's elective deferrals for the year, not to exceed 1.875% of compensation (as defined in the Plan). Matching contributions are accrued at year end and paid to the Plan in the subsequent year. Accrued matching contributions were \$188,081 and \$183,970 as of December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of a.) The Company's matching contribution and, b.) Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are 100% vested in their contributions and related earnings. Vesting on the Company's matching contributions and earnings thereon begins after completion of two years of service at 20% per year. A participant is 100% vested after 6 years of credited service. The non-vested portion of a participant's account is forfeited when the participant leaves the Company. Forfeitures are kept in a separate account and can be used to pay administrative expenses or applied to reduce Employer contributions for the plan year. There were \$1,697 and \$2,149 in forfeitures available in 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates approximating 5.25% to 10.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments.

Note 2 - Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with U.S. GAAP.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment.

Investments Valuation and Income Recognition

Investments in mutual funds and pooled- separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustees determine the Plan's valuation policies. See Note 4 for discussions of fair value measurements. Guaranteed interest accounts, which are fully benefit responsive, are reported at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

A portion of the expenses of maintaining the Plan are paid by the Company. Loan fees are paid by the participants. Investment related expenses are included with net appreciation/depreciation in the value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 28, 2025, which is the date the financial statements were available to be issued.

Note 3 - Information Certified by the Trustee

The Principal Group has provided certification as to the completeness and accuracy of the investments presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the related investment gains and income including interest income on notes receivable from participants for the year ended December 31, 2024. The accompanying supplemental schedule also includes investment information certified by The Principal Group as being complete and accurate.

Note 4 - Fair Value Measurements

The Plan's investments are stated at fair value, except for fully benefit responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize use of the unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset and liability; (4) inputs that are derived principally from or corroborated by observable (from sources independent of the reporting entity) market data by correlation or other means. If the asset or liability has specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable (best information available, which might include the entity's own data) and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Investment in Mutual Funds and Pooled Separate Accounts

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023:

- Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Pooled Separate Accounts: Valued at fair value based on the unit value provided by the insurance carrier as of the financial statement date. The unit value is determined daily and reflects the fair value of the underlying assets held within each account, divided by the total number of units outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with our market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment Contract with Insurance Company

The guaranteed investment fund is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Principal. The contract is fully benefit responsive and is presented on the face of the statement of net assets available for benefits at contract value, which approximates fair value. Contract value, as reported to the Plan, by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There is no reserve against contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with Principal; however, the plan administrator does not believe that occurrence of any such events are probable.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would still be 100% vested in their employer contributions.

Note 6 - Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan administrator and third-party administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 - Party-in-Interest Transactions

Plan investments are shares of mutual funds, pooled separate accounts, or guaranteed interest accounts managed or issued by Principal Life Insurance Company. The Principal Group manages administration of the Plan. As the trustee and third-party administrator of the Plan, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for contract administrator, recordkeeping services, and investment management fees were included as a reduction of the return earned on each fund. Fees paid for administrative expenses were \$60,245 in 2024. Fees paid to the Plan's auditors are paid directly by the Plan's sponsor.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Concentrations

The balance in one investment accounted for approximately 21% and 18% of total investments as of December 31, 2024 and 2023, respectively.
