## Independent Auditors' Report

To the Plan Administrator of  
Brockway-Smith Company Savings and Investment Plan Trust:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Brockway-Smith Savings and Investment Plan Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and December 31, 2023 (in liquidation), and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Brockway-Smith Savings and Investment Plan Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Fidelity Management Trust Company, a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the liquidation basis of accounting described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Brockway-Smith Savings and Investment Plan Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter - Basis of Accounting**

As discussed in Note 2 to the financial statements, the governing body of the Brockway-Smith Company Savings and Investment Plan Trust approved a plan of liquidation on September 29, 2023, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting to the liquidation basis used in presenting the 2023 and 2024 financial statements. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the liquidation basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the liquidation basis of accounting described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

**Note 1 – Description of the Plan**

The following is a brief description of the Brockway-Smith Company Savings and Investment Plan Trust (the “Plan”) and is provided for general information purposes. Participants should refer to the plan documents for more complete information.

*General*

The Plan is a defined contribution plan covering all hourly and salaried employees of Brockway-Smith Company (“Company”) who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established and became effective on January 1, 1992 as a successor plan to the Brockway-Smith Profit Sharing Plan and Trust.

Due to the acquisition of the Company, the governing body of the Brockway-Smith Company Savings and Investment Plan Trust approved the termination of the Plan, effective September 29, 2023, and management determined liquidation is imminent. The termination is subject to provisions set forth by ERISA and the Plan is following the standard termination procedures set forth by the Department of Labor (“DOL”) and Internal Revenue Service (“IRS”).

*Contributions*

Prior to the Plan’s termination, participants could make pre-tax payroll contributions between 1% and 60% of annual compensation as defined by the Plan. The Plan was amended, effective December 28, 2006, to permit Roth deferral contributions and Roth direct rollover contributions. Employee contributions were subject to the overall annual limitations of the Internal Revenue Code. The Company could make matching contributions up to 100% of the employee pre-tax contribution. In 2023, the match was 25 cents for each payroll deferral deduction dollar contributed to the Plan by employees for the first, second, and third percent of their eligible wages. In addition, the Company elected to make a supplemental contribution equal to 3% of eligible earnings for all participating employees for the year 2023. Discretionary profit-sharing contributions could also be made annually by the Company on or before filing the Company’s income tax return. For the year 2023, the Company made a matching 401(k) contribution of \$155,839, a supplemental contribution of \$657,554, and a discretionary profit sharing contribution of \$939,990. Participants were able to allocate contributions among thirty-one investment options. There were no employer contributions in 2024 due to the Plan’s termination effective September 29, 2023.

*Participant accounts*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan earnings, and charged with an allocation of loan administrative fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The default funds are the Fidelity Freedom Funds.

*Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service.

All participants became 100% vested as of the termination effective date of September 29, 2023.

*Notes receivable from participants*

Prior to the plan's termination, an employee could apply for a general purpose loan from his or her account for a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of his or her vested account balance. These notes were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates as determined by Fidelity Management Trust Company, the Trustee of the Plan, in accordance with plan documents. Principal and interest were previously paid ratably through weekly or monthly payroll deductions.

An employee could also request a hardship withdrawal of the pre-tax contribution as defined in the plan documents prior to the plan's termination.

As of the termination effective date, the Plan disallowed any future loans. Participants who have loans are able to roll their outstanding loans into the acquiring Company's 401(k) plan. For any participant who chooses not to roll their outstanding loan balance, the loan status will be updated to terminated and will be deemed a distribution. The last date for participants to request the rollover was March 30, 2024. In 2024, \$10,358 in loans were deemed distributions due to the remaining participants choosing not to roll their outstanding loan balances and were included in benefits paid to participants on the Statements of Changes in Net Assets Available for Benefits.

*Payment of benefits*

On termination of service, including death, disability, and retirement, a participant may elect to receive benefits in a lump-sum cash payment or a rollover to an IRA or Qualified Plan.

Upon termination of the plan, distributions will be made in accordance with the basic plan document. Participants had until March 29, 2024 to request a rollover or distribution. All participants remaining in the plan after this date will be deemed to have elected to rollover their account balance into an IRA with Principal Bank. Participants invested in the collective investment trust fund may be subjected to withdrawal restrictions and distributions will be made when permitted under the terms of the investment.

*Forfeitures*

Employees who terminate prior to complete vesting forfeit the unvested portion of their employer contribution account balances. If a participant forfeits any portion of his non-vested account balance as provided in the basic plan documents, to the extent that such forfeitures are not used to pay plan administrative expenses, forfeitures shall be applied to reduce employer contributions. During 2023, forfeited non-vested accounts totaled \$34,711 and were used to reduce employer contributions. There were no forfeitures in 2024.

*Operating expenses*

All expenses of maintaining the Plan, excluding loan administration fees and administrative fees passed to terminated participants, are paid by the Company. Minimal accrued expenses are expected to be incurred in liquidation through December 1, 2025, the expected date of final distribution.

*Plan amendment*

The Plan was amended on September 29, 2023 to terminate the Plan, effective September 29, 2023. All participants became fully vested as of this date. Distributions will be made in accordance with the basic plan document.

**Note 2 – Summary of significant accounting policies***Basis of accounting*

As a result of the Plan's termination, the Plan changed its basis of accounting to the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America, used in presenting the 2023 and 2024 financial statements.

The liquidation basis of accounting requires the Plan to accrue costs and income that it expects to incur or earn through the end of its liquidation when there is a reasonable basis for estimation. Under the liquidation basis of accounting, assets are stated at their estimated net realizable value and liabilities are stated at their anticipated settlement amounts. As a result of the liquidation basis, net assets available for benefits decreased by \$255,841 and increased by \$265,339 for the years ended December 31, 2024 and 2023, respectively. The decrease in 2024 is due to accrued realized gains of \$3,064, accrued interest and dividends of \$6,434 and the reversal of the 2023 liquidation basis adjustment of \$265,339. The increase in 2023 was due to accrued realized gains of \$245,806, accrued interest and dividends of \$20,269 and accrued expenses of \$736.

*Use of estimates*

The preparation of financial statements in conformity with the liquidation cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

*Investment valuation and income recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan documents.

*Payment of benefits*

Benefits are recorded when paid.

**Note 3 – Related party transactions**

Affiliates of the Trustee of the Plan, Fidelity Management Trust Company, sponsor investments and provide recordkeeping services to the Plan. These investments and the administrative fees associated with the recordkeeping services qualify as party-in-interest transactions. However, these transactions are exempt from the prohibited transactions rules under ERISA. Fees paid by the Plan for the investment management services are netted against net appreciation or depreciation in fair value of investments.

**Note 4 – Information certified by the Trustee (unaudited)**

The following information included in the Plan's financial statements was derived from data certified by Fidelity Management Trust Company, the Trustee of the Plan, as being complete and accurate and has been furnished to the plan administrator. The Plan had no reportable transactions for the years ended December 31, 2024 and 2023.

**Note 5 – Investments at fair value**

The fair value measurements standard provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the fair value measurements standard are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation method are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

*Mutual funds*

These investments are valued at the net asset value (NAV) of shares held by the Plan at year-end. Mutual funds are classified within Level 1 of the valuation hierarchy.

## Notes to Financial Statements

*Collective investment trust*

The investment is valued using the NAV provided by the administrator of the fund as a practical expedient. The NAV is based on the fair value of the underlying investments held by the fund. Participant transactions (issuances and redemptions) may occur daily. Were the Plan to initiate a full redemption of the investment, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The investment seeks to preserve principal while earning a level of interest income consistent with principal preservation by investing in a portfolio comprising primarily investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds.

**Note 6 – Tax status**

The Internal Revenue Service has determined and informed the Company by a letter dated August 17, 2010, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognitions of a liability or disclosure in the financial statements.

## Notes to Financial Statements

The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress. The Plan's tax returns for tax years beginning 2021 through 2024 may be subject to examinations by the Department of Labor and the Internal Revenue Service.

**Note 7 – Plan termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

The governing body of the Brockway-Smith Company Savings and Investment Plan Trust approved the termination of the Plan, effective September 29, 2023. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and employer contributions into the Plan. An application for determination upon termination was filed with the Internal Revenue Service on May 4, 2024. A favorable determination letter response was received subsequent to year-end on January 13, 2025. Final distributions will be made as soon as possible after the termination date. Distributions will be made in accordance with the basic plan document, as described in Note 1. The Plan expects all accrued costs to be paid and the full liquidation to be completed by December 1, 2025.

**Note 9 – Subsequent events**

The Plan has evaluated subsequent events through August 11, 2025, the date the financial statements were available to be issued. As of August 8, 2025, the plan participants withdrew an additional \$297,353 in fund assets. The remaining assets left to distribute totaled \$626,981. The Plan expects to complete liquidation by December 1, 2025.
