### Opinion

We have audited the accompanying financial statements of BRPH Companies, Inc. Employee Stock Ownership Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

### NOTE A - DESCRIPTION OF PLAN

The following description of BRPH Companies, Inc. Employee Stock Ownership Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

BRPH Companies, Inc. and its participating subsidiaries (the "Company") established the BRPH Companies, Inc. Employee Stock Ownership Plan and Trust (the "Plan"). The Plan originally became effective on January 1, 1990.

The Plan invests primarily in Company stock and is designed to comply with Internal Revenue Code Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code ("IRC") of 1986, as amended and is also subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### 1. Eligibility

Employees of the Company are generally eligible to participate in the Plan following completion of ninety days of employment. Participants who do not have at least 1,000 hours of service during such Plan year and are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year.

#### 2. Contributions

The Company's Board of Directors shall determine the amount of the annual contribution to the Plan, if any, subject to certain requirements and limitations imposed by law. The Company shall allocate employer contributions to participants for each Plan year as of the Plan's anniversary date. The Plan does not permit or require participant voluntary contributions.

#### 3. Participant accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of (a) Company contributions (if any), (b) Plan earnings (or loss), and (c) previously unallocated forfeitures. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

#### 4. Vesting

A participant begins to vest after their second year of service (20%) and will be fully vested after six years of service. A year of service is earned when a participant works more than 1,000 hours in a calendar year.

5. Payments of benefits

Distributions on account of death, disability, or retirement are made in a lump sum in the Plan year following the event. Distributions for other separations from service commence in the fifth Plan year following the separation from service and are made in five annual installments. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock.

6. Forfeitures

Employer contributions and Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. There was approximately 827 shares of forfeited stock and \$347,490 in cash reallocated to participants during the year ended December 31, 2024.

7. Segregated accounts

Segregated accounts refer to the non-forfeitable portion of a terminated participant's account. The Company shall redeem the stock of a participant's company stock account at the fair market value determined by an independent appraiser at fiscal year-end immediately following the participant's termination. These segregated accounts shall remain a part of the Plan and may be invested by the Trustee as described in the Plan. Balances shall be credited with separate earnings, losses and expenses and no longer share in the investment gains, losses or expenses of the trust funds of active participants.

8. Diversification

Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Terminated participants who elect to diversify will receive a cash distribution. Participants eligible to diversify make their election after year-end based on the number of shares of employer's stock held in their account at year-end.

9. Voting rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

10. Put option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period not to exceed five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**NOTE B - SIGNIFICANT ACCOUNTING POLICIES**

1. Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

2. Valuation of investments and income recognition

The common stock of the Company is valued annually by annual independent appraisals. The fair value at December 31, 2024 and 2023 was \$66.40 and \$57.87 per share, respectively. For the purpose of determining basis for realized and unrealized gains and losses, fair value at the beginning of the year is used. See fair value measurements disclosure.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management and the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

4. Payments of benefits

Benefits are recorded when paid.

5. Investment policy

The Plan is required to invest primarily in Company securities and to invest the balance, if any, in qualified investments as defined in the Plan document. All investments of assets are nonparticipant-directed. Investment decisions are made by the Trustee at the direction of the Plan Committee.

6. Cash and cash equivalents

Cash and cash equivalents include all highly liquid debt instruments purchased with an original maturity of three months or less. The Plan considers money held in demand accounts, money market funds, and certificates of deposit to be cash and cash equivalents. The Plan's cash and cash equivalents are stated at cost, as reported by the Trustee, which approximates fair value.

7. Administrative expenses

Administrative expenses are absorbed primarily by the Plan sponsor.

#### NOTE C - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated January 10, 2017 that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate section of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### NOTE D - ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of the Company's common shares, are held by the Trustee of the Plan and accounted for by a third-party administrator, which invests cash received, interest and dividend income, and makes distributions to participants. The Company is the Plan sponsor as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

#### NOTE E - INVESTMENTS

#### NOTE F - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Sponsor Company Common Stock:* The fair value of the sponsor company common stock is determined by an annual valuation performed by an independent appraiser. These valuations were based on a combination of the market and income valuation approaches consistent with prior years. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums.

*Cash and cash equivalents:* Measured in U.S. dollars.

*Registered investments:* Value is based on quoted net asset values of the shares as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Under the supervision of the Company's Board of Directors, management determines the fair value measurement policies and procedures in consultation with the Company's chief financial officer. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

#### NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and the interest of each participant in the trust fund will be distributed to such participant or his/her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Trustees will pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in the loan suspense account, if any, to the extent it determines such sale to be necessary in order to repay the loan.

#### NOTE H - RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rates, market and credit risks, as well as valuation assumptions based on earnings and cash flows. Due to the level of risk associated with the investment in common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and party-in-interest transactions. As described in Note B, the Company pays the expenses of the Plan. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.
