### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

### **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Skyline Technology Solutions LLC 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) adopted on January 1, 2009. The Plan covers all employees, except for union employees and non-resident aliens with no U.S. source income, age 21 or older, of Skyline Technology Solutions LLC (the Company), who have completed 3 months of service. Service with Sentinel IT Solutions and Skyline Staffing Solutions, LLC is credited as service under the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The assets of the Plan are held and managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, and Empower Retirement, LLC provides recordkeeping services to the plan (collectively referred to as "Empower", the plan custodian).

#### **Contributions**

Participants may contribute up to 96% of their annual eligible compensation, as pre-tax or Roth Contributions, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC). Roth contributions are subject to federal income taxes in the year of deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans referred to as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various Mutual funds and a group variable annuity contract as investment options for participants.

The Plan includes an auto-enrollment provision whereby all eligible employees are auto-enrolled in the Plan, with a default pre-tax deferral rate set at 3% of eligible compensation, unless they affirmatively elect not to participate in the plan. This deferral rate escalates by 1% every year until the deferral percentage reaches 6% of the eligible compensation in the fourth year of service. Unless otherwise directed by the employees, contributions are automatically invested in the target date fund based on the participants' expected retirement age.

The Company provides a safe harbor matching contribution for all eligible employees, equal to 100% of the first 1% of the participants' salary deferrals contributed to the plan, plus 50% of salary deferrals up to the next 5% of Plan compensation contributed to the plan. The Company may also make discretionary profit-sharing contributions or additional qualified non-elective contributions in order to pass certain nondiscrimination tests as determined annually by the Company. During the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions to the Plan totaling \$952,193 and \$870,367, respectively. The Company did not make any discretionary profit-sharing or qualified non-elective contributions to the Plan in 2024 or 2023.

**Participant Accounts**

Each participant's account is participant-directed and is credited with the participant's contributions and allocations of the Company's contributions, investment earnings and losses and any administrative expenses paid by the plan. Allocations are based on participant investments held, account balances, or specific participant transactions, as defined. Plan participants have daily access to their account via phone or internet and may change the allocation of their investments to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their elective deferrals, rollovers and company's safe harbor and qualified non-elective contributions, plus actual earnings thereon. Vesting in the employer profit sharing contributions is based on years of continuous service. A participant becomes 100% vested in the Company profit sharing contributions to the plan after 2 years of service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (reduced by the balance of any prior loans from the Plan) or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The maximum duration of a loan is not to exceed five years, except in cases where funds are used to purchase a principal residence. Principal and interest are paid ratably through payroll deductions. The interest rates of the outstanding loans at December 31, 2024 and 2023 ranged from 4.25% to 9.50%.

**Payment of Benefits**

Upon termination of service due to retirement, death, full and permanent disability or attaining age 65, participants may elect to receive either a lump-sum amount equal to the value of their account, a direct rollover into a qualified retirement plan, or a combination of cash and direct rollover distribution. For termination of service due to other reasons, participants may receive their benefits in the form of a distribution equal to the value of the vested interest in their account. The Plan allows in-service withdrawals at age 59 1/2, as defined in the Plan document. Hardship distributions are not permitted.

**Forfeitures**

Forfeitures of nonvested balances of terminated participants may be used to reduce future employer contributions to the Plan or to pay plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$741 and \$3,204, respectively. During the years ended December 31, 2024 and 2023, the Company used \$2,614 and \$25,845, respectively from forfeited nonvested accounts to reduce employer contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts (FBRIC). Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to FBR investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of Estimates**

The preparation of the financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for FBRIC, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Contributions**

Contributions from Plan participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Benefit Payments**

Benefits payments are recorded when paid.

**Excess Contributions Payable**

Amounts payable to participants totaling \$1,365 and \$-0- as of December 31, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS are recorded as accounts payable.

**Administrative Expenses**

Administrative expenses may be paid either by the Plan or directly by the Company. The Plan is not required to reimburse the Company for expenses paid on behalf of the Plan. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

The Plan has a revenue sharing agreement with the plan custodian. If the custodian receives fund compensation above a certain amount, this excess compensation is made available to the Plan to offset expenses. During the years ended December 31, 2024 and 2023, Plan expenses totaling \$80,222 and \$57,512, respectively, were paid from revenue sharing funds. At December 31, 2024 and 2023, the balance available to offset future expenses totaled \$28,637 and \$32,928, respectively.

**NOTE 3 - CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively referred to as "Empower"), the custodian of the plan, as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets

(Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

Mutual funds represent investments with various investment managers. The mutual funds are valued at the daily closing net asset value (NAV) as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission and are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (FBRIC)**

The Plan participates in a fully benefit-responsive investment contract (FBRIC) with Empower Annuity Insurance Company of America (Empower). The assets under the contract are invested in the Empower Fixed Account. The Empower Investments Fixed Account (EIFA) is a general account product of Empower Annuity Insurance Company of America (EAICA), whereby participant principal and interest are backed by the entire general account assets of EAICA. The EI Fixed Account credits interest daily to the group contract holder on a portfolio basis. The credited interest rate may change or stay the same each quarter. The quarterly credited rate applies to all money deposited in the group contract holder’s account regardless of when it was deposited.

Participants may transfer their account balance in the EI Fixed Account to any other investment option offered under the Plan at any time with no restrictions or penalties and few exceptions. Based on EAICA's excessive trading policy, participant transfers may be restricted for up to 30 days in the event of excessive participant trading.

Because the group annuity contracts with Empower is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contracts are presented on the face of the statements of net assets available for benefits at contract value. The accounts' contract value approximated fair value at December 31, 2024 and 2023.

Certain events limit the ability of the Plan to transact at account value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 7 - TAX STATUS**

The Plan has adopted a prototype profit sharing plan sponsored by Atlantic Pensions services Inc. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The plan is subject to routine audits by taxing jurisdictions for the statutory period; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

The Plan's assets include investments in funds managed by Empower. Empower refers to products and services offered in the retirement markets by Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC (ETC) and their subsidiaries, including Empower Advisory Group, LLC, Empower Financial Services, Inc., Empower Retirement, LLC, Empower Capital Management, LLC, Empower Funds, Inc., Empower Annuity Insurance Company, and Empower Life & Annuity Insurance Company of New York. Putnam Investments, a subsidiary of Empower parent Great-West Lifeco was acquired by Franklin Templeton effective January 1, 2024. Transactions in funds and contracts from the above listed issuers qualify as party-in-interest transactions.

Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. There were no financial transactions recorded between the Company and the Plan other than contributions made. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements are available to be issued.


