### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Flaherty, Sensabaugh & Bonasso, P.L.L.C. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1. – Plan Description

---

The following description of the Flaherty, Sensabaugh & Bonasso, P.L.L.C. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Flaherty, Sensabaugh & Bonasso, P.L.L.C. (the "Company). The Plan excludes seasonal employees, contract employees, leased employees, non-resident aliens, and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Plan amendment*

Employees are eligible to make Elective Deferral Contributions and receive Employer Matching Contributions and Non-Elective Contributions on the a) first day of the first month of the Plan Year or b) first day of the seventh month of the Plan Year, coincident with or next following the date employee attains age 20.5 and completes 3 consecutive months of service, measured from date of hire, provided that they are an Eligible Employee at the end of that period.

Each year, participants may contribute any percentage, up to 100%, of annual compensation as defined, as pre-tax and/or Roth deferrals up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified Plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor makes matching contributions equal to 50% of a participant's elective deferral, not to exceed 6% of each participant's compensation. Additional amounts may be contributed at the option of the Company's Board of Directors. During 2024 and 2023, the Plan Sponsor made discretionary profit sharing contributions of \$610,479 and \$525,809, respectively. Contributions are subject to certain limitations.

#### *Investment Options*

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and participant-directed brokerage accounts, which consist of common stocks, preferred stocks, and mutual funds.

#### *Participant's Accounts*

Each participant's account is credited with the participant's contributions, the Company's matching and discretionary profit sharing contributions, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their elective contributions, rollover, and transfer contributions, plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of

credited service, as defined. Participants are 100% vested in Company contributions and related earnings after three years of service.

*Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account with interest rates that are commensurate with local prevailing rates as determined by the Plan's Administrator at the date of issuance. At December 31, 2024 and 2023, interest rates on loans ranged from 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions.

*Payment of Benefits*

Upon termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value in the participant's vested interest in his or her account. The Plan also includes provisions for in-service distributions.

*Administrative Expenses*

The Plan's administrative expenses are paid by either the Plan Sponsor or the Sponsor, on a discretionary basis.

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,332 and \$4,909, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. Fees for the year ended December 31, 2024, were reduced by forfeited non-vested amounts of \$26,673.

**Note 2. – Summary of Significant Accounting Policies**

---

*Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on

investments bought and sold as well as held during the year. Investment-related expenses are included in net depreciation of fair value of investments.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Notes Receivable from Participants*

Notes receivables from participants are reported at their unpaid principal balances plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

### *Payment of Benefits*

Benefit payments are recorded when paid.

### *Administrative Expenses*

The Plan's administrative expenses are paid by either the Plan or the Plan Sponsor, as provided by the plan document. Certain administrative functions are performed by employees of the Plan Sponsor. No such employee receives compensation from the Plan. Expenses related to specific participant transactions (notes receivable from participants, distributions and self-directed brokerage investments) are charged directly to the participants' accounts.

### *Subsequent Events*

Subsequent events have been evaluated through July 31, 2025, which is the date the financial statements were available to be issued.

## **Note 4. – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for

identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded. Mutual funds are classified within Level 1 of the fair value hierarchy.

*Self-directed brokerage accounts:* Accounts consist primarily of common stocks, preferred stocks and mutual funds that are valued on the basis of readily determinable market prices and are classified within Level 1 of the fair value hierarchy. The self-directed brokerage accounts also include the fair value of certain life insurance policies that are based on the cash surrender value of the individual policies as reported by the issuing insurance company. These life insurance policies are classified within Level 3 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 are reported in net appreciation in fair value of investments. The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers into or out of Level 3.

### Note 5. – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

### Note 6. – Party-In-Interest Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee received compensation from the Plan.

Plan participants invest in funds held or managed by the Plan's Trustees as well as other investment management companies. Investments in funds issued or managed by the Trustees are considered related party transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing rather than direct payment. Fees paid to the Trustees by the Plan for investment management, recordkeeping, and trust services amounted to \$182,704 for the year ended December 31, 2024.

### Note 7. – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 – Tax Status**

---

The Plan was adopted under a non-standard pre-approved profit sharing plan with CODA plan document from Metro Benefits, Inc. Metro Benefits, Inc., has received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the plan qualifies as tax exempt under IRC Section 401. An employer who has adopted this plan will also be considered to have a plan qualified under Section 401 provided that all terms of the plan are followed. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
