Note 1. Plan Description

The following description of Alpha, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of Alpha, Inc. (the Plan Sponsor), Lortscher Agri-Service, Incorporated and American Nutrition, Inc. (collectively, the Company). The Retirement Plan Committee is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees of the Company are eligible for the 401(k) savings feature of the Plan after they have completed 30 days of continuous service and are age 18 or older. Employees who are participating in the Plan are eligible for an employer safe harbor matching contribution and employer discretionary contributions after 12 months of continuous service. Plan entrance dates are the first day of each month following meeting the eligibility requirements.

Contributions: Participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Participants are also permitted to contribute Roth after-tax deferrals to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a percentage of eligible compensation unless the participant made an affirmative election otherwise. For the year ended December 31, 2024, the automatic deferral percentage was 3%. The deferral percentages for eligible participants increase by 1% each January 1, until their deferral percentage reaches 10%.

The Company makes a safe harbor matching contribution of up to 8% of the participant's pretax annual compensation, as defined in the Plan. The Company may also elect to make discretionary contributions. The Company did not make any discretionary contributions for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Investment options: Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

Participant accounts: Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contribution, as well as allocations of any discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures: Forfeitures are used to reduce future employer contributions or pay Plan expenses. During the year ended December 31, 2024, \$41,825 of forfeitures were used to reduce employer contributions and \$1,064 was used to pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,207 and \$345, respectively.

Note 1. Plan Description (Continued)

Vesting: Participants are vested immediately in their contributions and the employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions portion of their account is based on years of continuous service, according to the following schedule. A participant is 100% vested after six years of credited service.

Regardless of the vesting schedules above, participants who participated in the American Nutrition, Inc. 401(k) Plan, that merged into the Plan effective January 1, 2022, are vested immediately in their contributions and employer contributions, plus actual earnings thereon that were made into the American Nutrition, Inc. 401(k) Plan.

Payment of benefits: The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. If the balance of a terminated participant's account does not exceed \$1,000, the participant will receive a lump-sum payment in the absence of other instructions. If the participant's account balance exceeds \$1,000, but does not exceed \$5,000, then the Plan will distribute the funds to an individual retirement account if the participant did not make an affirmative election to either receive a distribution or rollover the distribution. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59½. Benefits are payable in lump-sum payments with certain exceptions allowed.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000, and up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. The number of loans a participant may have outstanding at one time is two. Loan terms of the notes cannot exceed five years unless the note receivable is for the purchase of the employee's principal residence. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator at the time of the loan. These rates ranged from 3.25% to 10.25% on outstanding loans, maturing through July 2051, at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and such changes could materially affect participant account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Notes receivable: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses, and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefit payments to participants are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company, and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation of fair value of investments.

Contributions: Contributions from Plan participants and the safe harbor matching and discretionary contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Note 2. Summary of Significant Accounting Policies (Continued)

Allowance for credit losses: The measurement of expected credit losses under the current expected credit loss (CECL) methodology is applicable to financial assets measured at amortized cost, which include employer and participant contributions receivable. An allowance for credit losses under the CECL methodology is determined using the loss-rate approach and measured on a collective (pool) basis when similar risk characteristics exist. Where financial instruments do not share risk characteristics, they are evaluated on an individual basis. The CECL allowance is based on relevant available information, from internal and external sources, related to past events, current conditions and reasonable supportable forecasts. Management recorded no allowance for credit losses as of December 31, 2024 and 2023, as all amounts were determined to be fully collectable.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Note 4. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: The common/collective trust is valued based on NAV of the units of the common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment, and size of the transfer, relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

Note 5. Related-Party and Party-in-Interest Transactions

The Plan invests in mutual funds and a common/collective trust managed through Empower Trust Company, LLC, the trustee, of the Plan. The trustee is a subsidiary of Empower Retirement, the recordkeeper of the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for trustee and recordkeeping amounted to \$169,795 for the year ended December 31, 2024.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the preapproved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an significant uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Prohibited Transactions

During the years ended December 31, 2024 and 2023, the Company inadvertently failed to deposit participant deferrals within the required time frame as stated by the DOL's regulations of \$1,618 and \$165, respectively. Lost earnings related to the late deposit in 2024 will be calculated and remitted into the Plan in 2025. The Company will file a Form 5330 and pay the applicable excise tax to the IRS in 2025. The lost earnings and excise tax payments will be made from the Company's assets and not from the assets of the Plan. Lost earnings related to the late deposit in 2023 were calculated and remitted into the Plan in 2024. The Company filed a Form 5330 in 2024. The applicable excise taxes were below the required payment threshold and hence no check was issued to the IRS. The lost earnings payments were made from the Company's assets and not from assets of the Plan.
