## Auditors' Communication of Internal Control

### **The Retirement Committee of Albert Einstein College of Medicine 403(b) Retirement Income Plan**

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Albert Einstein College of Medicine 403(b) Retirement Income Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

Our consideration of internal control was for the limited purpose described in the two paragraphs above and was not designed to identify all deficiencies in internal control that might be material weaknesses. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified. As indicated in the attached addendum, we identified several deficiencies in internal control.

Addendum to Report on Internal Control Related Matters

Deficiencies in Internal Controls

**A. Timely Deposit of Participant Contributions**

During our audit, we noted instances where participants' contributions were not remitted to the Plan in a timely manner. The Department of Labor ("DOL") requires that participants' contributions be remitted to the Plan on the earliest date on which they can be reasonably segregated from the plan sponsor's general assets but no later than the 15<sup>th</sup> business day following the end of the month in which the amounts are contributed by employees or withheld from their wages. Failure to remit participants' contributions to the Plan in a timely manner results in a prohibited transaction which must be separately reported to the DOL and may result in penalties to the plan sponsor.

***Recommendation***

We recommend that the plan sponsor review the procedures currently in place involving the remittance of participants' contributions to the Plan and institute the necessary controls to ensure that participant contributions are remitted in a timely manner.

**B. Participant Contribution Deferral Amounts**

During our audit, we noted that one participant's contribution deferral amount per payroll was different from the contribution deferral amount elected by the participant per the Plan's record-keeper.

***Recommendation***

We recommend that the plan sponsor perform a detailed review of each participant's requested contribution deferral amount. The contribution deferral amount per payroll should agree to the deferral amount elected by each participant as documented by the Plan's record-keeper. In addition, any deferral changes should be updated in the payroll system in an accurate and timely manner.

## **Auditors' Communication with Those Charged with Governance**

We have audited the financial statements of Albert Einstein College of Medicine 403(b) Retirement Income Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) as of and for the year ended December 31, 2024, and we issued our report thereon dated August 7, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America ("U.S. GAAP"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated January 6, 2025. Professional standards also require that we communicate to you the following information related to our audit.

### **Qualitative aspects of significant accounting practices**

#### *Significant accounting policies*

Plan management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

#### *Significant accounting estimates*

Accounting estimates made by the Plan's management are an integral part of the financial statements and are based on Plan management's knowledge and experience about past and current events and assumptions about future events.

Certain accounting estimates are particularly sensitive because of their significance to the financial statements and their susceptibility to change. Management believes that the estimates used and assumptions made are adequate based on the information currently available. We evaluated the key factors and assumptions used to develop the estimates in relation to the value of the Plan's investments in determining that they are reasonable in relation to the financial statements as a whole.

#### *Financial statement disclosures*

The financial statement disclosures are consistent and clear.

#### *Going concern*

We concur with management's assessment that the Plan will continue as a going concern for one year from the auditors' report date.

#### *Significant risks*

We have identified the following significant risks in connection with our audit:

- Revenue recognition; and
- Plan management override of controls.

#### *Form 5500 procedures*

We are required to obtain and read a substantially completed draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties encountered during the audit*

We encountered no significant difficulties in performing and completing our audit.

#### *Corrected and uncorrected misstatements*

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. No misstatements were identified during our audit.

#### *Disagreements with management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

#### *Representations requested from Plan management*

We have requested certain written representations from the Plan's management in a separate letter dated August 7, 2025.

*Management consultations with other independent accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditors’ opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

*Other matters discussed with Plan management*

We generally discuss with the Plan’s management a variety of matters, including the application of accounting principles and auditing standards, business conditions affecting the Plan, and future plans and strategies that may affect the risks of material misstatement. None of the matters discussed and our responses thereto were a condition to our retention as auditors.

*Other matters supplemental schedules*

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, are presented in compliance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We have performed audits of the accompanying financial statements of Albert Einstein College of Medicine 403(b) Retirement Income Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Description of Plan**

The following description of the Albert Einstein College of Medicine 403(b) Retirement Income Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan, which became effective September 1, 2015, is a defined contribution plan covering substantially all employees of Albert Einstein College of Medicine (the “Employer”) the successor to the Albert Einstein College of Medicine, Inc. except for: (1) any person employed by the Employer who is part of a unit of employees covered by a collective bargaining agreement, unless such collective bargaining agreement expressly provides for inclusion of such person but only to the extent such agreement so provides; (2) any person who is a leased employee; (3) any person who is an independent contractor; (4) with respect to Employer contributions, any employee who is: (a) classified as a post-doctoral research fellow not supported by a training grant, (b) a visiting scientist, (c) a research trainee, (d) a casual staff instructor, (e) a research intern, (f) an adjunct faculty member; (g) a member of the 1199 Service Employees International Union; (h) a person who is part of a unit of employees covered by any other collective bargaining agreement, unless such collective bargaining agreement expressly provides for the inclusion of such a person with respect to such contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On September 9, 2015, the Yeshiva University (the “University”) entered into a Joint Collaboration Agreement regarding Albert Einstein College of Medicine (the “School”), an operating division of the University, with Montefiore Medicine Academic Health System, Inc. (“MMAHS”). MMAHS is the sole member of Montefiore Health System, Inc. which is the sole member of Montefiore Medical Center (“Montefiore”), the School’s principal teaching hospital. Pursuant to the Joint Collaboration Agreement, the University transferred operational and financial responsibility for the School to a newly-created not-for-profit corporation Albert Einstein College of Medicine, Inc. (the “College”). As of January 1, 2019, Albert Einstein College of Medicine, Inc. was merged into Albert Einstein College of Medicine. The College is a non-for-profit membership corporation with two members, MMAHS and the University. MMAHS is the controlling member with 51% of the voting interests in the College. The University has a 49% voting interest in the College. The transitional period is complete, therefore, the University’s role in the operation of the Medical School and its right as a member have decreased to certain reserved rights including the right to appoint one member of the College’s board. Effective September 8, 2015, the College employees were fully vested in matching contributions made by the University on their behalf to the Yeshiva University Retirement Income Plan (“Yeshiva Plan”). The College became a participating employer through December 30, 2015. On December 31, 2015, the assets and liabilities attributable to the accounts of the College employees were transferred to the Plan from the Yeshiva Plan. The College employees ceased to be eligible for the Yeshiva Plan and became eligible for the Plan on January 1, 2016.

**1. Description of Plan (continued)**

***Contributions***

Each year, participants may contribute up to 80% of their annual compensation on a pre-tax or after-tax (Roth) basis, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employees hired or rehired on or after April 1, 2017, will be automatically enrolled in the Plan as soon as administratively feasible after the opt-out period ends. The opt-out period is the 30-day period beginning on an employee's date of hire or rehire. All automatically enrolled employees will contribute 4% of their eligible compensation on a pre-tax basis and if they don't opt out of automatic escalation, their deferral will increase each January 1<sup>st</sup> by 1% up to a maximum of 8% of a participant's eligible compensation.

The Employer makes contributions in an amount equal to 7.5% of each eligible participant's eligible compensation up to \$285,000 of salary. For the 2024 plan year, Employer contributions amounted to \$9,493,779.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are fully vested in their contributions (pre-tax, Roth and rollover) and earnings thereon; however, the employer contributions are subject to a three-year cliff vesting schedule. A participant that (a) reaches normal retirement age; (b) becomes disabled (as defined); or (c) dies while an employee, shall be 100% vested in their account regardless of years of service. Contributions that were made under the Yeshiva Plan and transferred to the Plan as of December 30, 2015 are 100% vested. Effective November 4, 2024, certain employees who were part of a spin-off became 100% vested in their account balances.

***Forfeitures***

Forfeitures of terminated non-vested accounts are first used to reinstate any Employer contributions (if a participant is rehired by the Employer prior to incurring five consecutive 1-year periods of termination) and then may be used to reduce future Employer contributions or to pay Plan expenses. At December 31, 2024 and 2023, forfeited account balances held in non-participant directed accounts were \$62,281 and \$659,741. During 2024, Employer contributions were reduced by \$1,178,344 from the forfeited non-vested accounts. During 2024, no forfeitures were used to reduce Plan expenses.

***Revenue Credit Account***

The Plan and Fidelity Management Trust Company have entered into a revenue sharing arrangement whereby a portion of the revenue earned by certain funds is passed through to the Plan for either (1) payment of permitted Plan expenses or (2) reallocation back to participants on a pro rata basis. In order for the Plan to receive and use these credits, the Plan has created a Revenue Credit Account. The Revenue Credit Account is an account within the Plan and is used to record-keep the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. At December 31, 2024 and 2023, the Revenue Credit Account balance was \$112,176 and \$36,698. During 2024, \$81,274 was used from the revenue credit account to pay non-recordkeeping Plan administrative expenses (such as investment consulting, auditing and legal) and \$0 was allocated back to participants.

***Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

***Payment of Benefits***

Benefits are paid upon retirement (age 65), death, disability, or termination of employment. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of the participant's account, an annuity contract to be distributed under an option of the participant's choice, or a combination of both. In-service withdrawals are allowed at age 59 ½ for the participants account balance sourced from employee contributions (pre-tax and/or Roth after-tax), and any vested amounts of employer contributions from all or any part of the participants account balance sourced from rollover contribution or in the event of a hardship as defined by the Plan.

***Expenses***

Effective July 1, 2022 all plan-related expenses are paid by the Plan's participants. The Employer will pay expenses of maintaining the Plan to the extent they are not paid from the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Loans are collateralized by the balance in the participant's account and bear interest as determined at the time of loan origination (commensurate with the interest rates charged by persons in the business of lending money for loans with similar characteristics). Principal and interest are paid directly by the participant to the Plan. The loan must be repaid within a five-year period, unless the loan is used to acquire the principal residence of the borrower, which must be repaid within twenty years from the date of the loan.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

**2. Summary of Significant Accounting Policies (*continued*)**

***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value, except for the guaranteed investment contracts, which are stated at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. These mutual funds are deemed to be actively traded. The guaranteed investment contracts are valued at contract value, which represents contributions made under the contract, plus interest credited, less withdrawals and fees.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

***Payment of Benefits***

Benefits are recorded when paid.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 7, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends on investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

**4. Guaranteed Investment Contracts**

***Prudential Guaranteed Interest Account***

The Guaranteed Interest Account (“GIA”) is a fully benefit-responsive group annuity product issued by Prudential Insurance Company of America (“Prudential”) and reinsured and administered by Empower Annuity Insurance Company of America, which is designed to provide safety of principal, liquidity and a stable rate of return. GIA invests in a broadly diversified fixed income portfolio within Prudential’s general account. The portfolio is primarily invested in public bonds, commercial mortgages, and private placement bonds. Principal and accumulated interest are fully guaranteed by Prudential. The interest crediting rate is declared in advance and is guaranteed for a specified period of time.

Generally, a participant may withdraw all or a portion of their GIA assets without any fees or restrictions for benefit responsive events (e.g. termination of employment, retirement, disability, death, etc.). Transactions which are not the result of benefit responsive events may be subject to restrictions and/or charges. Amounts withdrawn from GIA may not be transferred to a competing fund or transferred back into GIA for a period of 90 days after the withdrawal date.

Since the GIA is fully benefit-responsive, it is recorded at contract value on the statements of net assets available for benefits.

***Prudential Guaranteed Interest Separate Account***

The Guaranteed Interest Separate Account (“GISA”) is a fully benefit-responsive group annuity product issued by Prudential and reinsured and administered by Empower Annuity Insurance Company of America, which is designed to provide safety of principal, liquidity and a stable rate of return. GISA is invested in a separate account, which is a diversified portfolio of fixed-income assets. The separate account is insulated from Prudential’s general account. Principal and accumulated interest are fully guaranteed by Prudential.

Restrictions or fees may apply to exchanges or withdrawals. The contracts provide for the payment of certain withdrawals and exchanges at book value during the terms of the contracts. In order to maintain the contract issuers’ promise to pay such withdrawals and exchanges at book value, the contracts subject the participants to certain restrictions. For example, withdrawals prompted by certain events (e.g., layoffs, early retirement windows, spin-offs, sale of a division, facility closings, plan terminations, partial plan terminations, changes in laws or regulations) may be paid at market value, which may be less than the book value balance or may restrict withdrawals in these events. Certain investment options (e.g., money market funds, short term bond funds, certain asset allocation/lifecycle funds and brokerage window) may be deemed a competing fund. The terms of the contracts prohibit a participant from making a direct exchange from the GISA to a competing fund. Instead, a participant must first exchange to a non-competing fund for 90 days.

Since the GISA is fully benefit-responsive, it is recorded at contract value on the statements of net assets available for benefits.

**5. Tax Status**

The Employer has adopted an approved prototype plan document which received an Internal Revenue Service (“IRS”) opinion letter dated August 7, 2017. The Employer believes the Plan is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**6. Party-in-Interest Transactions**

Certain Plan investments are managed by an affiliate of Fidelity Management Trust Company and Fidelity Workplace Services LLC is the record-keeper of the Plan. Fidelity Management Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Employer who may also be participants in the Plan. No such officer or employee receives compensation from the Plan.

**7. Prohibited Transactions**

For the year ended December 31, 2024, the Employer failed to transmit to the Plan certain participants’ contributions totaling \$85,681 within the period prescribed by Department of Labor regulations. The Employer is in the process of making the necessary corrections.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
