## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of AFAAC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. DESCRIPTION OF THE PLAN

The following brief description of the AFAAC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General** — The Plan is a defined contribution plan covering eligible employees of the Air Force Academy Athletic Corporation (the Corporation). Employees who are not independent contractors and are at least 21 years old and have completed ninety days of service are eligible to participate in the Plan. Effective January 1, 2023, seasonal employees are excluded from participating in the Plan unless they complete one year of service. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Contributions** — A participant may elect to have their compensation withheld by the Corporation and contributed to the Plan on their behalf as an elective contribution in lieu of receiving such amount as compensation. Such contributions may not exceed the limits established in the Internal Revenue Code (IRC).

The Corporation makes safe harbor contributions equal to 100% of each participant's first 5% of elective deferrals. The Corporation may also make discretionary contributions to the Plan.

**Automatic Enrollment** — The Plan provides for eligible employees with no deferral election to be automatically enrolled in the Plan at a contribution rate of 6% of compensation. The elective deferral contribution will automatically increase every year by 1%, up to a maximum elective deferral contribution of 10%. Participants may affirmatively elect a different percentage or elect to not make deferral contributions.

**Participant Accounts** — Each participant shall have one account and such account will be credited with the participant's contributions, an allocation of the Corporation's contributions, and an allocation of the Plan's earnings and losses. The Plan's earnings or losses, excluding that related to participants' loans, are allocated to the participant's account based upon the proportion that each participant's account bears to the total participant account balances related to that fund. Earnings resulting from loans to participants are credited to the respective participant's accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investments of their contributions into various investment options offered by the Plan.

**Notes Receivable from Participants** — Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates. Principal and interest is paid ratably through regular payroll deductions.

**Payment of Benefits** — Upon separation of service, the Plan will distribute vested account balances not exceeding \$5,000 in a lump-sum as soon as administratively practicable. Upon separation of service, a participant with a vested account balance greater than \$5,000 may elect to receive a lump-sum payment or maintain the vested balance in the Plan. A participant may also elect to receive an account distribution if the participant has attained the age of 59 ½ or incurred a hardship in accordance with Plan provisions.

**Vesting** — Participants are 100% vested at all times in their account balances.

**Administrative Costs** — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Corporation. Expenses that are paid by the Corporation are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

**Plan Termination** — Although they have not expressed an intention to do so, the Corporation has the right to terminate the Plan at any time.

**Tax Status** — The Plan is a non-standardized plan of Ascensus, LLC. Ascensus, LLC obtained its latest non-standardized plan determination letter dated June 30, 2020, stating that the non-standardized plan is qualified under Section 401 of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has concluded that as of December 31, 2024, the Plan has no material uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** — The accompanying financial statements have been prepared on the accrual basis of accounting.

**Valuation of Investments and Income Recognition** — Investments are reported at fair value except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors and the asset custodian. See Note 3 for information on fair value measurements.

Fully benefit-responsive investment contracts held by a defined-contribution plan are required to be reported at contract value.

Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Key Guaranteed Portfolio Fund represents a fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains or losses on investments bought and sold as well as held during the year. All investment income from collective investment trusts and pooled separate accounts is included within the net appreciation or depreciation in fair value of investments consistent with the presentation provided by the Plan's custodian.

**Use of Estimates** — The preparation of financial statements in conformity with the accrual basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Notes Receivable from Participants** — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Benefit Payments** — Benefits are recorded when paid.

**Subsequent Events** — The Plan has evaluated subsequent events for recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available for issuance.

### 3. INVESTMENTS

**Key Guaranteed Portfolio Fund** — As described in Note 2, since the Key Guaranteed Portfolio Fund is fully benefit-responsive, contract value is the relevant measurement attribute for this investment contract. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Interest earned on the Key Guaranteed Portfolio Fund is compounded daily to the effective annual interest rate. The interest rate to be credited is determined quarterly. Amounts may be transferred from the participant's account balance in the Key Guaranteed Portfolio Fund at any time.

Termination of the agreement or full Plan withdrawal from this account could restrict the liquidation of account balances. Management believes this is unlikely to occur.

**Fair Value Measurements** — Generally accepted accounting principles require the Plan to use a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2: Valuations determined using significant other observable inputs. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Valuations determined using significant unobservable inputs.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Collective investment trusts and pooled separate accounts* — Valued at the net asset value of shares held by the Plan at year-end. The net asset value is used as a practical expedient to measure fair value. This practical expedient would not be used if it is determined to be probable that the investment will be sold for an amount different from the reported net asset value. There are no significant restrictions on the accounts. Investments for which fair value is measured using the net asset value per share practical expedient are not categorized within the fair value hierarchy.

*Registered Investment Companies* — Valued at the quoted prices of shares held by the Plan at year end. The shares are actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Plan investments included the Key Guaranteed Portfolio Fund, a pooled separate account and mutual funds of Empower Annuity Insurance Company of America and Empower Trust Company, LLC. These are investment vehicles of the custodian of the investments, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are considered party-in interest transactions.
