Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from a qualified institution as of December 31, 2024 (in liquidation) and 2023 (ongoing), and for the year ended December 31, 2024 (in liquidation), stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

Basis for Opinion

As a result, the Plan changed its basis of accounting from the ongoing basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Management's Responsibilities for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events that, considered in the aggregate, raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Note 1 – Plan Description

The following description of the Lansdowne-Moody Company LP 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Lansdowne-Moody Company LP (“Company” or “Employer”) is the Plan Sponsor. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

Plan Termination

On December 2, 2024, the Plan’s governing body decided to terminate the Plan effective January 1, 2025 (“Termination Date”), and to distribute Plan assets as soon as administratively feasible. Effective December 19, 2024, the Plan ceased all contributions and new participant loans. The nonvested portion of all participant accounts were fully vested upon the Termination Date. All participants received an account closing distribution of their account balances based on their distribution election. Distributions were requested in lump sum cash distribution or as a direct rollover to an Individual Retirement Account (“IRA”) or other qualified retirement plan. As of December 31, 2024, the distribution of Plan assets was not complete, and the trust was not fully liquidated and terminated.

General

The Plan is a defined contribution 401(k) profit-sharing plan that provides retirement savings benefits to eligible employees. The Plan commenced effective January 1, 1962, and was amended and restated to comply with the latest rules and regulations effective February 17, 2022. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

Principal Life Insurance Company (“Principal”) and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (collectively, the “Custodians”) are the Custodians of the Plan, maintaining custody of all investments held by the Plan, maintaining the Plan’s participant account balances, and providing record-keeping services to the Plan. Among other duties, the Custodians receive contributions, hold and invest the fund assets in accordance with the directions of participants, and make distributions as directed by the Plan Administrator. An officer of the Company serves as Trustee of the Plan.

Eligibility and Plan Entrance Date

Except for leased employees, union employees covered by a collective bargaining agreement, and nonresident aliens who receive no United States source income, all employees become eligible to participate in the Plan upon reaching the age of 21 and completing 90 days of service. Eligible employees are permitted to enter the Plan upon the first day of each quarter coincident with or next following satisfaction of the eligibility requirements.

Contributions

Prior to the Termination Date, participants were permitted to contribute, on a before-tax and Roth basis, up to 100% of their eligible compensation up to the maximum amount allowed for deferral annually by the IRC, which was \$23,000 for 2024. Participants who reached the age of 50 before the end of the Plan year were eligible to make catch-up contributions of up to maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

Note 1 – Plan Description (continued)

Contributions (continued)

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Plan also includes an auto-escalation feature whereby a participant's deferral rate automatically increases by 1% annually until the participant reaches a deferral rate of 10%, provided that the participant has a deferral rate of greater than 0% and has not elected to not participate in the auto-escalation.

At the discretion of management, the Employer may make discretionary matching and profit-sharing contributions to the Plan on behalf of participants. In the year ended December 31, 2024, the Employer made matching contributions in an amount equal to 25% of the first 6% of the eligible compensation that a participant contributed to the Plan. The Employer did not make any profit-sharing contributions during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's and Employer's contributions and an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may direct their account balances to one or more of these investment options, which vary in type of investments, rate of return, and investment risk.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Prior to the Termination Date, vesting in the Employer's discretionary matching and profit-sharing contributions, plus any income or loss thereon, was based on years of service according to the following schedule:

Notes Receivable from Participants

Prior to the Termination Date, participants were permitted to borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans were secured by the balance in the participant's account. The loan interest rate, determined quarterly, was set at 1% above Prime rate, as defined. Principal and interest were paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant receives a lump sum distribution of the vested portion of his or her account. If the vested account balance exceeds \$5,000, the participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. Distributions to a terminated employee with a vested account balance not exceeding \$5,000 are automatically made as soon as administratively feasible. If the vested account balance exceeds \$1,000 and the participant has not elected to receive or rollover the distribution, the Plan permits automatic rollover of the distribution into an individual retirement account.

A participant may withdraw all or a portion of their account in the event of a financial hardship as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

Effective December 2, 2024, the Plan's governing body decided to terminate the Plan. As a result, the 2023 financial statements have been prepared on the ongoing basis, and the 2024 financial statements have been prepared on the liquidation basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, Custodian, and insurance company. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan Agreement.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain expenses incurred by or attributable to a specific participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission and required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Pooled Separate Accounts** – Valued using the NAV of units held by the Plan at year-end as provided by Principal. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate accounts, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or unfunded commitments.

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, have certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate.

The Plan’s independent auditor did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental information.

Note 5 – Guaranteed Investment Contract with Insurance Company

The Plan maintains a traditional fully benefit-responsive investment contract with Principal (“Contract Issuer”). This separate account guaranteed interest contract (“SAGIC”) maintains contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the SAGIC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Contract Issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the SAGIC is fully benefit-responsive, contract value is the relevant measurement for the portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the Contract Issuer or otherwise. The crediting interest rate is reviewed on a quarterly basis for resetting. The SAGIC does not allow for a crediting interest rate below 0%.

Certain events limit the Plan’s ability to transact at contract value with the Contract Issuer. Such events include: (1) amendments to the Plan Document (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (ex: divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemptions from either federal income taxes or any required prohibited transaction under ERISA.

The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The SAGIC does not permit the Contract Issuer to terminate the agreement unless the Plan is not in compliance with the investment agreement.

Note 6 – Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds or units of pooled separate accounts that are managed by the Custodians, and thus qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions that are exempt from being prohibited transactions by ERISA.

Note 7 – Tax Status

The Plan adopted a non-standardized, preapproved profit-sharing plan sponsored by Principal. In a letter dated June 30, 2020, the IRS informed Principal that it had determined that the Plan and related trust were designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 – Prohibited Transactions

During 2019, the Company failed to remit to the Plan's Custodians certain participant contributions and loan repayments totaling \$38,568 within the period prescribed by the DOL's Rules and Regulations. Delays in remitting contributions to the Custodian were due to unintentional administrative errors. As of the date of these financial statements, this has not been corrected.
