INDEPENDENT AUDITORS' REPORT

To the Plan Trustees and Management
Simkins-Hallin, Inc. 401(K) Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Simkins-Hallin, Inc. 401(K) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Simkins-Hallin, Inc. 401(K) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

1. Description of the Plan

The following description of the Simkins-Hallin, Inc. “Simkins-Hallin” or “the Company” 401(K) Plan and Trust “the Plan” provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

General

The Plan was established in 1994 to comply with the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is a defined contribution plan covering all eligible employees of Simkins-Hallin. Plan participants’ accounts are administered and managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (“Empower”). As the trustee, Empower receives contributions and executes transactions under the direction of Simkins-Hallin, Inc. The Board of Trustees is responsible for the oversight of the Plan. This Committee determines the appropriateness of the Plan’s investments offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

Eligibility

Employees are eligible to participate in salary deferral contributions and the safe harbor match after six months of service and once they have reached the age of 18. Entry into the Plan is on a monthly basis.

Automatic Enrollment

Once eligibility requirements are satisfied, there will be an automatic salary deferral of 3% of pre-tax compensation. The automatic enrollment process has an automatic escalation feature whereby newly eligible participants will have their default 3% deferral of base pay increase 1% each year until the participant is contributing 10%, unless the participant elects otherwise.

Contributions

Each year, participants in the Plan are allowed to contribute a specific percentage or dollar amount of pretax annual compensation. Participants 50 years of age or older at the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute distributions from other qualified defined benefit or defined contribution plans rollover. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant contributions qualify for Company safe harbor matching contributions equal to a specified percentage of the amount of the salary reduction participants have deferred. The Company matches the employee contribution 100% up to 3% of compensation and 50% for amounts over 3% but not exceeding 5% of compensation. For the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions of \$291,593 and \$309,606, respectively, to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Contributions (continued)

The Company may also elect to make a discretionary contribution to the Plan. The participant must be actively employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year. The employer can make a discretionary contribution even if the employee does not participate in the Plan that year. The Company did not make any discretionary contributions for the years ended December 31, 2024 and 2023. Participants may elect Roth 401(k) deferrals. These deferrals are subject to federal income taxes in the year of deferral.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of (a) the Company's contributions, (b) account earnings or losses, (c) forfeitures of terminated participants' nonvested accounts, and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the participant's vested account balance.

Investment Options

Participants may direct contributions, including Company matching and retirement account contributions, in whole percentage increments to any of the investment options offered by the Plan.

Vesting

Participants are immediately vested in safe harbor contributions and their contributions plus actual earnings (losses) thereon. Vesting in the Company's discretionary contributions, and earnings thereon, is based on the number of years of service.

Company discretionary contributions vest according to the following schedule:

Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months

Payment of Benefits

The Plan is designed to provide benefits at the time of retirement. However, if employment is terminated because of death, disability or retirement, the participant may request distribution of his or her vested account balance. The distribution may be made in a lump-sum amount or annual installments over a 10-year period. If the employee is terminated for another reason, the participant may only receive a lump-sum distribution. Hardship distributions out of the participant's voluntary contributions account are not permitted. The Plan also allows for in-service distributions upon reaching age 59 ½.

Forfeiture Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$273 and \$0, respectively. Forfeitures are used to reduce future Company contributions or to pay administrative expenses of the Plan, in accordance with the Plan document.

Benefit Obligations

As of December 31, 2024 and 2023, no benefit obligations existed for individuals who withdrew from the Plan.

2. Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America. Investment contracts held by the Plan are required to be reported at fair value. Participant loans are valued at amortized cost, which represents fair value.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred by the Plan, not including those expenses covered by the participants, are paid by the Plan Sponsor or through the forfeiture accounts. For the years ending December 31, 2024 and 2023, \$760 and \$361 were paid out of the Plan's forfeiture accounts, respectively.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value investments. Shares of mutual funds are valued daily at the net asset value of shares held by the plan. The Retirement Committee determines the Plan's valuation policies. See Note 3 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

4. Investments in Insurance Contract

The Plan entered into a group annuity contract with Empower Annuity Insurance Company of America. The group annuity contract, Key Guaranteed Portfolio Fund, is a fixed account that is part of the general account of Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest crediting rate (which will never be less than 0% as stated in the contract), and prevailing market conditions. Interest crediting rate is reset quarterly. At December 31, 2024 and 2023, the Key Guaranteed Portfolio Fund's fair value equaled its contract value.

4. Investments in Insurance Contract (continued)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include premature termination of the contracts by the Plan, layoffs, plan termination, bankruptcy, mergers and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The average yield earned by the Plan is derived by averaging the quarterly gross interest rates for the fund over the year. The average yield for the years ended December 31, 2024 and 2023 was 1.41% and 1.23%, respectively. The actual average yield earned by the Plan is derived by averaging the Plan's quarterly interest rates.

5. Tax Status

The Internal Revenue Service has determined and informed the Company by letter, dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue code. Although the Plan has been amended since receiving the latter, the Plan administrator and legal counsel are of the opinion that the Plan continues to fulfill the requirements of a qualified plan under Section 401(a) of the Internal revenue Code and that the Plan is not subject to tax. Accordingly, no provision for federal or state income taxes has been provided.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of Plan termination, participants become fully vested in their account balances.

7. Information Prepared and Certified by Trustee

The Plan administrator has elected the method of compliance in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 8. Related-Party Transactions

Certain Plan investments are shares of mutual funds managed Empower. Empower is the Plan custodian, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for investment management services are included in administrative expenses on the statement of changes in net assets available for benefits. Fees incurred and paid by the Plan for the investment management services were \$3,865 and \$3,251 for the years ended December 31, 2024 and 2023, respectively.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
