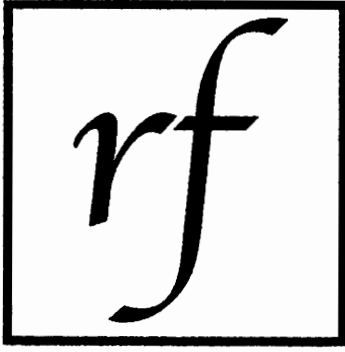

Note 1 Description of Plan

The following description of the Centennial Mental Health, Inc. 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Centennial Mental Health Center, Inc. (the "Center") established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Center, as defined in accordance with the universal availability standards, are eligible to enroll on their hire date. An employee becomes a participant in the elective deferral portion of the Plan on his/her first day of employment. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's custodians are Nationwide Mutual Insurance Company (Nationwide) and the Variable Annuity Life Insurance Company (VALIC).

Plan Contributions

For the calendar year 2024, participants may contribute up to \$23,000 annually (plus \$7,500 catch-up contributions for participants aged 50 and older) of their pretax wages by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan, (2023 limits were \$22,500 and \$7,500). The Center has the discretion to make matching contributions of 3% of base pay (Code Section 3401 federal income tax withholding wages increased by Elective Deferrals) per payroll period after one month of service and reaching the age of 18 if the employee contributes at least 3%. Elective deferrals in excess of 3% are not matched. After 3 years of participation in the Plan the employer match increases to 4%. Total annual contributions to the Plan (both employee deferrals and employer matching contributions) may not exceed \$66,000 (\$66,000 for 2023), as adjusted for inflations by the Secretary of the Treasury. All matching contributions apply to age 50 catch-up deferrals.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Center's contributions and Plan gains or losses. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

Investment Options

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Center's contributions into various investment contracts offered by the Plan.

Distributions

Upon retirements, disability or death, a participants or beneficiary receives the entire amount credited to the participant's account either in a lump sum or. for required minimum distributions only, in annual installments. Upon termination of

employment, other than retirement, disability, or death, a participant becomes eligible to receive the current value of the participant's vested account in a lump-sum. Hardship distributions are allowed for the deferral portion of a participant's account, including earnings thereon.

Vesting

Participants are immediately vested in their elective deferral contributions, rollovers, and actual earnings thereon. Vesting in the Center's matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. An employee must complete at least 1,000 hours of service during a vesting computation period continuous to receive service: credit for a year of service. The following summarizes vesting by years of continuous service.

1 Year	0%
2 Years	25%
3 Years	50%
4 Years	75%
5 Years	100%

Notes Receivable from Participants

Participants may borrow from their account balance with interest charged at a rate of prime plus 1 % above USA Today published prime rate. The interest rate remains in effect for the duration of the loan. Loan terms range from 1 to 5 years or up to 30 years for the purchase of a principal residence. The minimum loan amount is \$1,000 and the maximum loan is the lesser of \$50,000 or 50% of the participant's vested account balance.

The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through after-tax payroll deductions and are credited to the participant's account. Full and partial prepayments are permitted; however, loans may not be consolidated or refinanced. Participants may only have two loans outstanding at any time. As of June 30, 2024, and 2023, the Plan had notes receivable from participants with principal balances totaling \$16,907 and \$16,920, respectively, which are included with receivables in the accompanying Statements of Net Assets Available for Benefits.

Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified or 403(b) plans.

Forfeited Accounts

The Plan did not have any forfeited nonvested accounts as of June 30, 2024.

Note 2 Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of

assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts) which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully benefit-responsive investment contracts held by a defined-contribution plan are required to be reported at contract value. Contract value is the relevant measure attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the BOA Fixed contract at June 30, 2024, and 2023, represents non fully benefit-responsive investment contract, under SOP 94-4-1, insofar as the contract does restrict participant directed exchanges.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions

Contributions from employees and the Center are recorded in the period in which the Center makes the payroll deductions from participant earnings.

Distributions

Distributions are recorded when paid. On June 30, 2024, and 2023, there were no benefits processed and approved for payment, but not paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Center and are excluded from these financial statements. Specific fees related to the administration of investments are charged directly to the individual participant's accounts and are included in administrative expenses. All other investment related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

Subsequent events have been evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 3 Investments

The Plan's investments were administrated by the following service provider: National Benefit Services, LLC. The investments were held by nbs (national benefit services) the Variable Annuity Life Insurance Company (VALIC).

Note 4 Fair Value of Investments

The Plan uses a framework pursuant to generally accepted accounting principles for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1

Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2

Prices are determined using significant other observable inputs. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 Input must be observable for substantially the full term of the asset or liability.

Level 3

Prices are determined using significant unobservable inputs.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on June 30, 2024 and 2023.

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Note 5 Fixed Interest Investment Option

BOA Fixed Contract

As described in Note 2, since the BOA Fixed contract is not a fully benefit-responsive, contract value is the relevant measurement attribute for this investment contract. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Interest is credited to participant accounts at least monthly at rates determined from time to time by the custodian. Amounts may be transferred from the participant's account balance in the BOA Fixed contract at any time. Termination of the agreement or full Plan withdrawal from this account could restrict the liquidation of account balances. Management believes this is unlikely to occur.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The fixed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events limit the Plan's ability to transact at contract value with Nationwide. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

Note 6 Tax Status

The Plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. 403(b) plans currently are not required to submit plans to the Internal Revenue Service for determination. The Plan is required to operate in conformity with the Internal Revenue Code ("Code") to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provisions for income tax have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, Plan tax returns remain open for federal income tax examination for three years from the date of filing.

Note 7 Related Party Transactions

All Plan investments are registered investment companies or guaranteed interest accounts, managed by Nationwide Life Insurance Company (Nationwide) and the Variable Annuity Life Insurance Company (VALIC). Nationwide and VALIC are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. No expenses were paid by the participants of the Plan for the investment management services for the years ended June 30, 2024. All other investment related expenses are included in the net appreciation of fair value of investments. For the year ended June 30, 2024, Nationwide and companies providing services to Nationwide could not be determined. Nationwide provided services through June 30, 2024. Effective July 1, 2024, services were provided by nbs.

Note 8 Plan Termination

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

Note 9 Information Certified by nbs (national benefit services)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of June 30, 2024, and the supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of June 30, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the year ended June 30, 2024.
