INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Transystems Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Transystems Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Transystems Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Transystems Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the Transystems Retirement Plan (the Plan), provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective November 1, 1997. The Plan Sponsor is Transport Leasing Company LLP d/b/a Transystems Services (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined contribution plan covering substantially all employees of the Company except for employees covered by a collective bargaining agreement and non-resident alien employees.

Employees not otherwise excluded become eligible after completing one year of service (1,000 hours). Employees may enter the Plan on the first day of the calendar quarter subsequent to satisfying the eligibility requirements.

The Plan was restated effective January 1, 2021 pursuant to the cycle three restatement period and current CARES Act legislature.

Plan Administration

The administration of the Plan is the responsibility of the Plan Sponsor. All money that is contributed to the Plan is held in a trust for the benefit of the participants.

Contributions

Participant contributions are made on a pre-tax or Roth after-tax basis through payroll deduction. Participants may contribute up to 100% of defined earnings, as limited by §402(g) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from certain other tax-qualified retirement plans. Rollover contributions were \$5,017 and \$0 for the years ended December 31, 2024 and 2023, respectively. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan has an enhanced safe harbor matching contribution equal to 100% of elective deferrals that do not exceed 4% of compensation. The Company made safe harbor matching contributions of \$352,481 and \$304,160 for the years ended December 31, 2024 and 2023, respectively.

The Company may make discretionary contributions in the same proportion that each participant's compensation for the Plan year compares to the total compensation for the Plan year. A participant must be employed on the last day of the Plan year or if terminated, have completed 501 hours of service in order to receive a discretionary contribution. There were no discretionary contributions for the years ended December 31, 2024 and 2023.

Vesting

Participants are immediately vested in their deferral contributions and safe harbor matching plus actual earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on covered years of service. A participant has no vested interest until reaching two years of covered service, at which point that participant becomes 20% vested. Vesting is increased 20% for each year of covered service thereafter. A participant is 100% vested after six years of covered service. All participant balances are currently 100% vested.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions into any of a variety of funds made available through the Plan. The Plan Sponsor may change the investment options offered at any time, as deemed appropriate. Participants have access to their account information through the Internet and may make allocation changes at any time, subject to the Securities & Exchange Commission restrictions on excess trading.

The fund offerings are intended to provide participants with a variety of investment options over the usual range of asset classes with varying risk categories from conservative to aggressive. The prospectuses of the various funds offer detailed information on the characteristics, operations, management and expenses of the investments offered.

Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount. A participant may only elect to receive partial withdrawals or installments with respect to required minimum distributions, over a period of not more than the participant's assumed life expectancy.

The Plan also allows hardship distributions from deferral and rollover accounts. In addition, the Plan allows in-service distributions for participants who have attained the age of 65 from all deferral, employer safe harbor matching, employer discretionary contributions and rollover accounts.

Forfeited Accounts

Forfeitures are retained in the Plan and are to be used to reduce employer contributions or pay Plan expenses. Forfeitures available to be used were \$102 and \$101 for the years ended December 31, 2024 or 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment, Valuation and Income Recognition

The Plan's investments are reported at fair value and contract value. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's pooled separate account investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements are prepared on a contract value basis for fully benefit-responsive investment contracts.

Contributions

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from eligible compensation.

Benefit Payments

Benefits are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment management fees are paid by the Plan. Certain other investment related administrative fees are paid by the Plan and are included in net appreciation (depreciation) of fair value of investments. Participants may be charged distribution fees upon withdrawal of their accounts.

3. CERTIFIED INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. All investment information disclosed in the accompanying financial statements and schedule including the investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, gain on sales of assets, investment expenses and administrative fees for the years then ended were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Transamerica Life Insurance Company, a qualified institution.

Accordingly, as permitted under such election, the following information was not subjected to any auditing procedures performed by the independent public accountants, except for comparing such information certified by the qualified institution to information included in the Plan's financial statements and supplemental schedule:

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the “Fair Value Measurements” under FASB ASC 820 are described as follows.

Level 1 - observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets that the Plan has the ability to access.

Level 2 - observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

4. FAIR VALUE MEASUREMENTS (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled separate accounts: The unregistered pooled separate accounts are divided into investments called sub-accounts. Each sub-account invests in shares of an underlying mutual fund. Sub-account values are measured in terms of accumulation units. The accumulation units of a sub-account are assigned a unit value on a daily basis. The unit value is assigned at the close of each day the New York Stock Exchange (NYSE) is open for trading (this is called a "valuation day"). To determine the current accumulation unit value for a sub-account, the prior valuation day's accumulation unit value is multiplied by the net investment factor. The net investment factor is used to measure the investment performance of a sub-account from one valuation day to the next. The net investment factor for each sub-account equals the net asset value (NAV) per share of the underlying fund held in the sub-account at the end of the current valuation day, divided by the NAV per share of the underlying fund held in the sub-account at the end of each prior valuation day, minus any daily mortality and expense risk and administration charges, if applicable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan maintains a fully benefit-responsive investment contract with Transamerica Life Insurance Company. The Group Contract holder is the owner of the Group Annuity Contract, and has all rights, remedies and recourses given in the Group Annuity Contract. The Group Annuity Contract is treated as a trust for the purposes of §401(a), §401(f) and §457(g) of the Internal Revenue Code, and no portion of the amount contributed to the Group Annuity Contract, including earnings thereon, may be used for or diverted to any purpose other than the exclusive benefit of Plan participants and their beneficiaries prior to the satisfaction of all liabilities with respect to payees. The Group Annuity Contract and the participant annuity accounts are held in respect of the Plan, and there is no contractual relationship between either Company and the participants.

The account is credited with all contributions made by or on behalf of participants, all interest credited to the fixed account on an annual effective basis pursuant to the guaranteed interest rate applicable, any amounts transferred or distributed from the account and applicable charges and fees. The contract is included in the financial statements at contract value as reported to the Plan by Transamerica Life Insurance Company. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$127,940 and \$96,488, respectively, which approximates fair value. This approximation results in no adjustment to contract value in arriving at net assets available for benefits. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 0%. The crediting interest rate as of December 31, 2024 and 2023 was 1.65% and 1.25%, respectively.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) premature termination of the contract, (b) if the Plan fails to comply with any provisions contained in the contract, (c) if the Plan fails to qualify for or becomes disqualified under §401(a), (d) if the company closes, or (e) if the Plan terminates. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. The guaranteed investment contract permits either the insurance company or the Plan to terminate the agreement prior to the scheduled maturity date with at least 60 days written notice.

6. TAX STATUS

The Plan is operating under a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan that obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Since then, the Plan has been amended, however, the Plan administrator and the Plan trustees believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt.

6. TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed the tax positions taken or expected to be taken by the Plan, and has concluded that as of December 31, 2024, there are no such tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts and the assets will be distributed to participants in proportion to their respective account balances.

8. PARTY-IN-INTEREST TRANSACTIONS

Investment fees incurred by the Plan are netted with investment earnings. The Plan may assess fees against an individual participant's account for certain Plan expenses that are incurred by, or attributable to, a particular participant based on the use of a Plan feature. Fees charged by Transamerica Life Insurance Company to participant accounts for the years ended December 31, 2024 and 2023 were \$7,026 and \$5,419, respectively. The Plan paid third party administrator fees to Big Sky Retirement of \$7,530 and \$6,582 for the years ended December 31, 2024 and 2023, respectively. The Plan paid investment advisory fees to Edward Jones of \$18,526 and \$15,951 for the years ended December 31, 2024 and 2023, respectively.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 11, 2025, the date on which the financial statements were available to be issued. Management determined there were no subsequent events that required reporting in the financial statements.


