We have performed audits of the financial statements of the MeTEOR Education, LLC 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## **Note 1. Description of the Plan**

### ***General***

The following description of the MeTEOR Education, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by MeTEOR Education, LLC (Company) for the benefit of its employees. Employees who have completed one month of service and are age 21 or older are eligible for employee deferrals. Participants are eligible to receive matching contributions upon attainment of age 21 and 12 months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan and serves as Plan custodian.

### ***Contributions***

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 95% of compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions of 100% of employees' salary deferral amounts on the first 5% of employees' eligible compensation. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Each participant has the option of directing his or her contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant makes an affirmative election otherwise.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions, plus earnings thereon. For the Company's contribution portion of their accounts, plus earnings thereon, participants who terminated on or after January 1, 2022 are 100% vested. Participants who terminated prior to January 1, 2022 are subject to a six-year vesting schedule, with 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80% vested after five years of service and 100% vested after six years of service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at prevailing interest rates for loans made under similar circumstances. Principal and interest are paid ratably through monthly payroll deductions.

### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the vested interest in his or her account.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,710 and \$5,185, respectively. These accounts will be used to pay administrative expenses of the Plan or reduce future employer contributions. During the years ended December 31, 2024 and 2023, the Plan used \$7,629 and \$0, respectively, of forfeited nonvested accounts to reduce employer contributions to the Plan.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The money market fund is valued at cost, which approximates fair value. The Plan's interest in the collective trusts are valued at the NAV of units of the collective trusts. The NAV is used as a practical expedient to estimate fair value of the collective trust investments.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by Fidelity Investments, which is related to Fidelity, the trustee and custodian of the Plan for the years ended December 31, 2024 and 2023. Therefore, these transactions qualify as party-in-interest transactions.

For the years ended December 31, 2024 and 2023, the Plan paid \$26,026 and \$21,263 of record-keeping fees, net, to Fidelity and \$34,928 and \$27,777 of investment management fees to its investment advisor, respectively.

**Note 5. Plan Amendments**

Effective October 9, 2023, the Plan was amended to make certain changes to the compensation exclusions within the definition of compensation.

The Plan was amended on December 1, 2023 such that, effective January 1, 2024, the Plan includes an automatic enrollment feature where eligible participants are enrolled at a pre-tax deferral election of 1%. Additionally, participants will have an annual increase of 1% at the beginning of each plan year up to 5%.

Effective June 9, 2024, the participating employers addendum was amended to add a participating employer. Further, the Plan was amended to allow for service with the participating employer to be credited as service with the Plan sponsor for purposes of eligibility for the Plan.

The Plan was amended on October 2, 2024 such that, effective January 1, 2023, the Plan superseding provisions addendum was amended for certain compensation used in the calculation of employer matching contributions.

The Plan was amended October 1, 2024 such that, effective January 1, 2025, eligibility exclusion of a certain class of employees was removed.

**Note 6. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Plan Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a preapproved retirement plan and trust document sponsored by Fidelity Management & Research Company. This preapproved plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 1. Description of the Plan**

### ***General***

The following description of the MeTEOR Education, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by MeTEOR Education, LLC (Company) for the benefit of its employees. Employees who have completed one month of service and are age 21 or older are eligible for employee deferrals. Participants are eligible to receive matching contributions upon attainment of age 21 and 12 months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan and serves as Plan custodian.

### ***Contributions***

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 95% of compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions of 100% of employees' salary deferral amounts on the first 5% of employees' eligible compensation. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Each participant has the option of directing his or her contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant makes an affirmative election otherwise.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions, plus earnings thereon. For the Company's contribution portion of their accounts, plus earnings thereon, participants who terminated on or after January 1, 2022 are 100% vested. Participants who terminated prior to January 1, 2022 are subject to a six-year vesting schedule, with 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80% vested after five years of service and 100% vested after six years of service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at prevailing interest rates for loans made under similar circumstances. Principal and interest are paid ratably through monthly payroll deductions.

### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the vested interest in his or her account.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,710 and \$5,185, respectively. These accounts will be used to pay administrative expenses of the Plan or reduce future employer contributions. During the years ended December 31, 2024 and 2023, the Plan used \$7,629 and \$0, respectively, of forfeited nonvested accounts to reduce employer contributions to the Plan.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The money market fund is valued at cost, which approximates fair value. The Plan's interest in the collective trusts are valued at the NAV of units of the collective trusts. The NAV is used as a practical expedient to estimate fair value of the collective trust investments.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by Fidelity Investments, which is related to Fidelity, the trustee and custodian of the Plan for the years ended December 31, 2024 and 2023. Therefore, these transactions qualify as party-in-interest transactions.

For the years ended December 31, 2024 and 2023, the Plan paid \$26,026 and \$21,263 of record-keeping fees, net, to Fidelity and \$34,928 and \$27,777 of investment management fees to its investment advisor, respectively.

**Note 5. Plan Amendments**

Effective October 9, 2023, the Plan was amended to make certain changes to the compensation exclusions within the definition of compensation.

The Plan was amended on December 1, 2023 such that, effective January 1, 2024, the Plan includes an automatic enrollment feature where eligible participants are enrolled at a pre-tax deferral election of 1%. Additionally, participants will have an annual increase of 1% at the beginning of each plan year up to 5%.

Effective June 9, 2024, the participating employers addendum was amended to add a participating employer. Further, the Plan was amended to allow for service with the participating employer to be credited as service with the Plan sponsor for purposes of eligibility for the Plan.

The Plan was amended on October 2, 2024 such that, effective January 1, 2023, the Plan superseding provisions addendum was amended for certain compensation used in the calculation of employer matching contributions.

The Plan was amended October 1, 2024 such that, effective January 1, 2025, eligibility exclusion of a certain class of employees was removed.

**Note 6. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Plan Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a preapproved retirement plan and trust document sponsored by Fidelity Management & Research Company. This preapproved plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
