We have performed audits of the accompanying financial statements of HBC Employees Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended October 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances., has elected to have the audits of HBC Employees Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2024 and 2023, and for the year ended October 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Note 1: Plan Description:

The following description of the HBC Employees Trust (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all non-union employees of Horizon Beverage Company, Inc. (the "Company") who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan became effective on November 30, 1955 and the plan year is November 1 through October 31.

Custodians - The Plan established a trust and a group annuity contract with Empower Retirement and a group annuity contract with Massachusetts Mutual Life Insurance Company (collectively, "the Custodians"), which consists of such sums of money and other property acceptable to the Custodians that, from time to time, will be paid or delivered to the Custodians, including investments and proceeds thereof and earnings thereon, less the payments made by the Custodians, as authorized. The Custodians have agreed to invest and reinvest the funds as directed by the plan administrator in accordance with the trust agreement. Empower Retirement was appointed as the servicing agent, providing recordkeeping and administrative services to the Plan for assets kept under both the trust and group annuity contracts.

Participant Contributions - Eligible employees may elect to defer eligible compensation on a pre-tax basis or after tax basis ("Roth") or a combination of both. Deferral amounts may not to exceed applicable Internal Revenue Service regulatory limitations. Participants may also rollover contribution amounts representing distributions from other qualified plans.

Employer Contributions - The Company may make discretionary profit sharing and non-discretionary safe harbor contributions the plan. The Company made total contributions of \$1,409,365 to the Plan for the year ended October 31, 2024. The contributions were based on a percentage of current compensation subject to certain limitations. These contributions were reflected as receivables as of the balance sheet date.

Participant Accounts - Each participant's account is credited with the participant's elective contributions and allocations of employer contributions, if any, as well as Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions and employer safe harbor contributions and actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

### Note 1: Description of Plan - Continued:

Forfeitures - Participants who terminate their employment prior to becoming fully vested in their share of employer contributions forfeit the unvested employer contributions. Such forfeited amounts are considered unallocated and may be applied to reduce future employer contributions or administrative fees.

Unallocated Funds - As of October 31, 2024 and 2023, the Plan had unallocated assets totaling \$64,675 and \$43,047, respectively.

Investment Options - The Plan offers participants a choice of investing in twenty-seven different mutual funds, a guaranteed and a variable investment contract with specific investment objectives. Participants may change investment option specifications daily with respect to contributions to be made in the future and with respect to his or her individual account.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half their vested account balance or \$50,000. Principal and interest are paid ratably through regular payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits - On termination of service, a participant may elect to receive a lump-sum distribution equal to the vested value of his or her account. The Plan also allows for hardship withdrawals not to exceed the value of the participant's vested account.

Administrative Expenses - Plan administration expenses are paid directly by the Company to the extent not paid by the Plan, whereas participant account administrative expenses are paid by the participants and deducted from their accounts annually.

Plan Administration - The Company is the plan administrator. One of the Plan's trustees is a shareholder of the Company.

### Note 2: Summary of Significant Accounting Policies:

Basis of Accounting - The financial statements and supplemental schedule of the Plan are prepared using the accrual method of accounting, consistent with accounting principles generally accepted in the United States of America.

Payment of Benefits - The Plan records benefit payments when paid.

### Note 2: Summary of Significant Accounting Policies - Continued:

Investment Valuation and Income Recognition - Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of its investments which consists of the realized gains or losses during the year and the unrealized appreciation or depreciation of investments at year-end.

Notes Receivables from Participants - Notes receivable from participants are valued at their outstanding amortized balances, which approximates fair value. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant's individual account. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Use of Estimates - The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Subsequent Events - Subsequent events are events or transactions that occur after the balance sheet date but that could affect the amounts or disclosures in the financial statements. Management has evaluated subsequent events through the date that the financial statements are available to be issued, which is the date noted at the bottom of the auditor's report.

### Note 3: Guaranteed Investment Contract:

The Plan holds a traditional, guaranteed investment contract wherein the contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The interest rate is set by the issuer on a semi-annual basis and may not be less than zero percent. The contract has no set maturity or termination date.

This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

### Note 3: Guaranteed Investment Contract - Continued:

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
- There is a termination or partial termination of the Plan
- The Plan breaches a provision of the investment contract
- Bankruptcy of the plan sponsor or other plan sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- The issuer determines it will not be able to operate the Agreement under its current terms following the Plan's establishment, activation or material change to, any Plan investment fund.
- The Plan fails to make required contributions to the investment option.

Contract values of the guaranteed investment contract as of October 31, 2024 and 2023 were \$9,829,348 and \$11,242,894, respectively.

### Note 4: Related Party Transactions:

Certain Plan investments held are shares of mutual funds managed by Mass Mutual. Mass Mutual is a custodian as defined by the Plan and therefore these transactions qualify as party-in-interest transactions.

### Note 5: Plan Termination:

Although it has not expressed any intent to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 6: Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 7: Certification of Custodians:**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Custodians, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule. The plan administrator has obtained certification from the Custodians stating that all information provided to the plan administrator by the Custodians for 2024 and 2023 is complete and accurate. Such information includes investments, investment income, realized gains and losses on sales of investments and unrealized appreciation or depreciation in market value of investments.

### Note 8: Tax Status:

The Plan is a Prototype Non-Standardized Profit Sharing 401(k) Plan. The Angell Pension Group Inc. has obtained an Internal Revenue Service determination letter dated June 30, 2020 stating that the Plan, as designed, complies with the requirements under Section 401(a) of the Internal Revenue Code (the "Code"). The Plan has been amended since the date of this determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. No provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates all significant tax positions and believes that it has not taken any tax positions that require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would increase or decrease within the next year. The Plan's income tax returns are subject to examination by applicable tax authorities generally for three years after filing.

### Note 9: Fair Value Measurements:

The Plan follows generally accepted accounting principles, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term thereof.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Note 9: Fair Value Measurements - Continued:**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used as of October 31, 2024 and 2023:

Mutual Funds and Pooled Separate Accounts: Valued at the readily available net asset value ("NAV") of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.
