We have performed audits of the financial statements of the WE Employees' 401(k) Cash or Deferred Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). **NOTES TO FINANCIAL STATEMENTS**  
**DECEMBER 31, 2024 AND 2023**

**NOTE 1 – DESCRIPTION OF PLAN**

The following is a brief description of the WE Employees' 401(k) Cash or Deferred Retirement Plan (the Plan). It is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution 401(k) plan covering substantially all U.S. employees of Waggener Edstrom Worldwide, Inc. and its subsidiaries (the Company). Employees may enter the Plan on the first day of the month following 30 days of service, with no minimum age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Contributions consist of employee elective deferral contributions, employer matching contributions and additional discretionary employer contributions. Contributions from Plan participants and matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Employer matching and discretionary contributions are determined annually by the Company's Board of Directors. Participants may contribute up to 85% of total eligible compensation for the plan year, limited to \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and over may make additional catch-up contributions. Contributions are subject to certain limitations. For the years ended December 31, 2024 and 2023, the Company made employer matching contributions of 50% of employee deferrals up to 6% of compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

**Participant Accounts** - A separate account is maintained for each participant, which is credited with the participant's contributions, the employer's matching contributions, employer's discretionary contributions and an allocation of Plan earnings and forfeited balances of terminated participants. Allocation of Plan earnings and expenses is based upon participant account balances. Allocation of matching contributions and employer's discretionary contributions is based on a percentage of each employee's elective deferral and eligible participants' compensation, respectively. The benefit to which a participant is entitled is the vested amount in their individual account.

**Vesting** - Participants are fully vested at all times in that portion of their accounts attributable to their own contributions. Participants are 100% vested after three years of service in the employer portion of their accounts.

**Payment of Benefits** - On termination of service, attainment of age 59 ½, retirement, permanent disability or death, a participant may elect a distribution as a lump-sum amount equal to the vested value of his or her account. If a participant's vested account exceeds \$1,000 and is not more than \$7,000 upon termination of employment, the plan administrator may automatically rollover the entire vested interest to an individual retirement account (IRA), unless otherwise directed by the participant. If a participant's vested account is \$1,000 or less upon termination of employment, the entire vested interest may be distributed in a lump sum payment to the participant, unless otherwise directed.

**Expenses** - Administrative expenses may be paid by the Company, paid from the forfeiture account, or paid by the participants on a pro-rata basis. Loan administration expenses are charged to the borrower's account. Certain expenses of plan administration, including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel, are provided by the plan sponsor without charge to the Plan.

**Forfeitures** - Forfeitures may be used to reduce employer matching contributions. Forfeited, non-vested accounts amounted to \$97,128 and \$165,878 at December 31, 2024 and 2023, respectively. In 2024 and 2023, \$305,000 and \$120,000, respectively, of forfeited accounts were used to reduce employer matching contributions.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investment in mutual funds.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Subsequent events** - The Plan's management has performed an evaluation of subsequent events through July 31, 2025, which is the date these financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

#### **Basis of Fair Value Measurement**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the Trustee of the Plan.

**NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan makes loans to participants based on their vested account balances. Loans must be repaid within five years unless the proceeds are used to purchase the participant's primary residence. Loans are payable through payroll deductions. Interest is charged at the rates set by the plan administrator and ranges from 3.25% to 10.50% at December 31, 2024. Loans are secured by the vested account balance of the participant.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested.

Upon termination, the Company may continue the Plan to pay benefits as they mature or liquidate and distribute the relevant portion of the Plan to a successor defined contribution plan, or in the absence of a successor plan, to the participants. Net assets transferred or distributed shall be allocated to participants in proportion to their interests.

## **NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments include shares of mutual funds managed by Vanguard Fiduciary Trust Company, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees for investment management services for investments managed by the trustee ranged from 0.05% to 0.18%. Fees are netted against Plan earnings.

## **NOTE 8 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There are four investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023. See the supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of December 31, 2024.

## **NOTE 9 – INCOME TAX STATUS**

The Plan document is a volume submitter 401(k) profit sharing plan sponsored by the Vanguard Group. The volume submitter 401(k) profit sharing plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
