Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



(1) **Description of Plan:**

The following description of the P & S Paving, Inc. 401(K) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

(a) **General**—The Plan is a multiple-employer defined contribution plan covering all eligible employees of P & S Paving, Inc. and Phillips Ranch, LLC (collectively referred to as the Company). Employees become eligible to defer income after completing two months of service and attaining 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) **Contributions**—Each year, participants may contribute from one percent to 100 percent of eligible pre-tax annual compensation, as defined by the Plan. Additional “catch-up” contributions can be made to the Plan if the participant is at least age 50 by the end of the plan year up to the amount allowed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company contributes 100 percent of the first four percent of employee deferrals up to four percent of compensation. The Company may also make non-elective contributions. The Company did not make any non-elective contributions during 2024. Participants direct the investment of their contributions, as well as Company contributions to their participant account, into various investment options offered by the Plan. Contributions are subject to certain limitations allowed by law.

(c) **Participant accounts**—Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The Company currently offers 49 pooled separate accounts as investment options for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) **Vesting**—Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company's Safe Harbor matching contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

(e) **Payment of benefits**—Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The participant's contributions and earnings thereon may also be withdrawn for certain hardship situations.

(f) **Administrative plan expenses and participant fees**—The Plan permits payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. However, certain operating expenses of the Plan, such as audit fees, are paid by the Plan Sponsor. Plan administration and investment management fees reduce participants' account balances. Expenses relating to specific participant transactions (such as distribution request, etc.) are charged directly against the appropriate participant's account.

(1) **Description of Plan:** (Continued)

The Plan has entered into a revenue sharing program with the custodian whereby the Plan receives a credit paid to a “Plan Expense Reduction Account” that acts as a forfeiture and asset holding account. Qualified plan expenses may be paid from the Plan Expense Reduction Account. In 2024 and 2023, the Plan received a rebate of \$4,084 and \$4,066, respectively, which was used to offset administrative fees paid by the Plan. At December 31, 2024 and 2023, there was no balance remaining in the Plan Expense Reduction Account, which is included in the Plan’s net assets.

(g) **Forfeited accounts**—At December 31, 2024 and 2023, there were no amounts remaining in the forfeited non-vested accounts. Forfeitures may be used to reduce future employer contributions or pay plan expenses. During 2024, there were no forfeitures used to reduce employer contributions or plan expenses.

(2) **Summary of Significant Accounting Policies:**

(a) **Basis of presentation**—The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) **Investment valuation and income recognition**—The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for a discussion of fair value measurements. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

(c) **Contributions**—Contributions from Plan participants and the matching contribution from the Company are recorded in the year in which the employee contributions are withheld from compensation.

(d) **Payment of benefits**—Benefits are recorded when paid.

(e) **Use of estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

(f) **Subsequent events**—The Plan has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through July 30, 2025, the date the financial statements were available to be issued. There have been no subsequent events requiring recognition or disclosure.

(3) **Summary of Information Certified by Plan Custodian:**

All investment information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance as custodian to the Plan.

(4) Investments and Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted market prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the custodian is based on the fair value of the underlying mutual funds held by the fund less its liabilities.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and 2023, there were no purchases, issues or transfers between in or out of Level 3.

(5) Other Liabilities:

As of December 31, 2024, the Plan had received \$24,793 in contribution payments from the Plan Sponsor relating to compensation payable after year-end. These amounts consisted of \$15,826 in employee deferrals and \$8,967 in employer contributions. Because the associated payroll had not yet been processed as of the financial statement date, the advance remittances are presented as other liabilities in the accompanying statement of net assets.

(6) Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to permanently discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(7) Tax Status:

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by tax authorities, and may change upon examination.

(8) **Parties-in-Interest:**

John Hancock Financial served as custodian and recordkeeper, and therefore qualifies as a party-in-interest to the Plan. Executive Compensation Group provided investment advisory services, and therefore qualifies as a party-in-interest to the Plan. Benchmark Retirement Plan Services, Inc. served as third-party administrator, and therefore qualifies as a party-in-interest to the Plan.

(9) **Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
