

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hamill Manufacturing Company 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 PLAN DESCRIPTION

The following description of Hamill Manufacturing Company 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Hamill Manufacturing Company and Numis Corporation (collectively the "Company"). Employees who have attained eighteen (18) years of age and have completed ninety (90) days of service are eligible to participate in the plan. The Plan has an automatic enrollment feature for employees who meet the eligibility requirements. Under the terms of the automatic enrollment feature, participants are enrolled automatically at pre-tax deferral percentage of 4% per year. Unless otherwise directed, the deferral percentage is set to increase by 1% per year until the participant reaches a deferral percentage of 11%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants are permitted to make elective deferrals up to the maximum percentage of compensation and dollar amounts permissible under the Internal Revenue Service Code, not to exceed certain limits. Participants may also designate all or a portion of their elective deferrals as after-tax Roth elective deferrals. In addition, the Company will make a safe harbor matching contribution equal to one hundred percent (100%) of the participant's elective deferral, not to exceed four percent (4%) of the participant's compensation. At the direction of the Board of Directors, the Company may also make a discretionary contribution to the plan. There were no discretionary contributions made to the plan during the year ended December 31, 2024. Contributions to the Plan are recorded in the period that payroll deductions are made from participants. Company contributions are accrued based upon the period those contributions relate to.

Participants who have attained age fifty (50) by the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Participants may direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers a managed income/stable value common collective trust fund and registered investment companies as investment options.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution and related Company matching contribution, (b) an allocation of the Company's discretionary contribution, if any, and (c) investment earnings and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants may direct the investment of all contributions into various options offered by the Plan. The Plan currently offers pooled separate accounts as well as an investment contract with an insurance company sponsored by Empower Retirement.

Vesting

Participants are always fully vested in their voluntary contributions, Company matching contributions, rollover contributions, and any earnings thereon. Vesting in the remainder of their account is earned in accordance with the following six (6) year graded schedule:

Forfeited Accounts

Forfeited amounts are used to reduce employer matching contributions or pay administrative expenses. Forfeiture balances amounted to \$-0- for both years ended December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used to increase employer matching contributions.

Payment of Benefits

Upon retirement, disability, death or termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum distribution or an annuity. Participants with account balances of less than \$5,000 upon termination will automatically receive a lump-sum distribution. Upon reaching age fifty-nine and a half (59 ½), participants may elect to receive in-service withdrawals. The Plan also maintains a provision for hardship withdrawals.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. Up to fifty percent (50%) of a participant's vested account balance may be used as collateral and all loans bear interest at a reasonable rate which is commensurate with local prevailing interest rates as determined by the Plan Administrator. The interest rate shall remain fixed throughout the duration of the loan. Loans generally must be repaid within five (5) years. An individual may only have two (2) loans outstanding at any given time. Principal and interest is paid ratably through payroll deductions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of fair value measurements.

Net appreciation/depreciation includes the Plan's losses and gains on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

Level 1 – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities;

Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Value based on the closing price of the security as quoted by the principal exchange on which the security is traded, which represents fair value.

Registered investment companies: Valued at the net asset value ("NAV") of shares held by the plan at year end, which is based on quoted market prices in active markets.

Common collective trust fund: Valued at the NAV of units of a collective investment trust. The NAV, as provided by the Fund's trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the year ended December 31, 2024, there were no transfers in or out of Levels 1, 2, or 3. The following table sets forth by level, within the fair value hierarchy, a summary of the Plan's investments measured at fair value on a recurring basis as follows:

(a) **Stable Value Fund:** This class includes the Managed Income Portfolio Class 1 Fund. The fund is a collective investment trust for which the net asset value (“NAV) is based on the market value of its underlying investments. The fund seeks to maintain a stable net asset value (NAV) of \$1 per share, but it cannot guarantee that it will be able to do so. According to Fidelity, there were no unfunded commitments on the Fidelity stable value commingled pools as of December 31, 2024 and 2023. Participant level transactions (like a withdrawal) take place daily – typically the liquidation would be requested on one day and processed the next business day. Plan level liquidations (like a deconversion to another record-keeper) – require notice to Fidelity and could result in the plan’s investment in MIP being placed into an investment only account for up to twelve (12) months. The fund files a Form 5500 as a Direct Filing Entity with the Department of Labor.

NOTE 4 CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023
- Investment income as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

At the request of the Plan administrator, the Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent (100%) vested in their accounts.

NOTE 6 TAX STATUS

The Plan adopted the Fidelity Volume Submitter 401(k) Profit Sharing Plan. The volume submitter plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The volume submitter plan has been amended since receiving the determination letter. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities held by the Plan, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid to Fidelity Management Trust Company amounted to \$17,763 during the plan year ended December 31, 2024.

In addition, Private Advisor Group, LLC/Assured Partners Capital Inc. and Strategic Advisors, Inc. provide investment advisory services for the Plan which amounted to \$24,634 and \$7,596, respectively, for the year ended December 31, 2024. Fees paid to Private Advisor Group, LLC. are based on 15 basis points of assets under management and are paid quarterly.

NOTE 9 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
