Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Data-Mail 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Note 1 - Description of the Plan

The following description of the Data-Mail 401(k) Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement, and amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective October 1, 1990, and most recently amended on December 7, 2023. Employees of Data-Mail, Inc., Compu-Data Limited Liability Company, Data Graphics, Inc., Direct Mail Systems, Inc., Legends Sourcing, LLC and Graphic Packaging Group, LLC (collectively referred to as the "Company") are eligible to participate and receive matching contributions on the first day of the month following the completion of three months of service and attaining the age of 21. The Plan is subject to the provisions of ERISA. The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan sponsor.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan agreement, up to the maximum allowable under the Internal Revenue Code (the "IRC"). The Plan allows participants to make Roth 401(k) contributions into the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum allowable under the IRC. Participants may also contribute pretax amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan accepts rollovers of designated Roth contributions from participants.

The Company makes annual discretionary matching contributions, as determined by the Company. Effective January 1, 2024, the Company contributed an amount equal to 55% of elective deferrals up to a maximum of 6% of a participant's eligible compensation for the year ended December 31, 2024. In order to receive the discretionary matching contributions, participants need to be employed as of the end of the Plan year, except if they die, become disabled or retire within the Plan year. The Company made \$814,770 (\$790,858 in employer contributions and \$23,912 used from forfeitures) in discretionary matching contributions for the year ended December 31, 2024. Participant contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings. Company discretionary matching contributions are recorded annually. Participants direct the investment of their contributions and discretionary matching contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of service, as defined in the Plan agreement. A participant becomes 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80%

vested after five years of service and 100% vested after six years of service. However, if an active participant dies prior to the normal retirement age or becomes totally and permanently disabled prior to the normal retirement age, the participant's account becomes 100% vested.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is commensurate with market rates for similar loans with approval by the Plan administrator. Principal and interest are paid ratably through weekly automatic payroll deductions.

Payment of benefits

On termination of employment, retirement, the attainment of age 59½, death or permanent and total disability, a participant with a vested account balance less than \$1,000 may choose to receive a lump-sum amount equal to the value of the vested portion of his or her account. A terminated participant with a vested account balance of \$1,000 and less than \$7,000 will have his or her funds directly rolled over by the Plan administrator into an individual retirement account designated by the Plan administrator if no other election is made. Participants with a vested balance of more than \$7,000 may defer payment of benefits until a later date. Participants may also take hardship distributions from employee deferral amounts. Distributions are subject to the applicable provisions of the Plan agreement.

Forfeited accounts

Forfeitures result from nonvested discretionary matching contributions remaining in the Plan from terminated employees. Any amounts forfeited by reason of failure to vest are available to reduce future employer contributions or to pay future Plan administrative expenses. At December 31, 2024 and 2023, the forfeiture reserve balance was \$23,912 and \$26,274, respectively. Forfeited nonvested amounts totaling \$26,274 were used to reduce the annual discretionary match contribution made during 2024.

Note 2 - Summary of accounting policies

Basis of accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the discretionary matching contributions from the Company are recorded in the year in which participants compensation is earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through August 6, 2025 the date the financial statements were available to be issued. See Note 9 - Subsequent event.

Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("FMTTC"), the trustee of the Plan.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5 - Related party transactions and party-in-interest transactions

FMTC is the trustee as defined by the Plan and is considered a party-in-interest. FMTC provides certain administrative services to the Plan and receives revenue from mutual funds and the common/collective trust fund for services provided to these funds. This revenue is used to offset certain amounts owed to FMTC for its administrative services to the Plan.

If the revenue received by FMTC from such mutual funds or common/collective trust fund exceeds the amount owed, FMTC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan sponsor may make a payment to FMTC for administrative expenses not covered by revenue sharing.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the discretionary matching contribution portion of their accounts.

Note 7 - Tax status

The pre-approved plan document designed by Fidelity Management and Research Company, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not yet filed for an individual determination letter. Although the Plan has been amended since receiving the opinion letter, management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Subsequent event

Effective January 1, 2025, the Company's annual discretionary matching contribution was increased to 60% of elective deferrals, up to a maximum of 6% of a participant's eligible compensation.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Data-Mail 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of the Plan

The following description of the Data-Mail 401(k) Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement, and amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective October 1, 1990, and most recently amended on December 7, 2023. Employees of Data-Mail, Inc., Compu-Data Limited Liability Company, Data Graphics, Inc., Direct Mail Systems, Inc., Legends Sourcing, LLC and Graphic Packaging Group, LLC (collectively referred to as the "Company") are eligible to participate and receive matching contributions on the first day of the month following the completion of three months of service and attaining the age of 21. The Plan is subject to the provisions of ERISA. The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan sponsor.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan agreement, up to the maximum allowable under the Internal Revenue Code (the "IRC"). The Plan allows participants to make Roth 401(k) contributions into the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum allowable under the IRC. Participants may also contribute pretax amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan accepts rollovers of designated Roth contributions from participants.

The Company makes annual discretionary matching contributions, as determined by the Company. Effective January 1, 2024, the Company contributed an amount equal to 55% of elective deferrals up to a maximum of 6% of a participant's eligible compensation for the year ended December 31, 2024. In order to receive the discretionary matching contributions, participants need to be employed as of the end of the Plan year, except if they die, become disabled or retire within the Plan year. The Company made \$814,770 (\$790,858 in employer contributions and \$23,912 used from forfeitures) in discretionary matching contributions for the year ended December 31, 2024. Participant contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings. Company discretionary matching contributions are recorded annually. Participants direct the investment of their contributions and discretionary matching contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of service, as defined in the Plan agreement. A participant becomes 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80%

vested after five years of service and 100% vested after six years of service. However, if an active participant dies prior to the normal retirement age or becomes totally and permanently disabled prior to the normal retirement age, the participant's account becomes 100% vested.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is commensurate with market rates for similar loans with approval by the Plan administrator. Principal and interest are paid ratably through weekly automatic payroll deductions.

Payment of benefits

On termination of employment, retirement, the attainment of age 59½, death or permanent and total disability, a participant with a vested account balance less than \$1,000 may choose to receive a lump-sum amount equal to the value of the vested portion of his or her account. A terminated participant with a vested account balance of \$1,000 and less than \$7,000 will have his or her funds directly rolled over by the Plan administrator into an individual retirement account designated by the Plan administrator if no other election is made. Participants with a vested balance of more than \$7,000 may defer payment of benefits until a later date. Participants may also take hardship distributions from employee deferral amounts. Distributions are subject to the applicable provisions of the Plan agreement.

Forfeited accounts

Forfeitures result from nonvested discretionary matching contributions remaining in the Plan from terminated employees. Any amounts forfeited by reason of failure to vest are available to reduce future employer contributions or to pay future Plan administrative expenses. At December 31, 2024 and 2023, the forfeiture reserve balance was \$23,912 and \$26,274, respectively. Forfeited nonvested amounts totaling \$26,274 were used to reduce the annual discretionary match contribution made during 2024.

Note 2 - Summary of accounting policies

Basis of accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the discretionary matching contributions from the Company are recorded in the year in which participants compensation is earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through August 6, 2025 the date the financial statements were available to be issued. See Note 9 - Subsequent event.

Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("FMTTC"), the trustee of the Plan.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5 - Related party transactions and party-in-interest transactions

FMTC is the trustee as defined by the Plan and is considered a party-in-interest. FMTC provides certain administrative services to the Plan and receives revenue from mutual funds and the common/collective trust fund for services provided to these funds. This revenue is used to offset certain amounts owed to FMTC for its administrative services to the Plan.

If the revenue received by FMTC from such mutual funds or common/collective trust fund exceeds the amount owed, FMTC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan sponsor may make a payment to FMTC for administrative expenses not covered by revenue sharing.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the discretionary matching contribution portion of their accounts.

Note 7 - Tax status

The pre-approved plan document designed by Fidelity Management and Research Company, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not yet filed for an individual determination letter. Although the Plan has been amended since receiving the opinion letter, management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Subsequent event

Effective January 1, 2025, the Company's annual discretionary matching contribution was increased to 60% of elective deferrals, up to a maximum of 6% of a participant's eligible compensation.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Data-Mail 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Note 1 - Description of the Plan

The following description of the Data-Mail 401(k) Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement, and amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective October 1, 1990, and most recently amended on December 7, 2023. Employees of Data-Mail, Inc., Compu-Data Limited Liability Company, Data Graphics, Inc., Direct Mail Systems, Inc., Legends Sourcing, LLC and Graphic Packaging Group, LLC (collectively referred to as the "Company") are eligible to participate and receive matching contributions on the first day of the month following the completion of three months of service and attaining the age of 21. The Plan is subject to the provisions of ERISA. The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan sponsor.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan agreement, up to the maximum allowable under the Internal Revenue Code (the "IRC"). The Plan allows participants to make Roth 401(k) contributions into the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum allowable under the IRC. Participants may also contribute pretax amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan accepts rollovers of designated Roth contributions from participants.

The Company makes annual discretionary matching contributions, as determined by the Company. Effective January 1, 2024, the Company contributed an amount equal to 55% of elective deferrals up to a maximum of 6% of a participant's eligible compensation for the year ended December 31, 2024. In order to receive the discretionary matching contributions, participants need to be employed as of the end of the Plan year, except if they die, become disabled or retire within the Plan year. The Company made \$814,770 (\$790,858 in employer contributions and \$23,912 used from forfeitures) in discretionary matching contributions for the year ended December 31, 2024. Participant contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings. Company discretionary matching contributions are recorded annually. Participants direct the investment of their contributions and discretionary matching contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of service, as defined in the Plan agreement. A participant becomes 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80%

vested after five years of service and 100% vested after six years of service. However, if an active participant dies prior to the normal retirement age or becomes totally and permanently disabled prior to the normal retirement age, the participant's account becomes 100% vested.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is commensurate with market rates for similar loans with approval by the Plan administrator. Principal and interest are paid ratably through weekly automatic payroll deductions.

Payment of benefits

On termination of employment, retirement, the attainment of age 59½, death or permanent and total disability, a participant with a vested account balance less than \$1,000 may choose to receive a lump-sum amount equal to the value of the vested portion of his or her account. A terminated participant with a vested account balance of \$1,000 and less than \$7,000 will have his or her funds directly rolled over by the Plan administrator into an individual retirement account designated by the Plan administrator if no other election is made. Participants with a vested balance of more than \$7,000 may defer payment of benefits until a later date. Participants may also take hardship distributions from employee deferral amounts. Distributions are subject to the applicable provisions of the Plan agreement.

Forfeited accounts

Forfeitures result from nonvested discretionary matching contributions remaining in the Plan from terminated employees. Any amounts forfeited by reason of failure to vest are available to reduce future employer contributions or to pay future Plan administrative expenses. At December 31, 2024 and 2023, the forfeiture reserve balance was \$23,912 and \$26,274, respectively. Forfeited nonvested amounts totaling \$26,274 were used to reduce the annual discretionary match contribution made during 2024.

Note 2 - Summary of accounting policies

Basis of accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the discretionary matching contributions from the Company are recorded in the year in which participants compensation is earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through August 6, 2025 the date the financial statements were available to be issued. See Note 9 - Subsequent event.

Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("FMTC"), the trustee of the Plan.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5 - Related party transactions and party-in-interest transactions

FMTC is the trustee as defined by the Plan and is considered a party-in-interest. FMTC provides certain administrative services to the Plan and receives revenue from mutual funds and the common/collective trust fund for services provided to these funds. This revenue is used to offset certain amounts owed to FMTC for its administrative services to the Plan.

If the revenue received by FMTC from such mutual funds or common/collective trust fund exceeds the amount owed, FMTC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan sponsor may make a payment to FMTC for administrative expenses not covered by revenue sharing.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the discretionary matching contribution portion of their accounts.

Note 7 - Tax status

The pre-approved plan document designed by Fidelity Management and Research Company, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not yet filed for an individual determination letter. Although the Plan has been amended since receiving the opinion letter, management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Subsequent event

Effective January 1, 2025, the Company's annual discretionary matching contribution was increased to 60% of elective deferrals, up to a maximum of 6% of a participant's eligible compensation.
