NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

(1) DESCRIPTION OF PLAN:

The following description of the Kenneth Young Center (the Organization) 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The financial statements were available to be issued on August 11, 2025, with subsequent events being evaluated through this date.

General -

The Plan is a defined contribution plan covering all full-time employees of the Organization who are not:

- Non-resident aliens;
- Part of a Collective Bargaining Agreement;
- Part-time employees (less than 20 hours)

An employee becomes eligible to participate with elective deferrals into the Plan the first of the month following one full month of employment. There is no minimum age requirement. Employees that work more than 1,000 hours per year become eligible for matching and discretionary contributions beginning one year after their hire date.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions -

A participant may elect to contribute a portion of his or her pretax or after-tax compensation for the Plan year, as defined in the Plan, not to exceed the Internal Revenue Code (the Code) section 415(d) limit as adjusted in any Plan year. All participants who were eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the Plan year were eligible for catch-up contributions of up to \$7,500 during 2024. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. The Organization made a discretionary contribution of 2% of the participant's compensation for those employees who have completed one year of continuous service.

The assets of the Plan as of December 31, 2024 and 2023, are held by Reliance Trust Company, Voya Retirement Insurance and Annuity Company, Ascensus, LLC, and Symetra Life Insurance Company, the trustees of the Plan. Upon enrollment in the Plan, a participant may direct their contributions into a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

(1) DESCRIPTION OF PLAN: (Continued)

Participant Accounts -

Each participant's account is credited with the participant's elective contribution and allocations of the Organization's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting -

Participants are immediately fully vested in their salary deferral contributions plus actual earnings thereon, and in all other accounts, if the participant dies, becomes disabled, or retires while an employee of the Organization. Participants are also immediately fully vested in their discretionary matching and profit-sharing contribution portion of accounts upon meeting the eligibility requirements of the Plan.

Payment of Benefits -

Upon termination of service, a participant may elect to receive 1) a lump sum amount, equal to the value of the participant's vested interest in his or her account, or 2) partial withdrawals or installments, but only with respect to lifetime minimum required distributions, over a period of not more than their assumed life expectancy. If the participant's vested account balance does not exceed \$5,000, payment is made in a lump sum distribution. Except for hardship, and withdrawals are not permitted prior to a participant's death, disability, retirement, or termination of employment.

Plan Expenses -

Certain expenses of maintaining the Plan are paid for by the Organization.

(2) SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting -

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition -

Investments are reported at fair value. Shares of registered investment companies are valued based on the quoted market prices of the shares held by the Plan at year end. Gain or loss recognized from the disposition of an investment held at the beginning of the year is equal to the difference between the market value of the disposed asset at the beginning of the year and the proceeds from disposition. Gain or loss realized from the disposition of an investment acquired during the year is equal to the difference between the cost and the proceeds from disposition. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan's investment committee determines the Plan's valuation policies, utilizing information provided by the Investment Advisor and Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(2) SUMMARY OF ACCOUNTING POLICIES: (Continued)

Estimates -

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits -

Benefits are recorded when paid.

Administrative Expenses -

Administrative expenses of the Plan are charged against earnings except to the extent the expenses are paid by the Organization. Administrative expenses of \$68,208 were paid by the Plan during the year ended December 31, 2024.

(3) PLAN TERMINATION:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(4) FAIR VALUE MEASUREMENTS:

The Accounting Standards of Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

(4) FAIR VALUE MEASUREMENTS: (Continued)

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Shares in registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Investments in shares of pooled separate accounts held with an insurance company are stated at estimated fair market value and are valued by the insurance company based on the net asset value of shares held by the Plan at year end. The net asset value is determined by the insurance company based on the market value of the underlying investments held in the pooled fund.

Insurance Company General Accounts: The guaranteed investment contracts are non-fully benefit-responsive. The fair value of the accounts is determined by adding to the contributions made, the earnings on the underlying investments, and deducting participant withdrawals and administrative expenses.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) INCOME TAXES:

The Organization has adopted a prototype plan from Reliance Trust Company. Currently, the IRS has no procedures for processing determination letter applications for 403(b) prototype plan documents. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for fiscal years prior to 2021.

(6) CERTIFIED INVESTMENTS:

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained, or derived from, information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, Voya Retirement Insurance and Annuity Company, Ascensus, LLC, and Symetra Life Insurance Company, the trustees of the Plan.

(7) RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities/mutual funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) PARTY-IN-INTEREST TRANSACTIONS:

Plan assets include investments in funds managed by Reliance Trust Company, Voya Retirement Insurance and Annuity Company, Ascensus, LLC, and Symetra Life Insurance Company, totaling \$2,383,772 and \$2,402,252 for the years ended December 31, 2024 and 2023, respectively. As custodians of the Plan, these transactions are considered to be party-in-interest transactions. Personnel and facilities of the Plan Sponsor have been used to perform administrative functions for the Plan at no charge to the Plan.
