NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the 403(b) Thrift Plan of Adams & Brown Counties Economic Opportunities, Inc. (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the employer, Adams & Brown Counties Economic Opportunities, Inc. (the “Organization”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

An employee is immediately eligible to defer a portion of their compensation into the Plan. However, an employee must complete six months of service with the employer before they are eligible to receive contributions made by the employer. Temporary hires, Job Training Partnership Act adults, and summer youth participants and contractual workers are specifically excluded.

Contributions

Employees may elect to contribute, through the 403(b) feature, a percentage of their base salary or a fixed dollar amount each period, not to exceed the maximum amount permitted by the Internal Revenue Code. Employees may elect to have their contributions invested in various investment options administered by the Plan’s trustee. The employer matches the employee’s contribution in an amount equal to the lesser of 100 percent of the salary deferral amount the employee contributed during the Plan year or 4 percent of the employee’s compensation received during the Plan year. Contributions are subject to certain limitations.

Participant Accounts

In accordance with the terms of the Plan, the account of each participant is maintained on a fair value basis. Each participant’s account consists of the contributions made on their behalf by Adams & Brown Counties Economic Opportunities, Inc., their employee elective deferral contributions, their employee rollover contributions, forfeitures of terminated participants’ non-vested accounts, and their share of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants in the Plan are immediately vested in their elective contribution accounts and qualified non-elective contribution accounts. They are entitled to their entire account balance if their participation ceases for any reason whatsoever.

If a participant’s employment is terminated for reason of death, normal retirement, or retirement due to disability, the participant shall be entitled to the full account. If employment is terminated for any reason other than death, retirement, or disability, the participant shall be entitled to the vested portion of the employer-matching contribution account in accordance with the following schedule: 2 years – 20 percent; 3 years – 40 percent; 4 years – 60 percent; 5 years – 80 percent; and 6 years – 100 percent.

Forfeitures

Forfeiture of non-vested account balances will be used to offset the current-year employer contributions or used to pay Plan administrative expense payments. At December 31, 2024 and 2023, the forfeitures on non-vested accounts had a balance of \$0 and \$10,966, respectively. Forfeitures in the amount of \$18,906 were used to offset employer contributions during the year ended December 31, 2024.

Payments of Benefits

Benefits are recorded when paid.

Distributions may be made upon attainment of age 59 ½. No separation of service is necessary. Any amounts withdrawn due to hardship must be distributed in a single sum. Any other withdrawal may be paid in a single sum or in any other method of payment permitted by the contract or custodial account from which the withdrawal is made.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting and reporting policies applied in the presentation of the accompanying financial statements follows:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting Estimates

The financial statements have been prepared in conformity with U.S. generally accepted accounting principles. In preparing the financial statements, management is required to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ significantly from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The net appreciation in fair value of investments includes investments purchased, sold, and held during the year.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

NOTE 3 – INVESTMENTS

The Plan investments were administered by Charles Schwab Trust Bank, VOYA Retirement and Insurance and Annuity Company, and Mutual of America Life Insurance Company (“Custodians”). The following is a summary of the investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information provided by the Custodians and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Custodians that information provided to the Plan Administrator by the Custodians related to the following investments is complete and accurate. Accordingly, as permitted by CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and supplemental schedule, related to investments:

Charles Schwab Trust Bank certified to the accuracy of \$323,673 of net appreciation in fair value of investments and interest and dividend income of \$207,648 for the year ended December 31, 2024. Voya Retirement Insurance and Annuity Company certified to the accuracy of interest and dividend income of \$1,596 for the year ended December 31, 2024.

The Plan entered into a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements as reported by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As previously described, the guaranteed investment contract is considered not fully benefit responsive since the group annuity contract may have the potential to restrict certain transfers and withdrawals. There are no reserves for credit risk of the contract issuer or otherwise.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 5 – TAX STATUS

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document. However, the Plan Administrator believes the Plan is designed, and is being operated, in conformity with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Management of the Plan is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Participant loans held by the Plan reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Adams & Brown Counties Economic Opportunities, Inc. absorbs all costs incurred in relation to the administration of the Plan. Such costs include legal and accounting fees. These costs amounted to \$15,107 for the year ended December 31, 2024.

NOTE 7 – FAIR VALUE OF FINANCIAL INSTRUMENTS

The Plan discloses fair value of its financial instruments. Financial instruments are defined as cash, evidence of ownership in an entity, or a contract that creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. If quoted market price is available for a financial instrument, the estimated fair value would be calculated based upon the market price per trading unit of the instrument. Investments and notes receivable from participants would be considered financial instruments. At December 31, 2024, the carrying amount of these financial instruments approximates fair value.

NOTE 8 – FAIR VALUE MEASUREMENTS

The Plan utilizes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and lowest priority to unobservable inputs. The three levels of the fair value hierarchy under ASC 820 are described below:

- *Level I:* Inputs to the valuation methodology are unadjusted quoted prices for assets or liabilities in active markets that the Plan has the ability to access.

- *Level II:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.
- *Level III:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts and Collective Investments Trust: Primarily valued at net asset value (NAV) of the underlying investments.

Mutual Funds: Valued at closing price reported on the active market on which the individual securities are traded.

Money Market Fund: Valued at closing price reported on the active market on which the individual securities are traded.

Guaranteed Investment Contract: The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract as calculated by the annuity provider.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 10 – SUBSEQUENT EVENTS

Management has reviewed events occurring through July 31, 2025, the date that the financial statements were issued, and no subsequent events have occurred requiring disclosure.
