We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A -- Description of plan and significant accounting policies

The following description of RenewAire, LLC Retirement Savings Plan & Trust 2 provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. RenewAire, LLC (the Company) has adopted, with subsequent amendments, the Alerus Financial, N.A. (Alerus) Defined Contribution Pre-Approved Plan, under the name RenewAire, LLC Retirement Savings Plan & Trust 2 (the Plan) with the most recent restatement effective January 1, 2023. The Plan was originally effective May 2, 2010.

General

The Plan is a defined contribution plan with elective deferral 401(k) features covering all eligible employees of the Company who have 1 hour of service within the 3-month time period following the employee's employment commencement date, or one year of service (1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's 401(k) Investment Committee oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

The Plan's federal identification number is 27-2192399, and the Plan's number is 001.

Contributions

Each year, participants may contribute up to 75% of pretax and after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

For 2024, the Company's contribution was a safe harbor matching contribution of 100% of the participant's deferral amount up to 6% of the participant's eligible compensation. The Company also has the right to make additional contributions to be allocated to participants pro rata based on compensation. An employee must work at least 1,000 hours in the plan year and be employed on the last day of the plan year to receive an allocation of discretionary profit-sharing contributions. No additional discretionary contributions were made in 2024.

Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Contributions receivable and due from brokers

Contributions receivable and due from brokers are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the Company.

NOTE A -- Description of plan and significant accounting policies (Continued)

Participant accounts and “rollovers”

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching and discretionary contributions, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of Company contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan permits the rollover of funds from other qualified plans to a participant’s account.

Vesting

Participants are immediately vested in their contributions and the Company’s matching contributions plus actual earnings thereon. Vesting in the Company’s discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested ratably over five years of credited service. Participants, who leave the Plan because of death or disability, as defined in the Plan, are considered 100% vested in all amounts.

Participant loans

Participants may not borrow from their fund accounts.

Benefits

On termination of service due to death, disability, retirement (age 65) or termination of employment, a participant may elect either a lump-sum distribution of the entire vested account balance or in a single sum distribution of a portion of the participant’s vested interest in his or her account. In-service distributions are allowed provided the participant has attained age 59 ½. A participant with an account valued at less than \$1,000 shall receive a lump-sum distribution. An automatic rollover of a participant’s account will occur if the account is valued between \$1,000 and \$5,000. For accounts exceeding \$5,000 the participant may elect a lump sum distribution or may elect to defer such distribution to any valuation date subsequent to his/her termination but no later than the valuation date of his/her normal retirement date; or the participant may elect to rollover the distribution to another qualified plan.

Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts were \$0. These accounts will be used to reduce future company contributions or to pay administrative expenses. No amounts were used during 2024 from forfeited non-vested accounts.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Cash

The Plan maintains its cash in bank deposit accounts, which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. Management believes it is not exposed to any significant credit risk on cash.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid. At December 31, 2024 and 2023, amounts for distributions to participants who have requested a distribution from the Plan prior to the Plan year end but were not yet paid at the Plan year end were \$87,464 and \$0, respectively.

Administrative expenses

The Company pays some of the administrative expenses of the Plan, which are excluded from these financial statements. The major administrative expenses are recordkeeping and investment management fees.

Subsequent events

These financial statements have not been updated for subsequent events occurring after August 11, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

NOTE B -- Information certified by the asset custodian

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments and cash held at December 31, 2024 and 2023, and dividends, other income and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus, the asset custodian of the Plan.

NOTE C -- Party-in-interest transactions

Certain Plan investments are managed by Alerus. Alerus is the recordkeeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Alerus provides administrative services to the Plan pursuant to an agreement between the Company and Alerus. Alerus receives revenue from mutual fund service providers for services Alerus provides to the funds. This revenue is used to offset certain amounts owed to Alerus for its administrative services to the Plan.

If the revenue received by Alerus from such mutual fund service providers exceeds the amount owed, Alerus remits the excess to the Plan's trust on a monthly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were \$6,950 of excess amounts which is included in other income on the Statement of Changes in Net Assets Available for Benefits. The Plan or Plan Sponsor may make a payment to Alerus for administrative expenses not covered by revenue sharing.

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the years presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Stable value collective fund: A stable value fund composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

Investments Measured Using the Net Asset Value per Share Practical Expedient

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

NOTE E -- Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their allocated discretionary Company contributions.

NOTE F -- Tax status

The Alerus Defined Contribution Pre-Approved Plan that the Plan has adopted effective January 1, 2023, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE G -- Concentration of market risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
