Report of Independent Auditors

To the Administrator of The Southern Devall Group 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of The Southern Devall Group 401k Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

1. Description of the Plan

The following description provides general information on the provisions of The Southern Devall Group 401(k) Plan (the “Plan”), sponsored by Southern Towing Company, LLC (the “Company”). Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) prototype plan. Eligible employees (as defined) of the Company who have completed 90 days of entry service and attain age twenty-one (21) are able to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Employees who had not yet reached the age of 21, but were eligible under previously merged plans, remain eligible under the Plan.

Contributions

The Plan provides for an automatic 3% pre-tax elective payroll deferral for each participant, unless the participant has elected a different percentage or chosen not to participate. Participating employees may elect to make, through payroll deductions, elective deferral contributions up to 100% of eligible compensation (not to exceed the annual contribution limit, as set by the Internal Revenue Service, (“IRS”)).

The Company matches 100% of each participant’s first 5% of elective deferral contributions. The Company may also make discretionary Plan contributions. For the year ended December 31, 2024, there were no discretionary contributions.

Vesting

A participant is immediately vested in elective deferral contributions, Company matching contributions, discretionary contributions, rollover contributions and past employee contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company matching contributions, an allocation of Plan earnings and losses and any discretionary Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Investment Options

The Plan allows participants to direct their contributions and account balances among investments options offered by Principal Trust Company (“Principal”), the trustee of the Plan, and Principal Life Insurance Company, which includes certain mutual funds, pooled separate accounts, common/collective trust funds, and a fixed income guaranteed option.

Forfeitures

Forfeited nonvested accounts are first used to pay Plan expenses. Any remaining forfeitures are used to offset Company contributions. The remaining unused forfeiture balance was \$0 as of December 31, 2024 and 2023.

Notes Receivable from Participants

Participants are allowed to borrow from their vested account balance a minimum of \$1,000, up to a maximum equal to the lesser of 50% of their total vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Participants are only allowed to have one loan outstanding at a time. The notes are repaid through payroll deductions and must be repaid over five years, or fifteen years if the note is used for the purchase of a primary residence. Interest rates on outstanding notes ranged from 4.25% to 10.50% at December 31, 2024 and 2023.

Payment of Benefits

On termination of service, a participant may receive the value of the participant's vested interest in his or her account as a lump sum distribution. Withdrawals by a participant while still employed are limited to those requested due to events of financial hardship as defined in the Plan document or upon attainment of age 59 ½. Under Federal law, regular 401(k) benefit payments must begin on the April 1st following the later of the calendar year in which the participant reaches age 73 or is not a 5% owner and stops working for the Company.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Transfers from affiliated plans

From time to time, the Plan may have transfers to/from other affiliate plans. In October of 2024, the Company approved the transfer of the excess assets remaining following the full termination of the Southern Towing Company Pension Plan to the Plan thereby resulting in a receivable due from the affiliate pension plan as of December 31, 2024. Such excess assets totaling \$1,544,030 were transferred into the Plan on April 24, 2025.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be fully vested in their accounts and the trustee will distribute Plan assets to participants or their beneficiaries in accordance with the Plan document.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

Net Appreciation (Depreciation) in Fair Value of Investments

Net realized and unrealized appreciation (depreciation), which includes gains and losses on investments bought and sold, as well as held during the year, is recorded in the statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are reclassified as distributions.

Payment of Benefits

Benefits are recorded when paid.

Evaluation of Subsequent Events

Plan management has evaluated subsequent events that have occurred subsequent to December 31, 2024, through August 12, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in these financial statements.

3. Investments

The Plan provides for investments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

4. Fair Value

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, are described as follows:

Level 1 – Quoted market prices in active markets for identical assets or liabilities.

Level 2 – Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets and liabilities.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan’s investments are valued at fair value using the following methodology:

- **Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Pooled Separate Accounts:** Valued at NAV of units of the separate account. NAV is used as a practical expedient to estimate fair value. NAV is based upon the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.
- **Common/Collective Trust Funds:** Valued at NAV of units held by the Plan. NAV is used as a practical expedient to estimate fair value. NAV is based upon the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with Principal Life Insurance and Annuity Company. Principal Life Insurance and Annuity Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting interest rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life Insurance and Annuity Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

6. Income Tax Status

The IRS has determined and informed Principal Life Insurance and Annuity Company by a letter dated June 30, 2020, that the Principal Prototype Plan is designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan itself has not received a letter of determination but is entitled to rely on the letter issued to Principal Life Insurance and Annuity Company for the Principal Prototype Plan. Although the Plan has been amended since the date of the letter, the Company believes that the Plan continues to be designed and operated in compliance with the applicable sections of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. There are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Information Certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal has certified that the following data included in the financial statements, notes to the financial statements and ERISA-required supplemental schedule is complete and accurate:

8. Party-in-Interest Transactions

Certain Plan investments include interest in certain pooled separate accounts, common/collective trust funds, and a fully benefit-responsive investment contract managed by Principal or its affiliates. Principal is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid directly by the Plan for administrative expenses totaled \$32,777 for the year ended December 31, 2024. These transactions are party-in-interest transactions. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan document provides for notes receivable from participants which are managed by Principal and qualify as party-in-interest transactions.
