## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Grossenburg Implement, Inc. Retirement Savings Plan  
Winner, South Dakota

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Grossenburg Implement, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2024 and 2023 and for the year ended October 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

### **NOTES TO FINANCIAL STATEMENTS OCTOBER 31, 2024 AND 2023**

#### **(1) Summary of Significant Accounting Policies**

##### **Nature of Business of Plan Sponsor**

Grossenburg Implement, Inc. and Rosebud Concrete, Inc. (collectively, the Companies or Plan Sponsor) are engaged in the sales of farming equipment and provide construction services. The Companies sponsor the Grossenburg Implement, Inc. Retirement Savings Plan (the Plan), a defined contribution plan for the employees of the Companies.

##### **Basis of Accounting**

The financial statements of Grossenburg Implement, Inc. Retirement Savings Plan are prepared using the accrual method of accounting.

##### **Risks and Uncertainties**

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Market volatility of equity-based investments may substantially impact the value of such investments at any given time. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. It is possible that the value of the Plan's investments, both in total and in individual participant accounts, has changed significantly since October 31, 2024.

##### **Investment Valuation and Income Recognition**

The Plan's investments, except as defined below, are stated at fair value on a recurring basis as determined by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the Trustee) (Notes 3 and 8). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as received.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fully benefit-responsive investment contracts are reported as Guaranteed Investment Contracts (GIC) within the notes to the financial statements.

##### **Net Change in Fair Value**

The net change in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year and the unrealized gains and losses in securities held at the end of the year.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts and disclosures reported in the financial statements. Actual results could differ from those estimates.

### **NOTES TO FINANCIAL STATEMENTS OCTOBER 31, 2024 AND 2023**

#### **(1) Summary of Significant Accounting Policies**

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. The Companies have, at their discretion, absorbed certain other administrative expenses pertaining to the Plan. If not paid by the Companies, these administrative expenses become the responsibility of the Plan.

##### **Subsequent Events**

The Plan Sponsor has evaluated significant subsequent events through August 7, 2025, the date which financial statements were available for issue.

#### **(2) Description of the Plan**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution 401(k) profit-sharing plan covering all employees, other than those covered by a collective bargaining agreement, non-resident aliens, and leased employees of the Companies. Employees at Grossenburg Implement, Inc. and Rosebud Concrete, Inc. are eligible to participate in the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Eligibility**

Employees of the Companies who have completed six months of service and are 18 years of age or older are eligible to participate in the Plan. Excluded from participation are leased employees, independent contractors, and part-time, temporary, or seasonal employees regularly scheduled to work less than 1,000 hours in a plan year.

##### **Contributions**

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan, up to certain limits as established by the Internal Revenue Service. The Plan allows for discretionary profit-sharing and discretionary matching contributions by the Companies. During each of the years ended October 31, 2024 and 2023 the Companies made discretionary profit-sharing contributions. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at six percent of eligible compensation and their contributions invested in the respective target date fund until changed by the participant.

#### **(2) Description of the Plan**

##### **Contributions**

The Plan allows Roth elective deferrals. Contributions to Roth 401(k) accounts are made on an after-tax basis and contributions to a Roth 401(k) account are included in the participant's gross income. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participants' Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

##### **Payment of Benefits**

Upon termination of service, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or one of various annuities. Benefits less than \$1,000 are distributed as soon as administratively feasible after the participant's termination of employment. Vested benefits greater than \$1,000 but less than \$5,000 are rolled over into an individual retirement account.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Companies' profit-sharing contributions, and plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined.

##### **Investment Options**

Participants direct their account balance to selected investments as made available and determined by the plan sponsor. Participants may change their investment options and terminate contributions at any time throughout the year.

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participant's account attributable to the Companies' profit-sharing and matching contributions becomes 20 percent vested after two years of credited service, as defined, and continues to vest at the rate of 20 percent for each successive year of service until 100 percent vested after six years of credited service, or if less than six years, upon reaching normal retirement age, disability, death, or upon termination of the Plan.

##### **Forfeitures**

Non-vested account balances are forfeited unless participants return to employment and contribute the distribution received at termination within a specified time. The Plan allocates forfeitures to reduce future Company contributions and plan expenses. Forfeitures of \$31,194 and \$13,451 were used to pay administrative expenses during the years ended October 31, 2024 and 2023, respectively.

#### **(3) Information Certified by Trustee**

The Plan's investments are held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the Trustee) who performs all accounting functions associated with the Plan's investments. The fair value of investments at October 31, 2024 and 2023 is determined by the Trustee (Note 8).

The Plan is administered by the Companies. The Plan investments include collective investment trust, pooled separate accounts, and a guaranteed investment contract held and managed by the Trustee (Note 7).

#### **(3) Information Certified by Trustee**

In accordance with Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator has received certification from the Trustee as to the accuracy and completeness of certain financial information of the Plan as of and for the years ended October 31, 2024 and 2023. The Trustee has certified information contained in the following:

Statements of Net Assets Available for Benefits (except for receivables)  
Statement of Changes in Net Assets Available for Benefits (except for contributions, administrative expenses,  
and benefits paid to participants)  
Schedule of Assets Held at End of Year

The Plan invests in common collective trusts, pooled separate accounts and a guaranteed investment contract with underlying assets consisting of any combination of stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks.

#### **(4) Income Tax Status**

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### **(5) Plan Termination**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their entire account.

#### **(6) Participant Withdrawals**

Vested, undistributed account balances of separated Plan participants totaled approximately \$6,804,000 and \$6,732,000 at October 31, 2024 and 2023, respectively.

#### **(7) Guaranteed Investment Contract**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with the Trustee totaling \$2,093,518 and \$2,949,682 at October 31, 2024 and 2023, respectively. The Trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent or greater than 3 percent. The crediting rate was 1.55% and 1.75% as of October 31, 2024 and 2023, respectively. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **(7) Guaranteed Investment Contract**

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

#### **(8) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level One: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level Two: inputs include
  1. quoted prices for similar assets or liabilities in active markets;
  2. quoted prices for identical or similar assets or liabilities in inactive markets;
  3. inputs other than quoted prices that are observable for the asset or liability;
  4. inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level Three: inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023.

**(8) Fair Value Measurements**

*Pooled Separate Accounts:* Fair Value represents the value of the fund shares, which is calculated daily based on the valuation of the funds' underlying investments at fair value. The pooled separate accounts invest mainly in mutual funds, domestic stocks, international stocks, and fixed securities.
