Opinion

We have audited the accompanying financial statements of LGBT Benefit Plan Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 (in liquidation) and 2023 (ongoing), the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), and the related notes to the financial statements.

In our opinion, the financial statements referred to in the first paragraph present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 (in liquidation) and 2023 (ongoing), and the changes in its net assets available for benefits and benefit obligations for the years ended December 31, 2024 (in liquidation) and 2023 (ongoing), in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 8 to the financial statements, the sole trustee of the Plan, approved a plan of liquidation and terminated the Plan on December 31, 2024. As a result the Plan changed its basis of accounting from accrual basis used in presenting the December 31, 2023 financial statements to the liquidation basis of accounting used in presenting the December 31, 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America including the liquidation basis of accounting, and for the design, implementation, and maintenance of internal

control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The LGBT Benefit Plan Trust (the "Plan") formerly known as G & L Benefit Plan Trust, is a welfare benefit plan established effective March 1, 2013. The Plan provides hospital, medical, dental care, mental health, prescription drug and vision care benefits to active participants on whose behalf contributions to the Plan were sent in accordance with its subscription agreement. Dependents of eligible active participants are also eligible for certain specified benefits. No retired participants are covered under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting.

B. Estimates

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Contributions

Employer contributions are contributions made by the employer on behalf of eligible employees for months worked during the year. Contribution rates in effect during the year varied based upon amounts required to be contributed in accordance with the subscription agreement. The Plan allows for continuation of coverage for eligible active participants as required under the Consolidated Omnibus Budget Reconciliation Act of 1985 ("COBRA"). Rates for COBRA continuation of coverage premiums are set by the Board of Trustees. COBRA contributions, which vary according to the levels of participation elected are accounted for and reported in accordance with the rules of the Plan. COBRA contributions received in advance of the month worked or the month of coverage are reported as deferred COBRA contributions revenue.

D. Benefits

Benefits reported are premiums for eligible participants paid during the year (premiums paid). Benefit obligations consists of premiums payable, which is an estimate of premiums for coverage during the year, unpaid at the end of the year.

No retired participants are covered under the Plan; therefore, no postretirement benefit obligations are reported on the financial statements.

E. Other Income and Expenses

Other income and expenses are reported on the accrual basis, except for nominal amounts of recurring monthly expenses.

NOTE 4 - RECONCILIATION OF FINANCIAL STATEMENTS TO THE FORM 5500 (Continued)

Total benefits per the financial statements is the total of premiums paid during the year. Total benefits per the Form 5500 is the total of premiums for coverage during the year for participants, dependents, and beneficiaries.

NOTE 5 - TAX-EXEMPT STATUS

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - CONCENTRATION OF EMPLOYER CONTRIBUTIONS

One employer, subject to a subscription agreement, provides all employer contributions to the Plan. Employer contributions from the significant employer totaled \$10,000,452 and \$8,623,588, or 100% of total employer contributions for the years ended December 31, 2024 and 2023, respectively.

NOTE 7 - CONCENTRATION OF CREDIT RISK

During the year ended December 31, 2024, the Plan maintained a bank account with a cash balance in excess of the federally insured limits of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The uninsured balance at December 31, 2024 was \$340,452. The Plan has not incurred any losses on the uninsured balances.

NOTE 8 - PLAN TERMINATION

The Board of Trustees approved to terminate the Plan effective December 31, 2024. All participants in the Plan left the Plan effective December 31, 2024. As a result of the termination, the Plan has adopted the liquidation basis of accounting. All remaining assets of the Plan as of December 31, 2024 will be used to pay outstanding liabilities and after payment of such liabilities, the remaining assets was transferred to Kaiser on July 25, 2025 subject to the provisions of ERISA.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 5, 2025, the date on which the financial statements were available to be issued. The Plan will be liquidating its assets and the termination process was completed on July 25, 2025.

Other than the above, there were no material subsequent events that required recognition or additional disclosures in these financial statements.
