### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

### NOTE A - DESCRIPTION OF THE PLAN

In September 2023, the Company passed a resolution to terminate the Plan. On September 29, 2023, The Malvern Schools 401(k) Retirement Plan (the "Plan") adopted an amendment to terminate and liquidate the Plan. No participants were allowed to enter the Plan after the date of Plan termination. All participants were fully vested in their account balances, and the account balances were liquidated and distributed to participants as soon as administratively practicable after that time.

The Plan filed an application for termination with the IRS for approval. The IRS approval was received and the net assets have been distributed to participants. Participants chose amongst several options regarding the type of distribution. Participants were allowed to elect a lump sum payment, individual retirement account rollover, or direct transfer into another plan.

The following description of The Malvern Schools 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that commenced January 1, 2005. All full-time employees of The Malvern Schools (the "Company") who have attained the age of 20.5 and have completed 6 months of service are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Contributions to the Plan were no longer allowed following the passage of the resolution to terminate the Plan in September 2023.

#### **Participant Accounts**

A separate investment account was maintained for each Plan participant. Participants directed the investment of their accounts into various funds specified by the Plan. Participant accounts were credited with the participant's contribution. Participant accounts were also charged with an allocation of investment income (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants were immediately 100% vested in their salary deferrals including Roth 401(k) deferrals and “catch-up contributions”, employer matching contributions and rollover contributions.

Vesting in the Company’s matching and profit-sharing contributions was determined up until September 29, 2023 as follows:

Year 1	25%
Year 2	50%
Year 3	75%
Year 4	100%

Effective September 29, 2023, all participants became fully vested.

#### Payment of Benefits

Participants were eligible to receive a distribution of the vested portion of their individual account balance upon the following:

- The occurrence of any of the distributable events specified in the Adoption Agreement,
- The participant’s termination of employment after attaining normal retirement age and
- Termination of the Plan.

Normal retirement age under this Plan is 65.

#### Forfeitures

All benefits attributable to employee contributions are nonforfeitable at all times. The forfeited nonvested account balance at May 22, 2024 and December 31, 2023, was \$0 and \$159, respectively. During 2024, \$159 of forfeitures were used to offset administrative expenses.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The 2024 and 2023 financial statements have been prepared under the liquidation basis. This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update (“ASU”) 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent upon adoption of the resolution to terminate the Plan on October 31, 2023. Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting, including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation**

The Plan’s investments were stated at fair value at December 31, 2023. Quoted market prices are used to value investments. Due to termination of the Plan, all participant account balances were properly liquidated and distributed. There were no remaining investment balances in the Plan at May 22, 2024.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Administrative expenses, excluding transaction fees, are paid by the Company.

#### Plan Loans

During 2023, Plan participants were eligible to borrow against the Plan by pledging a percentage of their vested account balance as collateral. A loan was not to be less than \$1,000 nor exceed \$50,000 reduced by the excess of the participant's highest outstanding participant loan balance during the 12-month period ending on the date of the loan over the participant's current outstanding loan balance on the date of the loan.

#### Date of Management's Review

Management has evaluated subsequent events through February 12, 2025, the date which the financial statements were available to be issued.

### NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification 820-10 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

*Level 1* inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. *Level 2* inputs are other than quoted prices that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. *Level 3* inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

### NOTE D - RELIANCE ON CUSTODIANS' REPORTS

The administrator of the Plan chose the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by Reliance Trust Company, the custodian of the Plan during 2024 and 2023, other than comparing such information to that contained in the financial statements and supplemental schedule. ### NOTE E - TAX STATUS

The Plan participates in a prototype plan sponsored by ADP. The prototype plan has received a favorable opinion letter from the Internal Revenue Service dated October 6, 2020. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. The plan has been amended since letter, but the Plan Administrator believes the plan is still in compliance with IRS requirements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE F - PARTY IN INTEREST TRANSACTIONS

Participant loans qualify as party in interest transactions. All these transactions are exempt from the prohibited transactions rules.

### **NOTE G - RISKS AND UNCERTAINTIES**

Investments of the Plan were exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect investment assets reported in participant account balances and in the statements of net assets available for benefits.

### **NOTE H - PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Due to the sale of the Company, the Company resolved to terminate the Plan effective September 29, 2023. Participants became 100% vested in their accounts as of the termination date. The account balances were liquidated and distributed to participants as soon as administratively practicable after that time. All account balances were liquidated and distributed to participants on May 22, 2024.
