**NOTE 1 DESCRIPTION OF PLAN**

The following description of Stacy and Witbeck, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that was established in 2003 by Stacy and Witbeck, Inc. (the Company) to provide retirement benefits to eligible employees. The Plan has been amended and restated throughout the years to comply with tax legislation. The Plan was last amended and restated effective December 1, 2021. Employees of the Company are eligible to participate in the deferral component of the Plan on their date of employment. Employees of the Company are eligible to participate in the Company contributions component of the Plan on December 1 and June 1 following the completion of a year of service (1,000 hours). The Plan excludes employees covered by a collective bargaining agreement, interns, trainees, runners, independent contractors and hourly-paid employees who is a craft foreman, craftsman or craft workers. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company has appointed the Retirement Savings Plan Committee (the Committee) to manage the operation and administration of the Plan.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage or dollar amount, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth after-tax contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans.

The Company makes a safe harbor nonelective contribution equal to 3% of each eligible participant's eligible compensation, as defined by the Plan. In addition, the Company is allowed to make discretionary matching and profit sharing contributions as defined in the Plan and as approved by the Board of Directors. The Company made a discretionary profit sharing contribution of 7% to each eligible participant based on eligible compensation for the years ended November 30, 2024 and 2023. No discretionary matching contribution was made for the years ended November 30, 2024 and 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, plan earnings or losses and an allocation of the Company's contributions. Allocation of the Company's contributions are based on participant contributions or eligible employee compensation, as defined in the Plan.

**Vesting**

Participants are immediately vested in their contributions and Company safe harbor nonelective contributions. Participants are fully vested in the Company's matching and profit sharing contributions allocated to their account after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching retirement age or upon termination of employment due to death or disability.

**Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the participant's vested balance. Such loans bear interest at the prime rate plus 1% and must be repaid to the Plan within a five-year period. The specific terms and conditions of such loans are established by the Committee.

**Benefit Payments**

Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan, or receive their total benefits in a lump sum or annuity equal to the value of the participant's vested interest in their account. The Plan allows for in-service distributions if a participant reaches age 60 and hardship distributions subject to Plan provisions. The Plan allows for the automatic distribution of participant vested account balances that do not exceed \$5,000.

**Forfeited Accounts**

Forfeited nonvested discretionary matching accounts are used to first reduce Plan administrative expenses and then can be used to reduce future Company contributions. Forfeited nonvested Company discretionary profit sharing accounts are used to pay for plan administrative expenses or may be allocated to remaining eligible participants as soon as administratively feasible as of the last day of the plan year of the forfeitures. At November 30, 2024 and 2023, forfeited nonvested accounts totaled \$86,117 and \$62,179, respectively. No forfeitures were used to offset Company contributions for the years ended November 30, 2024 and 2023. No forfeitures were used to reduce plan expenses for the years ended November 30, 2024 and 2023. Total forfeitures allocated to eligible participants accounts for the years ended November 30, 2024 and 2023 were \$94,006 and \$65,548, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 30, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Substantially all expenses incurred for administering the Plan are paid by the Company.

**Subsequent Events**

The Plan has evaluated subsequent events through July 22, 2025, the date the financial statements were available to be issued.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at November 30, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Funds:* Valued daily at the net asset value (NAV) of units of the bank collective trust. The per unit share is determined and published daily and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 RELATED PARTY TRANSACTIONS**

The Company provides to the Plan certain accounting and administrative services for which no fees are charged and absorbs certain plan expenses.

Certain Plan investments are managed by Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, the trustee of the Plan. In addition, the Plan pays fees to Principal Financial Group for administration of the Plan. These transactions qualify as party-in-interest transactions.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on a determination letter dated September 15, 2017, received from the Internal Revenue Service (IRS) indicating the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.


