Notes to Financial Statements

1. Description of Plan

The following description of the Care Hospice, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Care Hospice, Inc. (the Plan Sponsor and its affiliated employers (collectively, the "Employer" or "Employers")) who have attained age 21 and, effective January 1, 2024, completed one month of service (changed from six months of service). Employees may begin participation on the first day of the month subsequent to or coinciding with meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Eligible employees may elect to contribute up to 89% of their before and/or after-tax ("Roth") compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service ("IRS"). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). The Employers make matching contributions of 100% of the first 3%, plus 50% of the next 2% of each participant's compensation contributed to the Plan. The Employers may also make a discretionary non-elective or profit-sharing contribution authorized annually by the Plan Sponsor's Board of Directors. No discretionary contributions were made during 2024.

Upon enrollment in the Plan, a participant may direct contributions between the investment options offered by the Plan. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant's account is credited with the participant's and the Employers' contributions and an allocation of the Plan's net earnings and administrative expenses. Allocations are based on participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus any earnings thereon. Vesting in the Employers' matching and discretionary contributions are based on continuous service. Participants are fully vested after six years of service or 20% each year after the second year of service is completed, with the exception of certain money sources transferred into the Plan from merged plans as defined in the plan agreement.

Notes Receivable from Participants

Participant loans are generally not allowed under the Plan agreement. However, the balances included in the accompanying financial statements relate to participant loans transferred into the Plan from other plans as part of the plan mergers, which is permitted by the Plan. The participant notes receivable were secured by the balance and bore interest at a fixed rate of 5.25% at December 31, 2023, which was commensurate with local prevailing rates as determined by the time of borrowing by the plan administrator. Principal and interest were collected ratably through payroll deductions. All remaining notes receivable from participants were paid off during 2024.

1. Description of Plan (Concluded)

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant or beneficiary may elect to receive lump-sum or installment payments. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified by the Plan.

Forfeitures

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$68,000 and \$75,000. These accounts will be used to reduce future employer contributions or offset administrative expenses. During 2024, employer matching contributions were reduced by approximately \$749,000 from forfeited non-vested accounts.

Administrative Expenses

Certain administrative fees are paid by the Plan. Withdrawal fees are paid from affected participant accounts. Other administrative expenses, including internal administrative costs, are absorbed by the Employers.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses was recorded as of December 31, 2023. Delinquent notes receivable were reclassified as distributions based upon the terms of the plan document. No notes receivable from participants were outstanding as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through August 5, 2025, the date the financial statements were available to be issued, and has determined that no other events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by ADP, LLC ("ADP"). The IRS has determined and informed ADP by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

7. Party-in-Interest Transactions

Fees paid by the Plan to ADP for administrative services were approximately \$54,000 in 2024. ADP is the recordkeeper of the Plan and, as such, these transactions qualify as party-in-interest.

8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurements

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

8. Fair Value Measurements (Concluded)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Common collective trust funds: Valued at NAV as determined by the issuer based on the fair market value of the underlying investments, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
