Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of American Aerogel Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to all employees of American Aerogel Corporation (the Company) meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable. The Company's management is responsible for oversight of the Plan.

Administration

The Company is the sponsor of the Plan and serves as the administrator of the Plan. Reliance Trust Company (Reliance) serves as the trustee and custodian of the Plan, and ADP Retirement Services (ADP) serves as the record-keeper of the Plan.

Eligibility

Employees of the Company who have attained the age of 18 are immediately eligible for employee contributions, discretionary employer matching contributions, and discretionary employer profit-sharing contributions.

Contributions

The Plan allows participants to contribute an amount up to 90% of their annual compensation. Participants are subject to certain contribution limitations under Section 401(k) and Section 415 of the Internal Revenue Code (IRC). Participants that have reached the age of 50 may elect to defer additional amounts to the Plan. A participant may designate all or a portion of their elective deferral contribution as after-tax Roth elective deferrals.

The Plan includes an automatic enrollment provision for non-contributing eligible employees unless the employee affirmatively elects not to participate. The automatic deferral percentage is 3% of eligible wages, subject to an auto-escalation feature of 1% annually until a deferral rate of 10% is reached.

The Plan includes a discretionary employer matching contribution, whereby the Company matched 50% of the first 6% of each participant's contribution during both 2024 and 2023.

Additionally, the Company may make discretionary profit-sharing contributions to eligible participants meeting certain criteria. The Company did not make a discretionary profit-sharing contribution for the years ended December 31, 2024 and 2023.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary employer matching contribution, the Company's discretionary profit-sharing contribution, and investment earnings or losses, and is reduced by benefit payments and administrative expenses. Net earnings and losses from each investment fund are allocated to each participant's account based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Participants vest in company discretionary matching contributions plus earnings thereon at a rate of 33.3% per annum beginning after one year of credited service. Participants are fully vested in employer discretionary matching contributions after three years of credited service. Participants vest in company discretionary profit-sharing contributions plus earnings thereon at a rate of 20% per annum beginning after two years of credited service. Participants are fully vested in employer discretionary profit-sharing contributions after six years of credited service.

Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the Plan year.

Forfeitures

Forfeitures of non-vested account balances are used to pay Plan expenses or reduce employer contributions. Forfeited non-vested accounts totaled \$21 and \$20 at December 31, 2024 and 2023, respectively. Total forfeitures used to pay Plan expenses or reduce employer contributions totaled \$31,949 and \$48,336 for the years ended December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may generally borrow up to the lesser 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. Effective October 2, 2023, participants are permitted three loans outstanding at any given time. Prior to October 2, 2023, participants were permitted two loans outstanding at any given time. The loans are secured by the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid weekly or bi-weekly through payroll deductions. Loans must be repaid over a period not to exceed five years, except for loans issued in connection with the purchase of a primary residence, which generally are payable over ten years.

Payment of Benefits

Participants generally are eligible to receive distributions of their vested benefits upon retirement, termination of employment, or due to death or disability. In-service withdrawals from the Plan are permitted from an actively employed participant's account upon the attainment of age 59 ½.

Administrative Expenses

The Plan pays for a substantial portion of expenses associated with the administration of the Plan. Certain administrative expenses are paid by the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in the fair value of investments consists of both realized and unrealized gains and losses on the Plan's investments.

Fair Value Measurement - Definition and Hierarchy

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at fair value based on quoted market prices in active markets.

Common collective trust fund: Valued based on the fair value using the net asset value (NAV) practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

A description of where the Plan's investments fall within the ASC 820 fair value hierarchy is provided in Note 4.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. At both December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, economic conditions, world affairs, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and chances thereon, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

5. PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed and held by Reliance. As trustee and custodian of the Plan, transactions between Reliance and the Plan qualify as party-in-interest. Additionally, notes receivable from participants qualify as party-in-interest transactions.

6. TAX STATUS

The Plan uses a prototype plan document developed by ADP, LLC. The Internal Revenue Service has determined and informed ADP, LLC by letter dated October 6, 2020 that the written form of the underlying prototype plan document is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has not yet applied for its own determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions set forth by ERISA. In the event of termination, all participants become fully vested in their account balances.
