Opinion

We have audited the accompanying financial statements of UAW/UMass Health & Welfare Trust Fund (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of UAW/UMass Health & Welfare Trust Fund (Plan) as of October 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of UAW/UMass Health & Welfare Trust Fund (Plan) and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of the UAW/UMass Health & Welfare Trust Fund (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General - The Plan was organized under a collectively bargaining agreement (“Bargaining Agreement”) which provides that the International Union, United Automobile, Aerospace & Agricultural Implement Workers of America, UAW, and its Local No. 2322 (“Union”) enter into an agreement with the Board of Trustees of the University of Massachusetts (“Employer”) to establish and jointly administer a Plan into which the Employer makes contributions. The Plan provides dental, vision benefits, wellness reimbursement, and childcare and reimbursement tuition benefits covering graduate student employees of the Employer (GEO Unit).

The Bargaining Agreements in place during this period included one effective for the period September 1, 2020 to August 31, 2023 and one effective September 1, 2024 to August 31, 2027.

During 2012, the Plan started to provide dental benefits to Post-Doctoral UMass employees (Post Doc Unit). The eligibility requirements are based on employees working in excess of 20 hours a week. As of July 1, 2014, dental benefits, vision benefits, life insurance benefits and childcare reimbursement are being provided to these members. The current Post Doctorate UMass employees’ collective bargaining agreement runs from September 1, 2023 to August 31, 2026.

The Plan has requested an advisory opinion to determine whether the Plan is excluded from Title I of the Employer Retirement Income Retirement Income Security Act of 1974 (ERISA), as a “governmental plan” within the meaning of Section 3(32) of that Title or subject to the provision of ERISA. In June 2009, the U.S. Department of Labor (“DOL”) replied to the request stating that they were unable to provide an opinion at this time. The DOL and Internal Revenue Service have been coordinating their development of additional guidance that relates to Title I of ERISA and IRS Code 414(d).

Employer contributions - The Employer funds the Plan based on requirements that are set forth under the Bargaining Agreement. As of January 1, 2006, the Continuing and Professional Education (“CPE”) agrees to contribute to the Plan based on full-time equivalents. Currently, participant contributions are not required for single plan coverage. Participants enrolled in the family dental plan must contribute specified amounts for their coverage. The contributions are determined by the Plan and apply to all participants.

Benefits - The Plan provides dental and vision benefits to graduate student employees of the Employer and their covered partner and dependents. The eligibility requirements for these benefits are based on the eligibility requirement to receive health fee exemptions, which are based on the eligibility requirements to receive tuition waivers. The Board of Trustees of the University of Massachusetts sets the tuition waiver eligibility requirements.

The Plan has a dental policy with an independent insurance company. The claims are processed by the insurance company and are the responsibility of the Plan as the dental plan is self-funded.

The Plan has a vision policy with an independent insurance company. The claims are processed by the insurance company and are the responsibility of the Plan as the vision plan is self-funded.

In addition, the Plan funds flexible schedule childcare tuition for eligible families enrolled in the Employer’s Flexible Child Care Program during the year. The Plan funds \$1 or \$2 per hour depending on eligibility criteria.

Priorities upon termination of the plan

In the event of a termination of the Plan, the participants have certain specific rights. Participants should refer to the Plan Agreement for a complete description of the Plan provisions covering the priorities upon the termination of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, who are responsible for their integrity and objectivity. These accounting policies have been consistently applied in the preparation of the financial statements.

Basis of accounting - The Plan uses the accrual basis of accounting. Under the accrual basis of accounting, revenues are recognized when earned and expenditures are recognized when incurred rather than when collected or paid.

Investments - The Plan's investments are stated at fair value, as determined by quoted market prices. Securities traded on the national securities exchange are valued at the last reported sales price on the last business day of the Plan year. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of the investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits. The Plan maintains policies and procedures to value instruments using the best and most relevant data available. In addition, the Plan has an investment management team that reviews valuation, including independent price validation for certain instruments. Further, in most instances, management develops internal valuations of the assets and instruments held in the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Fair value - Accounting Standards Codification provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification are described as follows:

- Level 1 valuations reflect quoted market or exchange prices for the actual or identical assets or liabilities in active markets.
- Level 2 valuations reflect inputs other than quoted prices in Level 1 which are observable. The inputs can include some or all of the following into a valuation model:
 - quoted prices on similar assets in active markets
 - quoted prices on actual assets that are not active
 - inputs other than quoted prices such as yield curves, volatilities, prepayments speeds
 - inputs derived from market data
- Level 3 valuations reflect valuations in which one or more of the significant valuation inputs are not observable in an active market, there is limited if any market activity, and/or are based on management inputs into valuation model.

Contributions receivable - Historically, the Plan has not had any bad debts so no reserve is provided. It is management's opinion that all accounts recorded on the books are collectible.

Insurance contracts - The Plan purchases insurance contracts, that are excluded from plan assets, for the purpose of paying for certain death, accidental death and dismemberment, major medical, disability, and dental claims incurred under the terms of the Plan. These costs are expensed as incurred.

Tax status - The Plan is a tax-exempt entity under 501(c)9 of the Internal Revenue Code. Accordingly, the Plan's net investment income is exempt from income taxes. The Sponsor has obtained a favorable tax determination letter from the Internal Revenue Service and the Sponsor believes that the Plan, as amended, continues to qualify and to operate as designed.

The Plan has adopted Accounting Standards Codification, "Accounting for Uncertainty in Income Taxes." Accounting Standards Codification prescribes a comprehensive model for the financial statement recognition, measurement, classification and disclosure of uncertain tax positions. Management has not identified any uncertain tax positions and, therefore, no liability has been recorded in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax period in progress.

Use of estimates - The preparation of financial statements requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent events - Management has evaluated subsequent events through July 11, 2025, the date which the financial statements were available to be issued.

3. INVESTMENTS

The following section describes the valuation methodologies the Plan uses to measure the financial instruments at fair value. The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Following is a description of the valuation methodologies used for assets measured at fair value.

Bond funds – Valued using pricing models maximizing the use of observable inputs for similar securities readily available on the active market. This includes basing value of yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, the bond is valued under a discounted cash flows approach that maximizes observable inputs, such as current yields of similar instruments.

Common stocks – Common stock equities are valued on the basis of the closing price per share on each business day as reported on the active market.

Mutual funds – Valued at the closing price as reported on the New York Stock Exchange.

4. RELATED PARTY TRANSACTIONS

Effective January 1, 2006, the Plan pays the employer \$1 for every contribution paid by the employer for full-time equivalent bargaining unit members. The purpose of this agreement is to defray graduate student employee health care contributions. At October 31, 2024 and 2023, respectively, the amount due the employer was \$598,166 and \$492,932.

5. PARTIES IN INTEREST TRANSACTIONS

The Plan receives 100% of its revenue from the University of Massachusetts at Amherst (the employer). During the years ended October 31, 2024 and 2023, the Plan received revenues of \$2,494,615 and \$2,343,164, respectively. The receivables associated with these revenues as of October 31, 2024 and 2023, were \$619,862 and \$689,987, respectively.

6. CONCENTRATION

In 2024 and 2023, the Plan had revenue from one employer representing 100% of additions to Plan assets.

As of October 31, 2024 and 2023, contributions receivable from the one employer was \$619,862 and \$689,987, respectively.

7. CREDIT RISK

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
