INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of the
Employee Benefits Plan of Methodist Home for Children

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Employee Benefits Plan of Methodist Home for Children (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits in liquidation as of October 31, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits in liquidation, and accumulated plan benefits in liquidation for the period January 1, 2024 through October 31, 2024 and the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Employee Benefits Plan of Methodist Home for Children's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of October 31, 2024 and December 31, 2023, and for the period January 1, 2024 through October 31, 2024 and the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Employee Benefits Plan of Methodist Home for Children and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.



Other Matters – Supplemental Schedule Required by ERISA

The supplemental schedule is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN:

The following description of the Employee Benefits Plan (the "Plan") of Methodist Home for Children (the "Plan Sponsor") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General. The Plan is a defined benefit pension plan covering substantially all employees of the Plan Sponsor who had completed one year of service in which the employee had worked 1,000 hours with the Plan Sponsor and were age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Status. The Plan was frozen effective March 31, 2013. This amendment had the following effects: (1) no employee shall be eligible to become a participant in the Plan after the effective date; (2) Benefit Accrual Service shall not be credited for any service or employment for any participant after the effective date; and (3) final average earnings shall not include any compensation earned by any participant after the effective date. In June 2014, the Board of Directors of the Plan Sponsor resolved that the Plan would be terminated as soon as administratively feasible. The Plan was officially terminated as of October 31, 2024. As of that date, all participant accounts were fully settled, and distributions were made to participants in accordance with the Plan's termination provisions.

Funding Policy. The Plan's funding policy is for the Plan Sponsor to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During the period January 1, 2024 through October 31, 2024 and the year ended December 31, 2023, the Plan Sponsor made contributions of \$176,171 and \$102,006, respectively. The Plan Sponsor's contributions for 2024 and 2023 exceeded the minimum funding requirements of ERISA.

Vesting. Prior to the amendment effective July 1, 2014, participants were 100% vested in retirement benefits after completing 3 years of vesting service. The amendment effective July 1, 2014 provided that a participant that was not 100% vested became 100% vested at that date.

Pension Benefits. Employees with 3 or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) equal to 1.5% of their highest average earnings during any five consecutive calendar years out of the last ten years of employment plus 0.5% of any excess of their final average earnings over the social security average wage times credited service, up to a maximum of 35 years, but shall not include any earnings after March 31, 2013. The Plan permits early retirement at ages 55-64. Employees may elect to receive their pension benefits in the form of a joint and survivor annuity. Employees may elect to receive the value of their accumulated Plan benefits as a lump-sum distribution upon retirement or termination, or they may elect to receive their benefits as an annuity payable monthly from retirement.

Death and Disability Benefits. If an active employee dies, a death benefit is paid to the employee's beneficiary. At age 65, or early retirement date, a disabled employee will begin receiving normal retirement benefits.

Plan Amendment. In connection with the 2014 resolution to terminate the Plan, there was an amendment to the Plan. One provision of the amendment provided that all participants became 100% vested on July 1, 2014. Another provision expanded on the forms of distributions under which a participant who had not commenced receiving benefits as of the distribution commencement date could elect to receive benefits. There was an amendment on September 11, 2023 that set the effective date of plan termination as of October 31, 2023. The Plan was officially terminated as of October 31, 2024, at which point all participant accounts were fully settled, and distributions were completed in accordance with the Plan's provisions and regulatory requirements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting. The accompanying financial statements of the Plan were prepared using the liquidation method of accounting due to the June 2014 resolution to terminate the Plan. The Plan will distribute assets to Plan participants. Any missing participants' benefits may be paid to the Pension Benefit Guaranty Corporation ("PBGC") (a U.S. government agency). The Plan was terminated as of October 31, 2024. See Note 8 for further discussion of the Plan's termination.

Use of Estimates. The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of Plan assets and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Cash and Cash Equivalents. Mutual of America Life Insurance Company ("Mutual of America"), the Custodian, has determined that some of the Plan's assets are cash equivalents. This is based on certain considerations including liquidity and the redeemable value of the investment.

Investment Valuation and Income Recognition. Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by its Custodian and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Actuarial Present Value of Accumulated Benefits. Accumulated Plan benefits are future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to service employees. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' average compensation during their last ten years of credited service, but shall not include earnings after March 31, 2013. The accumulated Plan benefits for active employees are based on their average compensation during the five years ending on the date as of which the benefit information is presented (the valuation date), but shall not include earnings after March 31, 2013. Benefits payable under all circumstances-retirement, death, disability, and termination of employment are included to the extent they are deemed attributable to employee service rendered to the valuation date, but shall not include service rendered after March 31, 2013. Benefits to be provided via annuity contracts that are excluded from Plan assets are excluded from accumulated Plan benefits.

The actuarial present value of accumulated Plan benefits is determined by an actuary from Mutual of America and it is that amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuations, as of October 31, 2024 and December 31, 2023, were (a) life expectancy of participants (the 2024 and 2023 Unisex Mortality Table and the Internal Revenue Service ("IRS") Static Mortality Tables were used for 2024 and 2023, respectively), (b) retirement age assumptions (the assumed average retirement age was 63), and (c) investment return. The 2024 and 2023 valuations assumed an average rate of return of 4% and 3.75%, respectively.

During 2024, the total actuarial present value of accumulated plan benefits decreased by \$10,803,910 primarily due to termination of the Plan. The total actuarial present value of accumulated Plan benefits decreased during 2023 by approximately \$383,000. See Note 5 for details on the changes in value.

Payment of Benefits. Benefit payments to participants are recorded upon distribution.

Administrative Expenses. The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the Plan document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits in liquidation.

Income Taxes. The IRS has determined and informed the Plan Sponsor by a letter dated March 30, 2018 that the Plan and related trust are designed in accordance with the applicable sections in the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is a qualified plan as described in Section 401(a) of the IRC and is therefore exempt from federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's mission would be subject to tax which, if incurred, would be recognized as a current expense. No such tax has been recognized during the period January 1, 2024 through October 31, 2024 and for the year ended December 31, 2023.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan. Management has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024 and December 31, 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine tax audits by jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to informational return examinations for years prior to 2021.

4. FAIR VALUE MEASUREMENTS:

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Fair Value Measurements:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements:

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements:

Fair values are based on inputs other than quoted prices included within Level 1 that are unobservable and significant to the fair value measurements.

The asset and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

6. CONTRACT WITH INSURANCE COMPANY:

In 1985, the Plan Sponsor entered into an investment contract with Mutual of America under which the Plan deposits a contribution each year. Mutual of America maintains the contributions in a fund that has a separate account. At the direction of the Plan Administrator, a single premium to buy an annuity for a retiring and vested terminated employee is withdrawn by Mutual of America from the pension general account. Purchased annuities are contracts under which Mutual of America is obligated to pay benefits to named employees or their beneficiaries.

7. PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are managed by Mutual of America. Mutual of America also provides actuarial services to the Plan. Mutual of America is the Custodian as defined by the Plan, therefore these transactions qualify as party-in-interest transactions.

Fees paid for professional services were based on customary and reasonable rates for such services. Fees incurred by the Plan for services provided by Mutual of America amounted to \$13,787 and \$7,960, respectively, for the period January 1, 2024 through October 31, 2024 and the year ended December 31, 2023. The Plan Sponsor also provides certain accounting and administrative services to the Plan for which no fees are charged. The Plan Sponsor directly pays any other fees related to the Plan's operations.

8. PLAN TERMINATION:

The Plan Sponsor resolved to terminate the Plan in June 2014 and began this process during 2014. The net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
2. Other vested benefits insured by the PBGC up to the applicable limitations (discussed below).
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

Benefits to be provided via contracts under which Mutual of America (Note 6) is obligated to pay the benefits would be excluded for allocation purposes.

Certain benefits under the Plan are insured by the PBGC when the Plan terminates. Generally, the PBGC guarantees most vested normal-age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. For Plan terminations occurring during 2024 and 2023, that ceiling was \$7,108 and \$6,750, respectively, per month, annually. That ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or Plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

The Plan was officially terminated as of October 31, 2024, at which point all participant accounts were fully settled, and distributions were completed in accordance with the Plan's provisions and regulatory requirements.

9. SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through April 25, 2025, the date which the accompanying financial statements were available to be issued. No significant subsequent events have been identified by management.
