Note 1 - Description of the Plan

The following description of the Community Teamwork, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the “Summary Plan Description” and the Plan document for a more complete description of the Plan’s provisions. Copies are available from the Plan Administrator.

General

The Community Teamwork, Inc. Retirement Plan (the Plan) is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

All employees are eligible to participate in the Plan, and an employee becomes eligible for the employer contribution after completing six months of service.

Contributions

Eligible participants may contribute, for both regular and Roth deferrals, up to 75% of their compensation, as defined by the Plan up to the maximum allowable under Internal Revenue Code (IRC) Sections 401(k), 402(g), 404 and 415, including catch-up contributions.

The Plan has an auto enroll feature, which allows at an initial deferral rate of 3% for all newly eligible employees with no or zero deferral elections upon the later of 35 days after hire or employee entry date, and eligible employees being rehired upon the later of 30 days from the date of rehire or entry date.

Employer discretionary contributions are 5% of compensation for each eligible employee, as defined by the Plan. Employees do not have to contribute to receive the employer contribution.

Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct all contributions in various investment options offered by the Plan. Participant and employer contributions are recorded in the period in which payroll deductions are made.

Pre-tax contributions are subject to limitations under federal law of \$23,000 and \$22,500 for the Plan years ended December 31, 2024 and 2023, respectively.

The Plan also provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan could also make a catch-up contribution of \$7,500 for both the years ended December 31, 2024 and 2023.

Note 1 - Description of the Plan (continued)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions and earnings are vested based on years of service. Employees will become 20% vested after one year of service, 50% vested after two years of services, and 100% vested after three years of service. A participant will be fully vested upon attainment of age 65, death or total and permanent disability.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) employer contributions and (b) Plan earnings and charged with transaction fees as applicable. Allocations are based on participant earnings or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow up to a maximum amount equal to the lesser of \$50,000 or one-half of their vested account balances. Participants may only have one loan outstanding at any given time. Repayment is made through payroll reductions. Upon default or termination of employment, the entire outstanding principal and accrued interest becomes immediately due and payable.

Plan Investments

The Plan's investments are held by Fidelity Management Trust Company in various mutual fund securities and a common collective trust. Participants have the option to allocate their contributions and the Plan Sponsor's contributions in their individual accounts among the various investment alternatives and to make transfers as specified in the Plan document.

Benefits and Related Amendment

If a participant's vested benefit is \$1,000 or less at the date of termination, the entire vested amount will be paid out as a lump-sum payment. If a participant vested benefit is greater than \$1,000 but less than \$7,000, the entire vested amount will be rollover to a designated Internal Retirement Account or Annuity ("IRA") set up by the Plan Sponsor. Upon retirement or termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account. Annuity payments in, the form of a life annuity or 75% joint and survivor annuity are also allowed under the Plan.

The Plan allows hardship distributions to be withdrawn from participant deferral contributions and the vested amount of their profit-sharing account. The Plan was most recently amended effective December 9, 2024, in which, participants shall be entitled to receive a distribution of all or any portion of all vested sub-accounts upon attainment of age 59 ½.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Fair Value Measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability and;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at contract and fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fair Value Measurements (continued)

Money Market Fund: The fair value of the money market fund has been estimated under the practical expedient approach using the net asset value (NAV) per share. The fair value of the underlying investments is determined using the amortized cost method which approximates fair value. Under this method, investments are valued at cost when purchased and thereafter, a constant proportionate accretion and amortization of any discounts and premiums are recorded until the maturity of the security. The fund seeks to maintain its NAV per share at \$1, although there is no assurance that it will be able to do so on a continuing basis.

Common/Collective Trust: Valued at NAV of units, as provided by the trustee and used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The portfolio attempts to obtain prices from one or more third party pricing vendors or brokers to value its investments and when current market prices or quotations are not readily available or reliable, securities will be valued in good faith. Factors used in determining value vary by security type and may include market or security specific events, changes in interest rates and credit quality.

The preceding methods described may produce a value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the value of certain financial instruments could result in a different value measurement at the reporting date.

Investment Valuation and Income Recognition

All investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest at interest rates between 4.25% and 9.50%. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and the benefit payment recorded.

Note 2 - Summary of Significant Accounting Policies

Contributions

Contributions from the Plan Sponsor are accrued as of December 31, 2024 and 2023, based upon the contribution formula. Participants' contributions are recorded in the period in which their payroll deductions are withheld.

Benefits Paid Directly to Participants

Benefits payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Expenses associated with the administration of the Plan and fees related to the administration of notes receivable from participants are charged directly to participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

Forfeitures

If a participant terminates employment, any unvested portion of his or her account is forfeited to the Plan. Such forfeitures will be applied to reduce the out-of-pocket contributions of the Plan Sponsor or to pay Plan administrative expenses. The following is a summary of forfeiture activity.

The Plan includes a Revenue Credit Program which allocates revenue credits received from investment providers back to participant accounts. These credits are derived from the fees paid to investment providers and are used to offset Plan expenses or credited directly to participant accounts. The balance in the revenue credit program account at December 31, 2024 and 2023, was \$4,776 and \$2,149, respectively. During the year ended December 31, 2024 the fees and dividend income contributed into the account totaled \$2,627.

Note 5 – Exempt Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company, and, therefore, these transactions qualify as party-in-interest transactions; however, these are not considered prohibited transactions. Fees paid by the Plan for the investment management services are included in net depreciation in fair value of investments.

In addition, the Plan issues loans to participants, which are secured by balances in the participants' accounts. These transactions also qualify as party-in-interest transactions as that term is defined in Section 3(14) of ERISA.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Further, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Note 7 - Tax Status

Effective January 1, 2021, the Plan adopted a non-standardized pre-approved plan sponsored by FMR LLC. The non-standardized pre-approved plan sponsor received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan and related trust are designed in accordance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require disclosure in the financial statements. Therefore, no provisions or liability for income taxes has been included in the financial statements. With few exemptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for the years before 2021.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will automatically become 100% vested in all unvested company contributions.
