### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the North State Bank 401(k) Plan and ESOP (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## Notes to Financial Statements

### 1. Description of the Plan

The following description of the North State Bank 401(k) Plan and ESOP (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of North State Bank (the "Company") who have met the eligibility requirements. The Board of Directors of the Company controls and manages the operation and administration of the Plan. As of December 31, 2024 American Trust Company served as the third-party administrator and trustee of the Plan. Mid Atlantic Trust Company served as the trustee as of December 31, 2022 and was re-branded through an acquisition in April 2023 to American Trust Company ("Trustee").

Effective January 1, 2015, the Board of Directors amended the Plan to include an Employee Stock Ownership Plan ("ESOP") for the purpose of providing employees the opportunity to obtain an ownership interest in North State Bancorp ("Bancorp"). The ESOP is primarily invested in shares of the Bancorp's common stock. Participants may not direct the investment of their accounts under the ESOP. First Trust of MidAmerica serves as the trustee for the ESOP investments. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Contributions**

Each year, participants may contribute both pre-tax deferrals and Roth after tax deferrals, as defined in the Plan document, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In 2024, the Company temporarily suspended the employer match. In 2023, the Company contributed a 100% dollar for dollar safe harbor match of the first 6% of compensation that a participant contributed to the Plan. Additional non-elective discretionary amounts may be contributed at the option of the Company's Board of Directors. No additional contributions were made for the year ended December 31, 2024. Contributions are subject to certain limitations.

#### **Investment Options**

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers mutual funds and a stable value collective trust fund as investment options for participants. Prior to 2022, Company contributions were not participant directed and were invested in Bancorp common stock and a money market mutual fund.

#### **Voting Rights**

With respect to certain corporate matters which must be decided by more than a majority vote of outstanding common shares voted, each eligible participant directed First Trust of MidAmerica, the trustee of the ESOP component trust, as to the manner in which voting rights representing the interest of such participant would be exercised. Eligible participants had one vote for each share of common stock in the participant's Bancorp stock account.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and Company contributions and allocations of Plan earnings. The account is charged with benefit payments, transaction fees, and allocations of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also vested immediately in the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's non-elective discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 33.33% vested after one year of credited service and vests an additional 33.33% per year thereafter up to 100% vesting after three years.

***Payment of Benefits***

On termination of service, death, disability, retirement, or for other reasons a participant may elect to receive an equal amount to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installments as provided by the Plan document. Amounts contributed on a before-tax basis may be withdrawn upon demonstration of financial hardship, disability, or after the participants reach the age of 59.5 years.

Distributions on account of attainment of normal retirement age, total and permanent disability, and death will be made as soon as is feasible in the plan year following the event. If the employee terminates for another reason, the distribution for accounts with a combined balance (including the ESOP portion) of \$7,000 or less will be made in the plan year following the event. If a participant's vested account exceeds \$7,000 the ESOP account will be distributable in the plan year following the earlier of either the end of the fifth plan year, in installments, following the event or the end of the plan year in which the participant attains normal retirement age. Benefits will be paid in cash or stock, as determined by the Plan administrator, with the amount based upon the immediately preceding valuation date; however, if the Plan administrator determines to make distributions in stock, the stock is subject to immediate purchase by the Company or the Plan.

***Put Option***

Under federal income tax regulations, the Company common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the trust buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The put option is exercisable for a period of 60 days. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash. Payment under the put option involving a total distribution shall be paid in annual installments over a period beginning not later than 30 days after exercising the put option and not extending beyond five years.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments, which are more diversified. Participants who are at least age 55 with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

## 2. Summary of Significant Accounting Policies

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

### ***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits are recorded upon distribution.

### ***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions such as distributions are charged directly to the participant's account.

### ***Subsequent events***

The Plan has evaluated subsequent events through July 18, 2025, the date the financial statements were available to be issued. Effective December 31, 2024 the Company began a 3% non-elective contribution for the 2025 plan year.

## 3. Fair Value Measurements

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1:** Observable inputs such as quoted prices in active markets.
- Level 2:** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3:** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurements. The Plan’s assessment of the significance of a particular input to fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in methodologies used at December 31, 2024 and 2023. The following is a description of valuation methodologies used for assets measured at fair value:

***Mutual Funds***

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

***Stable Value Collective Trust Fund***

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (“NAV”) per share provided by Trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust fund, no notice is required by the issuer. The stable value collective trust fund is not required to be classified within a level on the fair value hierarchy.

***Common Stock***

The Bancorp’s common stock is valued at an estimated fair value as determined at the end of the year by an independent appraisal. This appraisal was based upon a combination of the market and discounted cash flow valuation techniques. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market equivalents, and fair value of the Company’s assets and liabilities. Bancorp’s common stock is classified within Level 3 of the valuation hierarchy.

The estimated fair value of the Company common stock as of December 31, 2024 and 2023, was \$12.95 and \$12.75 per share, respectively. Net appreciation in the fair value of the Company common stock totaled \$89,153 for the year ended December 31, 2024.

There were no issuances and no transfers in and out of Level 3 assets for the year ended December 31, 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The certification mentioned above includes all investment information discussed in Note 3, except for \$6,337,402 and \$6,234,947 as of December 31, 2024 and 2023, respectively, in the ESOP account, which includes the Company common stock and a Federated Prime Cash Obligation fund that are not certified by the trustee. Net appreciation in fair value investments and investment income related to dividends and interest in the ESOP account totaled \$89,153 and \$349,317, respectively, for the year ended December 31, 2024 are also are not certified by the Trustee.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**6. Exempt Party-In-Interest Transactions**

As described in Note 2, the Plan paid certain expenses related to the Plan operations and investment activity to various service providers, including the trustee. Fees paid by the Plan for investment management and administrative service were \$94,515 for the year ended December 31, 2024. These transactions qualify as exempt party-in-interest transactions.

At December 31, 2024 and 2023, the Plan held 445,815 shares of the Bancorp's common stock with cost basis of \$5,783,072. During the year ended December 31, 2024, the Plan recorded \$316,764 of dividend income from the Bancorp's common stock.

**7. Tax Status**

The Internal Revenue Service (the "IRS") has determined and informed the Company by letter dated December 23, 2015, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has since been amended; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
