Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Quantum Corporation Employee Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 – Description of the Plan

The following description of the Quantum Corporation (the “Company” or “Plan Sponsor”) Employee Savings and Investment Plan (the “Plan”) provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan, which went into effect July 1, 1985, that is generally available to employees of the Company and Participating Employers (collectively, the “Employer”). The Plan excludes nonresident aliens, collectively-bargained employees, leased employees, interns, and employees who are paid through an outside agency. Eligible employees may enter the Plan immediately upon meeting the eligibility requirements for each type of contribution offered under the Plan. There are no age or service requirements for participant contributions, however, there are service requirements for discretionary matching and discretionary nonelective Employer contributions as further discussed below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Contributions. The following types of contributions are allowable under the Plan:

- **Participant Contributions** – Participants may contribute up to 50% of their pretax compensation, as defined in the Plan document, or after-tax compensation. Participants may also elect to make an after-tax Roth contribution to the Plan. If an eligible employee does not make a salary deferral election, the Plan has an automatic enrollment feature whereby such employee is automatically enrolled at a pre-tax salary deferral percentage of 6% of compensation, unless such employee elects out of the automatic enrollment after appropriate advance notice. Such percentage shall be auto-increased by 1% on July 15th of each year until a 10% deferral percentage is reached. A participant’s total pre-tax and Roth contributions cannot exceed \$23,000 (\$30,500 for participants age 50 or older) in calendar year 2024.
- **Discretionary Matching Employer Contributions** – The Employer may contribute matching amounts each payroll period to eligible participants who have completed 6 months of service and who are employed by the Employer on the last day of the Plan year quarter. For the period from January 1, 2024 through June 30, 2024, the Employer matched 50% of each eligible participant’s contribution up to a maximum of 6% of a participant’s compensation. For the period from July 1, 2024 through December 31, 2024, no discretionary Employer matching contributions were made.
- **Discretionary Nonelective Employer Contributions** – The Employer may make a nonelective contribution on a quarterly basis to those eligible participants who have completed 6 months of service and are employed by the Employer on the last day of the Plan year quarter. This contribution is allocated to each eligible participant’s account based on a participant group allocation method whereas each eligible participant will be considered their own allocation group. For the year ended December 31, 2024, the Employer did not make a discretionary Employer contribution.
- **Rollover Contributions** – Certain amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants. The total annual additions to a participant's account may not exceed the lesser of \$69,000 or 100% of the participant's compensation in 2024. Annual additions are defined as participant contributions (pre-tax, after-tax, and Roth) and Employer contributions.

Participant Accounts. Each participant's account is credited with the participant's contributions (pre-tax, after-tax, Roth, and rollovers, if any) and an allocation of (a) the Employer's discretionary contributions (matching and nonelective), if any, (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participant's are 100% vested in their accounts.

Investment Options. Participants may direct their investments into various registered investment companies, a money market fund, a common collective trust, or any investment security offered through the self-directed brokerage accounts.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms range up to a maximum of 5 years (15 years if used for the purchase of a principal residence). The loans are secured by the balance in the participant's account and bear a rate of interest equal to prime plus 1% at the date the loan is granted as determined by the Plan administrator. Principal and interest payments are paid ratably through payroll deductions.

Payment of Benefits. Benefits to participants or beneficiaries generally are payable as a lump sum, installments, or partial withdrawals equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. Additionally, participants may request in-service withdrawals of their rollover contribution account or certain portions of their accounts upon attainment of age 59½, for active military distributions, or upon incurring a financial hardship, as defined in the Plan document, if certain criteria are met.

Forfeitures and Participant Revenue Credit Accounts. When certain terminations of participation in the Plan occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay administrative expenses of the Plan or are used to reduce Employer contributions. During 2024, no forfeitures were used for either of these purposes. As of December 31, 2024 and 2023, unutilized forfeitures were \$53,711 and \$41,107, respectively.

The Plan provides for a Participant Revenue Credit Arrangement. The balance in the revenue credit account as of December 31, 2024 and 2023 was \$29,414 and \$22,362, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates. The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Contributions. Participant contributions and the related Employer matching contribution are recognized in the period in which participant contributions are withheld from compensation.

Benefit Payments. Benefits are recorded when paid.

Administrative Expenses and Revenue Credits. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are recordkeeping, account maintenance, accounting, and other fees. Certain investment related expenses are included in net appreciation in fair value of investments.

The Plan calculates quarterly revenue credits for participants based on the Plan's average quarterly balances held by participants invested in eligible funds. Revenue credits are allocated back to participants' accounts on a pro-rata basis. For the year ended December 31, 2024, total administrative expenses and revenue credits netted to \$110,235, which consisted of \$155,177 in administrative fees and \$44,942 in revenue credits.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Registered investment companies ("RICs") and money market funds ("MMFs") (including RICs and MMFs held in the self-directed brokerage accounts) are valued at the quoted net asset value ("NAV") of shares/units held by the Plan at year end;
- The common collective trust ("CCT") is valued at the NAV of units in a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.
- Common and preferred stocks held in the self-directed brokerage accounts are valued at the closing price reported on the active market on which the individual securities are traded;
- Corporate bonds and U.S. government securities held in the self-directed brokerage accounts are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings;

- Certificates of deposit held in the self-directed brokerage accounts are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer; and
- Rights / warrants held in the self-directed brokerage accounts are valued using pricing models maximizing the use of observable inputs for similar securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 – Tax Status

The Company has adopted an FMR, LLC Non-Standardized Pre-Approved Profit Sharing Plan (“pre-approved plan”). The pre-approved plan received an opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code (“IRC”). Although the Plan and pre-approved plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments are shares/units of registered investment companies, a common collective trust, and a money market fund offered by Fidelity. As Fidelity Management Trust Company is the trustee of the Plan, these transactions qualify as party-in-interest transactions. Additionally, the Plan maintains notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 9 – Concentrations, Risks and Uncertainties

The Plan provides for various investment options in registered investment companies, a money market fund, a common collective trust, and various securities offered through the self-directed brokerage accounts. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there were two investments which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

On June 28, 2024, the Plan Sponsor submitted their Annual Report on Form 10-K ("Annual Report") for the fiscal year ended March 31, 2024 ("Fiscal 2024") with the United States Securities and Exchange Commission ("SEC"). In the Fiscal 2024 Annual Report, the Company's external auditors, Grant Thornton LLP, indicated in their Independent Registered Public Accounting Firm Report that there was substantial doubt about the Company's ability to continue as a going concern. No adjustment has been made to the accompanying financial statements as a result of this uncertainty.

Note 10 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 4, 2025, which is the date the financial statements were available to be issued.

On June 30, 2025, the Company filed a Notification of Late Filing on Form 12b-25 with the SEC indicating that the Annual Report for the fiscal year ended March 31, 2025 ("Fiscal 2025") would be delayed due to additional time being needed to review its accounting related to certain revenue contracts as well as the application of standalone selling price under applicable accounting standards. On July 17, 2025, the Company received a written notice (the "Notice") from the Listing Qualifications staff of the Nasdaq Stock Market LLC ("Nasdaq") stating that the Company is not in compliance with Nasdaq Listing Rule 5250(c)(1) as a result of the Company's failure to timely file its Fiscal 2025 Annual Report with the SEC. No adjustment has been made to the accompanying financial statements as a result of these uncertainties.
