Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Alwin Manufacturing 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Note 1: Description of Plan

The following description of the Alwin Manufacturing 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Alwin Manufacturing Company, Inc. and its wholly owned subsidiaries Forest Tool, Inc., Deluxe Plastics (Medford), M & M Tool & Mold, LLC, and Deluxe Plastics (the "Company"). To become eligible to participate in the Plan and receive safe harbor matching contributions, employees must have attained 19 years of age and have completed four months of service. Effective January 1, 2024, long term-part-time employees must complete three consecutive years of service where the employee completes at least 500 hours of service to become eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring of investment performance.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate rate. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company contributes a safe harbor matching contribution equal to 100% of each participant's contributions that do not exceed 3% of the participant's compensation plus 50% of the amount of each participant's contributions that exceed 3% but do not exceed 5% of the participant's compensation. Rollover contributions are not matched. In addition, the Company may make an additional matching or discretionary nonelective contribution that is allocated based on a participant's compensation as a percentage of total compensation for all participants. In order to receive discretionary nonelective contributions, a participant must have over 1,000 hours of service during the plan year and must be employed on the last day of the plan year. The Company did not make an additional matching or discretionary nonelective contribution for 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, and allocations of (a) the Company's additional matching and discretionary nonelective contributions and (b) plan earnings (losses). Participant accounts are reduced by withdrawals and are charged an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's additional matching and discretionary nonelective contribution portion of their account plus actual earnings thereon is based on continuous years of service subject to a six-year graded vesting schedule, as defined in the plan document. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service. In addition, participants become fully vested upon death or disability.

Payment of Benefits

On termination of service due to death, disability, normal retirement (age 60), or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in installment payments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000 but is greater than \$1,000, the plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement plan. Vested balances less than \$1,000 can be distributed only in a single lump-sum payment. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½. Participants may withdraw their rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's additional matching or discretionary nonelective contributions. Forfeited nonvested accounts totaled \$5 at December 31, 2024 and 2023. These accounts can be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, there were no forfeitures used to pay administrative expenses or offset company contributions.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 (“SECURE 2.0”), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment management expenses and included in net investment income. Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. Other administrative expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through August 12, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market: Valued at NAV.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments, and non-interest-bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N.A. ("Alerus"), the trustee of the Plan.

Note 5: Party-In-Interest Transactions

A certain plan investment is managed by Alerus. Alerus is the trustee, as defined by the plan document; therefore, transactions with Alerus qualify as party-in-interest transactions. Fees paid by the Plan to Alerus for administrative services, which were not covered by revenue sharing, were \$22,888 for 2024.

Nicolet National Bank ("Nicolet") is the Plan's investment advisor. Fees paid by the Plan to Nicolet qualify as party-in-interest transactions. Fees paid by the Plan to Nicolet for investment management services were \$32,569 in 2024.

Note 6: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan has been amended since receiving the notification letter; however, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company additional matching and discretionary contributions.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Company is required to remit participant contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Plan's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Plan. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for a payroll during the plan year ended December 31, 2024, totaling \$8,696 were not timely remitted. This transaction constitutes a prohibited transaction as defined by ERISA.
