**NOTE A - DESCRIPTION OF PLAN**

The following description of the Shannondell 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan, which commenced February 1, 2004. All employees who have three months of service and are age 21 or older are eligible to participate. Employees are able to enter the Plan the first day of the plan year quarter coinciding with or next following the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, eligible participants may contribute a portion of their gross compensation on a pre-tax basis to the Plan through salary reduction. Participants’ elective deferrals are subject to the limitations of Internal Revenue Code Section 402(g). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Shannondell at Valley Forge (the “Company”) can make a discretionary match. For the Plan year ended December 31, 2024, the Company contributed 50% of employee deferrals up to 4% of compensation. The Company match is determined annually by management. Matching contributions were \$367,503 in 2024.

**Participant Accounts**

A separate investment account is maintained for each Plan participant. Participants may direct the investment of their accounts into various funds specified by the Plan. Participant accounts are credited with the participant’s contribution, an allocation of the Company’s matching contribution and an allocation of Plan earnings (losses) and are charged with an allocation of administrative expenses, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately 100% vested in their own contributions to the Plan.

Participants shall be vested in their employer matching account based on their years of service in accordance with the following schedule:

Year 1.....	33%
Year 2.....	66%
Year 3.....	100%

Regardless of the vesting schedule, a participant will become fully vested upon death, disability, and at normal retirement age.

**Participant Loans**

Participants may borrow from their fund accounts a minimum of \$500 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates, as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions. The maximum loan term is five years, and each participant may only have up to five outstanding loans.

**Payment of Benefits**

Participants are eligible to receive a distribution of the vested portion of their individual account balance upon the following:

- The occurrence of any of the distributable events specified in the Adoption Agreement,
- The participant's termination of employment after attaining normal retirement age and
- Termination of the Plan.

The normal retirement age under this Plan is 65.

**Forfeitures**

Employees who terminate employment and are not vested will forfeit the nonvested portion of their account balance to the Plan, as specified in the Adoption Agreement. The forfeiture nonvested account balance was \$8,894 and \$24,155 for the years ended December 31, 2024 and 2023, respectively, and is maintained in an account separate from the individual participant accounts. Forfeited amounts of \$17,624 for 2024 was used to reduce plan expenses and \$19,534 for 2024 was used to reduce employer match contributions.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distribution of participants' accounts shall be in accordance with the Plan document.

**Plan Amendments**

On December 29, 2022, the “Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act” was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan’s investments in mutual funds (registered investment companies) are stated at fair value. Shares of registered investment companies are valued at quoted market prices. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investment options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day the principal market is open and are available to any participant in the Plan. The Plan’s investments in the guaranteed investment account are reported at contract value which represents the contributions made under the contract plus earnings less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

**Participant loans receivable**

Participant loans receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses, excluding transaction fees, are paid by the Company.

**Party in Interest Transactions**

Certain investments of the Plan are managed by JPMorgan Chase, which is an affiliate of JPMorgan Invest Holdings LLC, who provides administrative services for the Company and the Plan. JPMorgan Invest Holdings LLC has subcontracted out recordkeeping services to Empower Trust Company, LLC. Also, certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as party-in-interest transactions allowable under ERISA guidelines.

**Date of Management's Review**

Management has evaluated subsequent events through July 16, 2025, the date which the financial statements were available to be issued.

**NOTE C - RELIANCE ON TRUSTEES' REPORT**

The administrator of the Plan has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by Empower Trust Company, LLC, the trustee of the Plan, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, other than comparing such information to that contained in the financial statements and supplemental schedule.

**NOTE D - TAX STATUS**

The Plan is a prototype non-standardized profit-sharing/money purchase plan with CODA sponsored by Empower Retirement LLC. Empower Retirement LLC has received a favorable opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, indicating that the Plan is a qualified plan under Section 401(k) of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan, as amended, is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan was qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE E - FAIR VALUE MEASUREMENTS**

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

Level 1 inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs are other than quoted prices that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. Level 3 inputs are unobservable inputs based on the Plan’s assumptions used to measure assets and liabilities at fair value. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE F - GROUP ANNUITY CONTRACT WITH MASSACHUSETTS MUTUAL LIFE INSURANCE COMPANY**

In 2016, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Massachusetts Mutual Life Insurance Company (Mass Mutual) totaling \$- for 2024 and \$83,921 for 2023. Mass Mutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Mass Mutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**NOTE G - RISKS AND UNCERTAINTIES**

Investment securities are exposed to various risks, such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially and adversely affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
