- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule of Delinquent Contributions for the year ended December 31, 2023 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1 Description of Plan

The following description of INOAC Exterior Systems, LLC Retirement Savings & Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all full-time and part-time employees of INOAC Exterior Systems, LLC (“Company”), the Plan Sponsor, who meet the hours of service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan has been previously restated (via adoption agreement) to bring the Plan into compliance with all recent required regulatory updates.

Plan Merger and Transfer:

Effective October 24, 2024, the assets of the Plan were merged with and transferred to the INOAC USA 401(k) Savings Plan (“INOAC USA Plan”). In anticipation of the merger transaction, the Plan was frozen to employee and employer contributions to the Plan (except rollover contributions) effective January 1, 2024.

Eligibility:

Prior to January 1, 2024, all full-time and part-time employees who worked three consecutive months of eligibility service requirement were eligible to participate in the Plan.

The Plan had an automatic elective deferrals feature. Employees hired on or after January 1, 2016 were enrolled into the Plan at an elective deferral of 4%. There was also an automatic elective deferral increase of 1% of payroll once a year with a maximum up to 10%.

Contributions:

Employee Deferral – Prior to January 1, 2024, participants could contribute up to 50% of their compensation to the Plan in increments of 1%. Catch-up contributions were allowed in accordance with Internal Revenue Service guidelines.

Employer Matching Contributions – Prior to January 1, 2024, the Plan matched the first 2% of the employees' voluntary salary deferral contributions and 50% of any contributions in excess of 2% with a maximum matching percentage of 3%.

Employer Discretionary Contributions – Prior to January 1, 2024, the Company could contribute a yearly profit sharing amount to the account of each eligible Plan participant. The annual profit sharing percentage was based on the annual operating margin performance of the Company. Each participant's profit sharing amount was determined by multiplying their eligible annual compensation by the profit sharing percentage. There were no such profit sharing contributions for 2024 or 2023.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

1 Description of Plan, Continued

Contributions, Continued:

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, and earnings and losses thereon.

Vesting:

Participants are immediately vested in their elective deferral contributions, employer matching, and rollover amounts, plus actual earnings thereon. Vesting in the discretionary profit sharing contributions is based on years of continuous service, with full vesting occurring after four years of credited service.

Forfeitures:

Forfeitures due to termination from the Plan before a participant is 100% vested were used to reduce employer profit sharing contributions or to offset plan administrative expenses. During 2024 and 2023, \$0 and 38,000, respectively, of forfeitures were used to offset plan administrative expenses. At October 24, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$116,386, respectively.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions on at least a quarterly basis.

Loans are valued at unpaid principal plus any accrued, but unpaid interest. No allowance for credit losses has been recorded as of October 24, 2024 and December 31, 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Other Plan Provisions:

Normal retirement age is 65, however, a participant could elect early retirement on or after age 55. The Plan also provided for early payment of benefits after reaching age 59-1/2.

Hardship Withdrawals:

Hardship withdrawals are permitted in accordance with Internal Revenue Service ("IRS") guidelines.

1 Description of Plan, Continued

Investment Options:

Upon enrollment in the Plan, a participant could direct any contributions to any of the investment options offered by the Plan (in multiples of 1%).

Payment of Benefits:

On termination of service, a participant is entitled to receive a lump sum amount equal to the vested value of his or her account. Upon termination of employment due to retirement, total and permanent disability or death, a participant or their beneficiary will be entitled to receive a distribution of his or her entire account without regard to the Plan's vesting rules: (i) in one lump sum amount; or (ii) in monthly installments of a fixed amount or over a specific period of time in an amount of at least \$100 per month. If the value of a participant's account is less than \$5,000, the Plan Administrator will distribute the participant's entire interest in one lump sum payment. Benefit payments are recorded when paid.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Investments held in the Plan are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value of the collective investment trust is valued based on the underlying investments which are generally a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts backed by bond funds and trust that are selected by the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

2 Summary of Significant Accounting Policies, Continued

Administrative Fees:

Expenses of the Plan are borne by the participants. In addition, loan fees are paid by the participant requesting the loan.

Risks and Uncertainties:

The Plan's investment portfolio included investments in mutual funds, money market funds, and a collective investment trust holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through August 8, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

The Plan adopted a pre-approved prototype plan from The Vanguard Group. On June 30, 2020, the IRS stated that the pre-approved prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been restated; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of October 24, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

5 Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Vanguard Fiduciary Trust Company, the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest. Usual and customary fees were paid by the mutual fund for the investment management services. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party-in-interest transactions.

6 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

6 Fair Value Measurements, Continued

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 24, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds are based on quoted market prices. These fall into the Level 1 category of the valuation hierarchy.

Money Market Fund:

The fair value of the fund investments is based on amortized cost. Amortized cost approximates current value, but since the value is not determined by observable inputs in an active market, the fund falls into the Level 2 category of the valuation hierarchy.

Collective Investment Trust:

The fair value of the Vanguard Retirement Savings Trust III is based on the underlying assets of the contract. The fair value is expressed in units. This fund is classified in the Level 2 category of the valuation hierarchy.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment trust, the investment adviser reserves the right to temporarily delay from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Withdrawals may be initiated by the Unitholder for the primary purposes of funding an authorized distribution, withdrawal or loan disbursement, pay a participating profit-sharing plan to an employee or beneficiary covered thereunder, or for the purpose of the participating plan making an employee-directed transfer to another investment election.

There were no assets held by the Plan as of October 24, 2024.
