## Independent Auditor's Report

To the Plan Administrator of  
Greater Lynn Senior Services, Inc. Tax Sheltered Annuity Plan:

We have performed audits of the financial statements of Greater Lynn Senior Services, Inc. Tax Sheltered Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. DESCRIPTION OF THE PLAN

The following description of Greater Lynn Senior Services, Inc. Tax Sheltered Annuity Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions.

#### a. General

The Plan is a defined contribution plan covering all eligible employees of Greater Lynn Senior Services, Inc. (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance and reports to the Plan Sponsor's Retirement Oversight Committee.

#### b. Eligibility

All employees upon employment with the Plan Sponsor are eligible to participate in the Plan and receive the Plan Sponsor's discretionary matching contributions. Employees who normally work less than 20 hours per week are not eligible to participate in the Plan. Effective January 1, 2025, long-term part-time employees who worked 500 hours of service in the previous two consecutive years are eligible to participate in the Plan. Collectively bargained employees are not eligible to participate in the Plan unless their collectively bargained agreement states otherwise. Employees who are in the Teamsters Local Union No. 42 - Drivers and Clerical Units are not eligible for discretionary matching contributions.

To be eligible to receive the Plan Sponsor's discretionary contributions, a participant must be employed on the last day of the plan year and have completed 1,000 hours of service during the plan year.

#### c. Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Service (IRS). The Plan allows for catch-up contributions for participants who have attained age fifty by the end of the plan year. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Effective January 1, 2024, the Plan also allows participants to make post-tax (Roth) contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1, 2024, employees of the Plan Sponsor who do not affirmatively elect otherwise are automatically enrolled into the Plan and have their deferral rate set to 2% of eligible compensation. Participants may opt-out or elect a different deferral amount at any time.

The Plan Sponsor may make discretionary matching contributions. For the year ended December 31, 2024, the discretionary matching contribution calculation was 3% of eligible compensation, with a minimum requirement of 2% pre-tax contribution from the participant. For the year ended December 31, 2024, the total discretionary matching contributions were \$297,965.

The Plan Sponsor may also elect to make discretionary contributions to be allocated as a percentage of plan compensation. There were no discretionary contributions for the year ended December 31, 2024.

#### d. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of discretionary employer contributions and plan earnings and losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings and losses and account balances, as defined. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are immediately vested in their contributions, Plan Sponsor discretionary matching contributions, and Plan Sponsor discretionary contributions plus actual earnings or losses thereon.

#### f. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account. Participants may have one loan outstanding at any time. Loan terms range from one to five years, unless for the purchase of a primary residence, in which case the term may be up to ten years. The loans bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

#### g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to a participant, or their beneficiary, who has reached the normal retirement age of 65, with no option for early retirement. Upon termination of service, a participant may elect to receive either a lump-sum equal to the value of the participant's vested account balance or leave their balance in the Plan if the balance is over \$5,000. The Plan requires balances up to \$5,000 be paid out to participants upon termination. Effective April 17, 2025, the involuntary force-out distribution limit was increased to \$7,000 under the provisions of SECURE Act 2.0. There are also retirement benefits available upon disability or death.

The Plan allows in-service withdrawals upon attainment of age 59½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship", from their deferral contributions only. Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

#### h. Forfeitures

Forfeitures represent corrections of Plan Sponsor contributions. Forfeitures are retained by the Plan and are used to reduce future Plan Sponsor contributions or to pay plan expenses. There were \$8,648 of forfeitures used to reduce discretionary matching contributions for the year ended December 31, 2024. The Plan had no unallocated forfeitures as of December 31, 2024. The Plan had \$9,649 of unallocated forfeitures as of December 31, 2023.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments, with the exception of the fully-benefit-responsive group annuity contract (see Note 9), are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and qualified institutions. See Note 4 for disclosure of fair value measurement.

Group annuity contracts held by a defined contribution plan are required to be reported at fair value, except for fully-benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. There were \$994 of defaulted loans that have been deemed distributed and included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits as of December 31, 2024.

#### Contributions

Contributions from plan participants and the discretionary matching contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation. The Plan Sponsor discretionary contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the recordkeeping, advisory services, administration of participant loans, and processing of distributions are charged directly to the participant's account and are included in net appreciation of investments. Investment-related expenses are included in net appreciation of investments.

#### Subsequent Events

Subsequent events have been evaluated through July 18, 2025, which is the date the financial statements were available to be issued. Except as noted in Note 1b and Note 1g, there were no other events that met the criteria for recognition for disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTIONS

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, Empower), the qualified institutions, have certified to the completeness and accuracy of certain investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and certain related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

There has been no change in the methodology used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all vested benefits would be paid to participants in accordance with Plan provisions.

During 2021, the Plan was subject to a partial plan termination where plan participation decreased by greater than 20% due to the Plan Sponsor terminating its transportation contract and closing the associated company division. All benefits for participants affected by the partial plan termination were already 100% vested. All assets and participant accounts associated with this division were within a separate Empower account under the Plan that was closed out during 2024. The closing of the Empower account resulted in twenty-four accounts being closed out and \$1,240,839 of assets distributed to the affected participants during the 2024 plan year.

### **6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. On December 31, 2020, Empower Retirement, LLC (Empower) acquired the retirement business and operations of Massachusetts Mutual Life Insurance Company (MassMutual). Both MassMutual and Empower are considered parties-in-interest. Accordingly, notes receivable from participants and transactions with investment funds managed and held by the qualified institutions are considered party-in-interest transactions.

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to the qualified institutions for their administrative services to the Plan. During 2024, there were \$13,385 of revenue sharing credits reimbursed to the Plan, net of \$6,608 of administrative expenses which are included in net appreciation of investments in the accompanying statement of changes in net assets available for benefits.

### **7. TAX STATUS**

The Plan Sponsor has obtained an opinion letter dated April 7, 2021, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the accompanying statements of net assets available for benefits.

### **9. GROUP ANNUITY CONTRACT**

The Plan's group annuity contract is a fully-benefit-responsive investment contract with Empower Annuity Insurance Company of America (Empower Retirement). Empower Retirement maintains the contributions in a separate account used solely to satisfy the claims of the contract holder. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The group annuity contract is included in the financial statements at contract value as reported to the Plan by Empower Retirement. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average crediting interest rate is set quarterly.

Certain events limit the ability of the Plan to transact at contract value with Empower Retirement. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Empower Retirement and the Plan participants have a probability of occurring.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
