Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. Description of Plan

The following description of the Plan 2 - West Coast Dental, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 2012, as restated January 1, 2022. The Plan covers all employees, excluding union employees, leased employees, non-resident aliens, key employees, participants in Plan 1 – West Coast Dental, Inc. 401(k) Profit Sharing Plan, and employees other than Highly Compensated Employees who are not shareholders or Non-Highly Compensated Employees with compensation less than \$50,000 in the preceding Plan year, of West Coast Dental Services, Inc. who have completed six consecutive months of service and are age 18 or older. The Plan requires a participant to be employed as of year end to be eligible to receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan document, for up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company has adopted a safe harbor provision to eliminate the need for certain nondiscrimination tests required by the Internal Revenue Service. Company contributions made under the safe harbor provision are immediately 100% vested. Under the safe harbor provision, the Company has elected to make a matching contribution equal to 100% of each participant's deferral up to 3% of the respective participants' compensation and 50% of each participant's deferral from 3% to 5% of the respective participants' compensation. To be eligible for the Company's safe harbor contributions, a participant must be considered a Non-Highly Compensated employee in the preceding plan year.

For the year ended December 31, 2023, there were no profit sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, rollover contributions, and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions is based on years of continuous service. A participant is 20% vested after two years of service and continues to vest in increments of 20% per year, until 100% vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through biweekly payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed in the form of a lump sum cash payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

As of December 31, 2023 and 2022, there were no forfeited nonvested accounts. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2023, no amounts were applied to plan activities from forfeited nonvested accounts.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan's management evaluated events that occurred after December 31, 2023 through March 24, 2025, the date when the financial statements were available to be issued.

On September 8, 2023 and for the purpose of consolidating the affiliated plans, the trustees of the Plan entered into a Merger and Transfer Agreement to transfer all of the assets of Plan 2 - West Coast Dental, Inc. 401(k) Plan into West Coast Dental Administrative Services, LLC 401(k) Plan, an affiliate of the Plan. The total Plan assets were transferred on January 8, 2024 under the amended and restated Plan document for West Coast Dental Administrative Services, LLC 401(k) Plan effective January 1, 2024. Refer to the Plan document for a more complete description of the Plan's provisions.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2023 and 2022.

Pooled Separate Accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year-end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from, or corroborated by, observable market data by correlation or other means are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair Value of Investments that Calculate Net Asset Value

4. Transfers of Plan Assets

The Company sponsors two other affiliated plans covering the remainder of the Company's employees. Participant are transferred among the three plans based on their compensation levels or as a result of a plan amendment. At the end of each plan year, a transfer of assets to or from this Plan, when necessary, is recorded in the statement of changes in net assets available for benefits.

In 2023, certain participants, with an aggregate account balance of \$356,241, became ineligible to participate in the Plan as their compensation in the preceding plan year exceeded the maximum allowed under the Plan. Also in 2023, certain participants of affiliated plans with an aggregate account balance of \$146,583 became eligible to participate in the Plan as their compensation in the preceding plan year was within the range allowed by the Plan. Accordingly, these balances will be transferred to and from affiliated plans after the Plan year ended December 31, 2023, and have been recorded in the 2023 statement of net assets available for benefits as amounts due to affiliated plans and due from affiliated plans.

In 2022, certain participants, with an aggregate account balance of \$98,640, became ineligible to participate in the Plan as their compensation in the preceding plan year exceeded the maximum allowed under the Plan. Also in 2022, certain participants of affiliated plans with an aggregate account balance of \$58,974 became eligible to participate in the Plan as their compensation in the preceding plan year was within the range allowed by the Plan. Accordingly, these balances will be transferred to and from affiliated plans after the Plan year ended December 31, 2022, and have been recorded in the 2022 statement of net assets available for benefits as amounts due to affiliated plans and due from affiliated plans.

Transfers among the affiliated plans mentioned above resulted in a net transfer of assets from this Plan of \$169,992 as reported in the statement of changes in net assets available for benefits.

5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are managed by the custodian, and therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. John Hancock Life Insurance Company (U.S.A.) receives revenue from investment fund service providers for services John Hancock Life Insurance Company (U.S.A.) provides to the funds. This revenue is used to offset certain amounts owed to John Hancock Life Insurance Company (U.S.A.) for its administrative services to the Plan. If the revenue received by John Hancock Life Insurance Company (U.S.A.) from such investment fund service providers exceeds the amount owed for its services, John Hancock Life Insurance Company (U.S.A.) remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan sponsor may make a payment to John Hancock Life Insurance Company (U.S.A.) for administrative expenses not covered by revenue sharing.

Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Information Certified by the Custodian #Value Unavailable#

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023 and 2022. Accordingly, John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2023 and 2022, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2023, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2023.

7. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

On January 8, 2024, all assets of the Plan were transferred to an affiliated Plan West Coast Dental Administrative Services, LLA 401(k) Plan.

8. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Delinquent Participant Contributions

For the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan on a timely manner as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$24,094, are pending correction in the Department of Labor Voluntary Fiduciary Correction Program as of the date these financial statements were issued. Lost earnings resulting from the late remittances are expected to be nominal. The Plan Sponsor intends to correct the late deposits in addition to lost earnings in accordance with the DOL's self-correction program during the December 31, 2024 plan year.
