Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jim Ellis Atlanta, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, Transamerica Trust Company as of December 31, 2024 and for the period July 1, 2024 through December 31, 2024, and Reliance Trust Company as of December 31, 2023 and for the period January 1, 2024 through June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Jim Ellis Atlanta, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of Jim Ellis Atlanta, Inc., Jim Ellis Volkswagen, Inc., Jim Ellis, Inc., Jim Ellis Atlanta South, Inc. and Jim Ellis Motors, Inc. (referred to collectively hereafter as "the Company"). Employees are eligible to participate in the Plan beginning on the first day of each quarter once attaining age 21 and completing six months of service (1,000 hours). Upon enrollment in the Plan, a participant may direct contributions in various investment options, including mutual funds. Participants may change their investment options daily. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may elect to defer their compensation up to the maximum amount allowed under the Internal Revenue Code, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan has a flexible discretionary match formula. For 2024, the Company matching contributions equals 50% of the participants' contribution, limited to 4% of compensation after completing one year of service. Additional profit sharing amounts may be contributed at the option of the Company. Contributions are subject to certain limitations. The Plan includes an automatic enrollment feature whereby all newly eligible employees are automatically enrolled in the Plan after meeting the eligibility requirements, unless they affirmatively elect to not participate. The default deferral rate is four percent of eligible compensation.

Participant accounts:

Each participant's account is credited with the participant's contribution, any Company contributions, and an allocation of Plan earnings. Allocations are based on compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in their share of Company contributions is based on years of service, as defined by the Plan. A participant is 100 percent vested after the earlier of six years of credited service, total disability, death, or the reaching of normal retirement age.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of the participant's account. The loans are secured by the balance in the participant's account. The interest rate on all notes outstanding range from 4.25% to 9.50%. The notes are to be repaid within five years, unless the note is used to purchase a primary residence. Principal and interest is paid ratably through payroll deductions.

Note 1. Description of Plan (continued)

Forfeited accounts:

Forfeitures may be used to reduce employer contributions and to pay the Plan's administrative expenses. The amount of unallocated forfeitures as of December 31, 2024 and 2023 was \$12,427 and \$59,723, respectively. \$87,287 of forfeitures were used during 2024.

Payment of benefits:

The vested value of a participant's account is payable upon termination, retirement, death, or disability in either a lump sum or partial payments. Distributions are payable as soon as administratively feasible following the date on which a distribution is requested or otherwise payable. Certain in-service withdrawals are also allowed under the Plan.

Hardship distributions:

Participants may be distributed up to 100% of their elective deferral and vested employer match in the event of immediate and heavy financial need. In order to receive a hardship distribution, certain requirements and conditions must be satisfied. Hardship distributions are allowed from all sources.

Note 2. Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses on the Plan's investments are included in net appreciation (depreciation) in the fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Note 2. Significant Accounting Policies (continued)

Plan expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Payment of benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the use of estimates based on management's knowledge and experience. Due to their prospective nature, actual results could differ from those estimates.

Note 3. Party-In-Interest Transactions

Certain Plan investments are underlying assets of mutual funds managed by TransAmerica Life Insurance Company (TransAmerica), who acts on behalf of Transamerica Trust Company ("TTC") and Reliance Trust Company ("RTC"). TTC and RTC are the corporate trustees/custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The corporate trustees/custodians received \$97,181 in direct fees from the Plan in 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 4. Information Prepared and Certified by the Trustees/Custodians of the Plan

The following information included in the accompanying financial statements and supplemental schedule was compiled from data certified by TTC and RTC, the trustees/custodians, as being complete and accurate:

- A. Investments included in the Statements of Net Assets Available for Benefits – December 31, 2024 and 2023.
- B. Investment income included in the Statement of Changes in Net Assets Available for Benefits – Year Ended December 31, 2024.
- C. Investment information included in the supplemental information.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 7. Income Tax Status

The Plan has adopted a prototype non-standardized profit sharing volume submitter defined contribution basic plan document. The underlying volume submitter plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying prototype document is qualified under the applicable sections of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under the applicable section of the IRC. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status.

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt and no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year-end.

Money market: Valued at quoted market prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
